ARTICLES OF FAITH

Article 1. We believe in only one true, living God, and there are three in the God-head, the Father, the Son and the Holy Ghost.

Article 2. We believe that the Scriptures of the Old and New Testaments are the word of God and the only rule of faith and practice.

Article 3. We believe in the doctrine of particular and eternal election.

Article 4. We believe in the doctrine of original sin.

Article 5. We believe in man's impotency to recover himself from the fallen estate in which he is, by nature, by his own free will and ability.

Article 6. We believe that we are justified in the sight of God only by the imputed righteousness of Christ.

Article 7. We believe that God's elect shall be called, regenerated and sanctified by the Holy Ghost.

Article 8. We believe that the Saints shall persevere in grace and never finally fall away.

Article 9. We believe that Baptism and the Lord's Supper are the only ordinances of Jesus Christ; that nothing is Baptism except immersion, and that believers are the only subjects of this ordinance, and that none but baptized believers are entitled to partake of the Lord's Supper.

Article 10. We believe in a general resurrection of the dead, and a general judgment

Article 11. We believe the punishment of the wicked shall be everlasting, and the joy of the righteous eternal.

Article 12. We believe that no minister has a right to administer the ordinances only such as are regularly called and have come under the imposition of hands of the Presbytery.

FOREIGN MISSIONS

Your Committee on Foreign Missions reports as follows:

We can never be what we should be until we excel in this grace also. The pastors should preach missions until our people are informed. Prayer should be offered for our missionaries who are on the field and for others to enter the wide-open doors.

We rejoice in the work that has already been done, in the

faithful efforts that are being so abundantly blessed now, and look forward to the future with renewed hope.

HOME MISSION REPORT

The foundations of America are fundamentally religious, and the only spirit which may be trusted adequately to safeguard them is that of Christian patriotism.

Following the World War, and in the midst of reconstruction problems, thousands of our people have made a new dedication of themselves to this Christian Americanism, and in no section more than in the South, where the largest proportion of native Americans reside. They purpose to safeguard American liberties by safeguarding that faith which alone made those liberties possible, and to keep lighted in America a beacon of liberty which shall shine out across the seas to cheer and bless peoples who grope in darkness.

Christian Americanism is the work of Home Missions, which, by bringing men to Christ, creates that righteousness that exalteth a nation. Our Baptist Home Mission Board is the outstanding agency of Southern Baptists for making America Christian. It has a great record of successful service, but is now entering on a time of even larger opportunity and need.

In 1919 the missionaries of our Board baptized one convert for every three received into our churches. Regularly they baptize from twenty to twenty-five per cent as many converts as the entire number who enter our churches. For fifteen years, its evangelists have averaged 450 baptisms per year per worker, a record far outstripping that of any other similar agency. Its system of mountain schools is larger than any other, and is the acknowledged standard in adaptability. Its enlistment work is rapidly bringing a more adequate standard and effectiveness in hundreds of churches. The Church Extension work has grown from infancy to lusty strength in a period of only a few years.

Recently the Board has also far surpassed its own fine record. Within the last seven years of its history of seventy-five years its missionaries have baptized 94.5 per cent as many converts as were baptized in the first sixty-eight years.

In soul-winning and nation-serving; in teaching the truth of Christ and conserving it; in building Christians up and maturing for the state the type of character that makes our Republic great, and in the end must save it from disintegration, our Board

has been wonderfully used of God.

Every loyal Baptist will rejoice in the admirable efforts of our Board to meet the crucial needs of these days by enlarging its work. At its Annual Meeting in Atlanta, in June, after long and painstaking efforts to reduce the appropriations as far as possible, the brethren of the Board found that \$2,876,000 was necessary for the work of the present year. Even with this appropriation, it had to decline many worthy appeals to enter wide open doors.

We commend our Board for its faith and vision in grappling the stupendous tasks that now confront us and in believing that our people will respond to such leadership. We recommend that constant prayers be made for the Board, for its missionaries and for its work, and that we give it large and sustained support through our gifts to the 75 Million Campaign.

We commend to our people the admirable Mission Study Books of the Board, through which a true view is presented of the large problems we confront, and recommend that pastors, superintendents, Mission Society leaders and others write often for the large and splendid assortment of free tracts about its work and the needs, which our Board gladly furnishes on request.

REPORT ON EDUCATION

Your Committee on Education reports as follows:

As a denomination we believe in education. We feel that the peculiar doctrines which we present thrive better where there is an educated people.

Ignorance never has been good for the Baptist. We believe in and preach that every one should read the Bible for himself; should decide all matters of the soul for himself. That each one is competent to settle all religious questions.

These questions cannot be settled aright unless there is a trained mind. For this cause we have always taken the lead in educational matters.

Our schools, colleges and universities are second to none and should have the undivided and loyal support of all our Baptists. The 75 Million Campaign has brought us to the place where we can emphasize the importance of education, and, in a large measure, meet the needs of our schools.

The Education Board, located at Birmingham, Ala., is a step in the right direction. This Board will have general supervision of all our denominational schools; be a clearing house on educational matters, and gradually build up an educational literature. Stetson University, which has recently come under the control of the Baptists of Florida, should have our loyal support, both with our finances and also our patronage. We have a school at DeLand which is thoroughly equipped to meet the needs of the day, and a faculty both competent and efficient.

We give our loyal support to the common schools of our state, and commend them for the work done. Realizing that there is a need for higher education that is permeated with religion, we recommend that our young people attend our own schools and colleges wherever practicable, and that they seek training that shall fit them for church work as well as for the common avocations of life.

REPORT ON MINISTERIAL SUPPORT

Your committee understands "Ministerial Support" to mean the financial support of Gospel missionaries, evangelists, ex-ministers (such as the old, infirm and disabled ministers) and present pastors of our churches. We understand that the purpose of this report is to encourage the churches of this Association to provide adequate financial support for their pastors.

It is hard to understand how Missionary Baptists can proclaim to the world that they accept the New Testament as a rule of faith practice, and condemn all other religious bodies for not doing the same, and at the same time refuse to make scriptural and adequate support possible for their pastors. Listen to what the Scriptures have to say on this subject. The first Board of Deacons were appointed so that the preachers might give themselves to "prayer and to the ministry of the Word," Acts 6:4. "Even so hath the Lord ordained that they which preach the Gospel should live of the Gospel," 1 Cor. 9:14. Then in Gal. 6:6, "Let him that is taught in the word communicate unto him that teacheth in all good things." And many other Scriptures that we have not the space to quote.

Brethren, it is a shame to the Baptist name and to the cause of Christ for the members of our churches to live so luxuriously and sumptuously every day, and your pastors limited to such

niggardly pittance that they just barely eke out an existence.

Your Committee beg leave to recommend to the churches of this Association that each church make full and adequate provision for the support of your pastors, or destroy your Articles of Faith and no longer profess that the New Testament is your rule of faith and practice.

REPORT ON SUNDAY SCHOOLS

Since the Baptists have declared to the world that the Bible is "the word of God" and that the New Testament is the only rule of practice for a "New Testament Church," it would seem that it would be unnecessary to urge that a Baptist church conduct and maintain a Sunday School. But when we turn to the minutes of our Association and notice that only eleven churches out of forty-one reported a Sunday School last year, we see the need of preaching the gospel of Sunday Schools to our churches, yet.

The Sunday School is the teaching service of the church, and should be maintained and conducted by the church, for no other institution in the world has a commission to evangelize or teach. The object of the Sunday School is to dispense Christian knowledge to the members of the church, that each member of the church may be instructed in the doctrines, duties and responsibilities of the church, so that the church as a body may perform its functions and accomplish the purposes of God in the world. No church has a scriptural right to call itself a "New Testament church" that does not conduct and maintain a teaching service for the benefit of its members, and require that each member attend that service, so far as possible.

Your committee begs leave to recommend that each church composing this Association establish at once, equip and maintain a teaching service, and teach the Bible to its members, and thus fortify our member against all the false teachings and prepared to "contend earnestly for the faith which was once delivered unto the saints."

REPORT ON ORPHANAGE

Your Committee on Orphanage would report as follows:

Our Orphanage is located at Arcadia, Florida. This is a

beautiful city in southern Florida, where the climate is good and the colds of winter do not necessitate the expenditure of large sums of money for fuel.

We own about sixty acres of land, which was donated by the City of Arcadia. We have most of this under cultivation, doing general farming, dairy work, also trucking. We have quite a nice grove of citrus fruits, which proves both a source of revenue and also enables the children to enjoy some of the things which other children have so abundantly.

Our superintendent, Rev. J. E. Trice, with his consecrated corps of assistants, takes a real interest in the children in the home, and makes every effort to train those consigned to their care into useful, consecrated citizens.

At present there are 110 children in the Home, and many more need to be taken, but the lack of room and sufficient funds make it impossible.

There is a school maintained at the Home, and this, together with the city school of Arcadia, gives each child a high school education. In addition to this, agriculture, trucking, dairying, printing, telegraphy, bookkeeping, and many other things are taught.

The girls are taught to sew and to cook, and, in fact, all the things needful for successful housekeeping.

The success of the 75 Million Campaign gives our Orphanage \$20,000 per year; but with the increased cost of everything, we are still pressed for room and means to care for the many who need to be there.

We suggest that each church, Sunday School and other auxiliary organization take a special offering for the orphans at least once each year, and that the management and the children be the special objects of your prayers.

All extra collections should be sent direct to the Orphans Home, and the 75 Million Fund will not get credit for same.
