# ARTICLES OF FAITH

## I. The Scriptures

We believe that the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction: that it has God for its author, salvation for its end, and truth, without any mixture of error, for its matter; that it reveals the principles by which God will judge us; and therefore is. and will remain to the end of the world, the true center of Christian union, and the supreme standard by which all human conduct. creeds and religious opinions should be tried.

#### God II,

There is one and only one living and true God. an intelligent. spiritual, and personal Being. the Creator. Preserver. and Ruler of the universe. infinite in holiness and all other perfections. to whom we owe the highest love, reverence, and obedience. He is revealed to us as Father, Son, and Holy Spirit, each with distinct personal attributes, but without division of nature, essence, or being

# III. The Fall of Man

Man was created by the special act of God, as recorded in Genesis. "So God created man in his own image, in the image of God created he him," male and female created he them" (Gen. 1:27). "And the Lord God formed man of the dust of the ground. and breathed into his nostrils the breath of life: and man be-came a living soul" (Gen. 2:7).

He was created in a state of holiness under the law of his Maker, but, through the temptation of Satan, he transgressed the command of God and fell from his original holiness and righteousness; whereby his posterity inherit a nature corrupt and in bondage to sin. are under condemnation, and as soon as they are capable of moral action, become actual transgressors.

## IV. The Way of Salvation

The salvation of sinners is wholly of grace, through the mediatorial office of the Son of God., who by the Holy Spirit was born of the Virgin Mary and took upon him our nature. vet without sin; honored the divine law by his personal obedience and made atonement for our sins by his death. Being risen from the dead, he is now enthroned in Heaven, and, uniting in his person the tenderest sympathies with divine perfections, he is in every way qualified to be a compassionate and all-sufficient Saviour.

#### V. Justification

Justification is God's gracious and full acquittal upon principles of righteousness of all sinners who believe in Christ. This blessing is bestowed, not in consideration of any works of righteousness which we have done, but through the redemption that is in and through Jesus Christ. It brings us into a state of most blessed peace and favor with God, and secures every other needed blessing.

#### VI. The Freeness of Salvation

The blessings of salvation are made free to all by the gospel. It is the duty of all to accept them by penitent and obedient faith. Nothing prevents the salvation of the greatest sinner except his own voluntary refusal to accept Jesus Christ as teacher. Saviour, and Lord.

#### VII. Regeneration

Regeneration or the new birth is a change of heart wrought by the Holv Spirit, whereby we become partakers of the divine nature and a holy disposition is given, leading to the love and practice of righteousness. It is a work of God's free grace conditioned upon faith in Christ and made manifest by the fruit which we bring forth to the glory of God.

# VIII. Repentance and Faith

We believe that repentance and faith are sacred duties, and also inseparable graces, wrought in our souls by the regenerating Spirit of God; whereby being deeply convinced of our guilt, danger, and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession, and subplication for mercy; at the same time heartily receiving the Lord Jesus Christ as our Prophet, Priest, and King, and relying on him alone as the only and all-sufficient Saviour.

# IX. God's Purpose of Grace

Election is the gracious purpose of God. according to which he regenerates, sanctifies and saves sinners. It is perfectly consistent with the free agency of man, and comprehends all the means in connection with the end. It is a most glorious display of God's sovereign goodness, and is infinitely wise, holy, and unchangeable. It excludes boasting and promotes humility. It encouages the use of means in the highest degree.

# X. Sanctification

Sanctification is the process by which the regenerate gradually attain to moral and spiritual perfection through the presence and power of the Holy Spirit dwelling in their hearts. It continues throughout the earthly life, and is accomplished by the use of all the ordinary means of grace, and particularly by the Word of God.

#### XI. Perserverance

All real believers endure to the end. Their continuance in well-doing is the mark which distinguishes them from mere professors. A special Providence cares for them, and they are kept by the power of God through faith unto salvation.

#### XII. A Gospel Church

A church of Christ is a congregation of baptized believers. associated by covenant in the faith and fellowship of the gospel: observing the ordinances of Christ. governed by his laws. and exercising the gifts, rights, and privileges invested in them by his word, and seeking to extend the gospel to the ends of the earth. Its Scriptural officers are bishops, or elders, and deacons.

## XIII. Baptism and the Lord's Supper

Christian baptism is the immersion of a believer in water in the name of the Father, the Son, and the Holy Spirit. The act is a symbol of our faith in a crucified, buried and risen Saviour. It is a prerequisite to the privileges of a church relation and to the Lord's Supper. in which the members of the church, by the use of bread and wine, commemorate the dving love of Christ.

# XIV. The Lord's Day

The first day of the week is the Lord's day. It is a Christian institution for regular observance. It commemorates the resurrection of Christ from the dead and should be employed in exercises of worship and spiritual devotion. both public and private. and by refraining from worldly amusements. and resting from secular employments. works of necessity and mercy only excepted.

# XV. The Righteous and the Wicked

There is a radical and essential difference between the righteous and wicked. Those only who are justified through the name of the Lord Jesus Christ and sanctified by the Holy Spirit are truly righteous in his sight. Those who continue in impenitence and unbelief are in his sight wicked and are under condemnation. This distinction between the righteous and the wicked holds in and after death, and will be made mainfest at the judgment when final and everlasting awards are made to all men.

# XVi. The Resurrection

The Scriptures clearly teach that Jesus rose from the dead

His grave was emptied of its contents. He appeared to the disciples after his resurrection in many convincing manifestations. He now exists in his glorified body at God's right hand. There will be a resurrection of the righteous and the wicked. The bodies of the righteous will conform to the glorious spiritual body of Jesus.

# XVII The Return of the Lord

The New Testament teaches in many places the visible and personal return of Jesus to this earth. "This same Jesus which is taken up from you into heaven, shall so come in like manner as ye have seen him go into heaven." The time of his coming is not revealed. "Of that day and hour knoweth no one. no. not the angels in heaven, but my Father only" (Matt. 24:36). It is the duty of all believers to live in readiness for his coming and by diligence in good works to make manifest to all men the reality and power of their hope in Christ.

# XVIII. Religous Liberty

God alone is Lord of the conscience, and he has left it free from the doctrines and commandments of men which are contrary to his Word or not contained in it. Church and state should be separate. The state owes to the church protection and full freedom in the pursuit of its spiritual ends. In providing for such freedom no ecclesiastical group or denomination should be favored by the state more than others. Civil government being ordained of God, it is the duty of Christians to render loval obedience thereto in all things not contrary to the revealed will of God. The church should not resort to the civil power to carry on its work. The gospel of Christ contemplates spiritual means alone for the pursuit of its ends. The state has no right to impose penalties for religious opinions of any kind. The state has no right to impose taxes for the support of any form of religion. A free church in a free state is the Christian ideal, and this implies the right of free and unhindered access to God on the part of all men, and the right to form and propogate opinions in the sphere of religion without interference by the civil power.

# XIX. Peace and War

It is the duty of Christians to seek peace with all men on principles of righteousness. In accordance with the spirit and teachings of Christ they should do all in their power to put an end to war.

The true remedy for the war spirit is the pure gospel of our Lord. The supreme need of the world is the acceptance of his teachings in all the affairs of men and nations. and the practical application of his law of love.

We urge Christian people throughout the world to pray for the reign of the Prince of Peace, and to oppose everything likely to provoke war.

#### XX. Education

Christianity is the religion of enlightenment and intelligence. In Jesus Christ are hidden all the treasures of wisdom and knowledge. All sound learning is therefore a part of our Christian heritage. The new birth opens all human faculties and creates a thirst for knowledge. An adequate system of schools is necessary to a complete spirtual program for Christ's people. The cause of education in the Kingdom of Christ is coordinate with the causes of missions and general benevolence. and should receive along with these the liberal support of the churches.

# XXI. Social Service

Every Christian is under obligation to seek to make the will of Christ regnant in his own life and in human society: to oppose in the spirit of Christ every form of greed. selfishness. and vice: to provide for the orphaned, the aged, the helpless. and the

sick; to seek to bring industy government, and society as a whole under the sway of the principles of righteousness. truth and brotherly love; to promote these ends Christians should be ready to work with all men of good will in any good cause. always being careful to act in the spirit of love without compromising their loyalty to Christ and his truth. All means and methods used in social service for the amelioration of society and the establishment of righteousness among men must finally depend on the regeneration of the individual by the saring grace of God in Christ Jesus.

# XXII. Co-Operation

Christ's people should, as occasion requires, organize such associations and conventions as may best secure co-operation for the great objects of the Kingdom of God. Such organizations have no authority over each other or over the churches. Thev are voluntary and advisory bodies designed to elicit. combine. and direct the energies of our people in the most manner. Individual members of New Testament effective churches should co-operate with each other, and the churches themselves should co-operate with each other in carrying forward the missionary, educational, and benevolent program for the extension of Christ's Kingdom. Christian unity in the New Testament sense is spiritual harmony and voluntary co-operation for common ends by various groups of Christ's people. It is permissable and desirable as between the various Christian denominations. when the end to be attained is itself justified, and when such co-operation involves no violation of conscience or compromise of loyalty to Christ and his Word as revealed in the New Testament.

# XXIII. Evangelism and Missions

It is the duty of every Christian man and woman, and the duty of every church of Christ to seek to extend the gospel to the ends of the earth. The new birth of man's spirit by God's Holy Spirit means the birth of love for others. Missionarv effort on the part of all rests thus upon a spiritual necessity of the regenerate life. It is also expressly and repeatedly commanded in the teachings of Christ. It is the duty of every child of God to seek constantly to win the lost to Christ by personal effort and by all other methods sanctioned by the gospel of Christ.

#### XXIV. Stewardship

God is the source of all blessings, temporal and spiritual: all that we have and are we owe to him. We have a spiritual debtorship to the whole world. a holy trusteeship in the gospel, and a binding stewardship in our possessions. We are therefore under obligation to serve him with our time, talents and material possessions; and should recognize all these as entrusted to us for the glory of God and helping others. Christians sholld cheerfully, regularly, systematically, proportionately, and liberally contribute of their means to advancing the Redeemer's cause on earth.

# XXV. The Kingdom

The Kingdom of God is the reign of God in the heart and life of the individual in every human relationship. and in every form and institution of organized human society. The chief means for promoting the Kingdom of God on earth are preaching the gospel of Christ and teaching the principles of righteousness contained therein. The Kingdom of God will be complete when every thought and will of man shall be brought into captivity to the will of Christ. And it is the duty of all Christ's people to pray and labor continually that his Kingdom may come and his will be done on earth as it is done in heaven.

# THE MIDDLE FLORIDA BAPTIST ASSOCIATION

# **RULES OF DECORUM**

1. The Moderator shall preserve order in the Association, which shall be opened and closed by prayer. He shall decide all questions of order and propriety.

2. All members of the body shall respect the authority of the Moderator, but any member shall have the right to appeal to the body from his decision.

3. The Moderator shall have the same right of speaking as any other member of the body provided he appoints some member to fill the chair; but he shall not vote except when there is a tie, when he may cast the deciding vote.

4. No more than one member shall speak at a time. Any member desiring to speak shall rise from his seat and address the Moderator and when recognized by the chair may speak to the subject, but not more than twice on the same subject without permission of the body.

5. No member shall leave the body while in session without permission of the chair.

6. All motions in order must be disposed of by the body, unless withdrawn by the one who made the motion.

7. When a question is taken up, after allowing time for deliberation, the Moderator shall take the vote of the body and then announce the decision. If a division is called for the Moderator shall take the vote by calling on the members to rise and stand until they are counted. After the count is made on both sides the Moderator shall announce the result.

8. The Clerk shall enroll the names of the Messengers, and keep a regular record of all the business of the Association. He shall have the Minutes printed and distributed to each church, according to the amount of money sent up.

9. The Treasurer shall receive and manage the funds of the Association, taking receipts of all disbursements thereof, and present an annual report of all funds received and disbursed, for insertion in the Minutes of the Association.

10. This decorum may be altered or amended by two-thirds vote of the members present at any annual session of the Association.

# CONSTITUTION

#### of

# THE MIDDLE FLORIDA BAPTIST ASSOCIATION

Article 1. The name of this organization shall be "THE MIDDLE FLORIDA MISSIONARY BAPTIST ASSOCIATION."

Article 2. The Association shall be composed of messengers duly elected by the Churches affiliated with this body who shall present letters certifying to their election, or other satisfactory evidence thereof, and all ordained pastors who are members of or pastors of any of said churches.

Article 3. Each church having fifty members or less shall be entitled to two messengers. Churches having more than fifty members shall be entitled to one additional messenger for every twenty-five members or major fraction thereof.

Article 4. The objects of this Association shall be the promotion of fellowship among the churches, and the fostering of Missionary, Educational and Benevolent enterprises, in harmony with the Florida Baptist State Convention and the Southern Baptist Convention.

Article 5. The Association shall meet annually at such time and place as may be selected by the body. If it should become necessary, the Executive Committee of the Association may change the time, or place of meeting, or both.

Article 6. Any church, in harmony with this Association as to doctrine and practice, may be admitted into the union upon the presentation of a petitionary letter accompanied by satisfactory information.

Article 7. Any church wishing for a letter of dismission shall make application therefor by letter.

Article 8. The officers of this Association shall be a Moderator, an assistant Moderator, who shall be a layman or Pastor who shall act as Moderator in the absence of the Moderator, and who shall also be Moderator for the Fifth Sunday Meetings, a Clerk and a Treasurer, who shall be elected annually by the suffrage of the messengers elected by the Churches, and shall hold office until their successors are elected.

Article 9. This Association shall have an Executive Committee composed of a lay member from each Church and the Pas tors of each Church belonging to this Association, the Associational Sunday School Superintendent, the Associational B. T. U. Director, the Associational Woman's Missionary Union President, the Associational Brotherhood President, together with the officers as Ex-officio members. This committee shall foster all the interest of the Association, when the body is not in session. The Committee shall have authority to appoint or recommend to the State Board Missionaries, or colporteurs, and to make appropriation to weak churches or destitutions, and to give such advice to the churches as may seem Wise and necessary, and the Moderator shall be chairman of the Executive Committee.

Article 10. The Articles of Faith of this Association shall be the same as those which are adopted by the Southern Baptist Convention when in session at Memphis, Tennessee, in May, 1925, and shall be the basis of fellowship and cooperation.

Article 11. The Association shall recognize and respect the rights and independence of every church cooperating.

Article 12. This Constitution may be changed or amended at any annual meeting of the body when two-thirds of the members present deem it expedient.

# RADIO-T-V REPORT

A year and a half ago Southern BaBptists television program THIS IS THE ANSWER was released to the American public.

To date there are 23 different episodes of THIS IS THE ANSWER traveling the circuit of television stations. A total of 170 different stations has carried the telecast into 1,160,000 homes reaching 85 percent of the nation's viewing audience.

With the number of people reached by stations telecasting the program the second and third times, it is estimated conservatively that our denomination has sent into American homes 138 million messages of the Gospel.

The cost of the first year's work in television, plus all the preparation that preceded it, was approximately \$450,000., A sizeable figure to be sure, but looking at what has been obtained for this investment in the Gospel message briugs us to a start-ling fact:

By adding up the commercial value of the time given free by the teleivsion stations (as a public service) for THIS IS THE ANSWER—what it would have cost us if we had purchased the time—we find that it has almost exactly equalled our expenditure. THIS IS THE ANSWER has received free time amounting to a value of approximately \$450,000.

This \$450,000 cost has enabled us to send directly to viewers some 138,000 million messages of the Christian Gospel. This means that TO SEND ONE MESSAGE TO A FAMILY OF THREE ... IT COSTS ... ONE CENT!

Actually, for only one-third of a cent per person your Radio-Television agency is presenting an appealing, winning, half-hour message of Christianity to those who need it most.

## **Baptist Hour - Other Programs**

At the same time, THE BAPTIST HOUR on radio, continues its world-wide success by reaching out over more than 440 stations in this country and abroad, to a listening audience estimated at 30 million.

Other radio programs which are being used by a steadily increasing number of stations in several states include: Moral Side of the News, International Sunday School Lesson, Chapel Upstairs (devotional), and Great Hymns by the Baptist Hour Choir.

All programs are offered without cost to any station which will carry them, or to any pastor who can use them in his local ministry.

#### The Beam

THE BEAM, the Commission's monthly magazine has now reahced a circulation in excess of 20,000 and continues to grow. It is a periodical in which THE BAPTIST HOUR sermons are reprinted for even wider distribution, and which carries news of religious radio and television in many denominations. A unique publication.

## The Future

The future of the Radio and Television Commission is brighter than it has ever been. The 1957 Southern Baptist Convention voted to give this agency a total of one million dollars in capital needs funds during the five year period, 1959-1963, for use in TV film production and distribution.

We thank God for the way He has blessed the spread of the genuel through these modern means of communications, radio and television. BYRON TEDDER

#### SUNDAY SCHOOL REPORT

The Bible says: "Gather the people together, men, and women, and children, and thy stranger that is within thy gates, that they may hear, and that they may learn, and fear the Lord your God, and observe to do all the words of this law:"

The Sunday schools have proven themselves to be a great reaching, teaching, evangelistic, enlistment, and financial agency of the churches. We rejoice in the growth and service of the Sunday schools of our association.

Our association reports this year 37 Sunday schools; 4188 Sunday school enrolment; 405 decrease in enrolment over last year; No Standard Sunday Schools; 243 Baptisms; 16 Vacation Bible Schools; and an active Associational Sunday School Organization. Mr. Everett Murphy, Jr., served as Associational Superintendent and Mr. Cecil Hicks as assistant Superintendent.

The State Sunday School Department, C. F. Barry, Secretary, reports approximately 1300 plus church & mission Sunday schools, a Sunday school enrolment of approximately 350,000, a total of 50,921 training awards and 975 Vacation Bible schools for 1956.

Florida is seeking to have 125 Standard Sunday schools for this year, a 10 per cent increase in Sunday school enrolment, 1,025 Vacation Bible schools, and 52,000 training awards. We urge our Sunday schools to help reach these challenging totals.

Committee makes the following recommendations:

- 1. That we maintain a complete Associational Sunday school organization, with regular meetings and that we urge all of our Sunday schools to co-operate fully with this pogram.
- 2. That we set a goal of 10 per cent increase in Sunday school enrolment this year, a Vacation Bible School in every church, two or more study courses for teachers and officers, the observance of Bible Study Week in January, a minimum of 25 per cent of our churches with Standard Sunday Schools.
- 3. That our Sunday schools co-operate with all the special days as promoted by the Florida Baptist Convention.

# MUSIC REPORT TO THE ASSOCIATION

Today, the Church Music Department of the Southern Bapttist Convention has twelve full-time workers—all devoted to the cause of better Church Music in your church—your association—and your state. This staff, under the leadership of Dr. W. Hines Sims, produces music, study course books and materials, free pamphlets, THE CHURCH MUSICIAN, which is the official department magazine published monthly, anthems and anthem collections for the different age choirs, and films and other audio-visual aids for the music program in cooperation with the Audio-Visual Aid Department of the convention.

The Music Ministry in the church is an agency existing on an organized basis for the purpose of developing a comprehensive graded music education program that ministers to all areas of church life. The Music Department of the Florida Baptist Convention is concerned with promoting all phases of the Music Ministry in every church through a fully organized Associational Music Organization. During the past year our association has been fully organized with a capable person in each place of responsibility.

Churches were encouraged to conduct their own schools by the associational organization. There was such a school held at Burton; about 50 awards were given.

The Church Music Festival program is designed to reach every church whether large or small. Six festivals were held on the state level during the year throughout Florida. For 1957-58 the dates and places for these festivals are as follows:

# STEWARDSHIP REPORT

According to information in last year's minutes, thirty-eight churches with a residence membership of 4,250 people gave an average of \$4.39 to the cooperative program.

This same membership took 10.4 people one year to win one person to Christ. Something to think about, isn't it?

Stewardship can be summed up in one word. Tithe. If we place the proper importance upon the tithe which is not ours but God's, then there would be no question of stewardship.

In Proverbs 3:9 we find these words: "Honour the Lord with thy substance, and with the first fruits of all thine increase."

Too often when we think of tithing we think only of money. This is an error. The Scripture just read said first fruits of all thine increase. Believing this, then the tithe would cover every area of life. If 4,250 Middle Florida people would realize that as God blesses us with added days and years of life, this is a part of our increase. I believe that this time should be tithed as much as our money. If we tithed our time as we should then there would be a growth such as never witnessed before in our Association.

Too often our churches think that they are the stopping place for God's tithe. I believe the church should tithe as well as it's members. Tithe to the cooperative program so that God's work might continue. The advancement of God's Kingdom depends on the importance we place upon stewardship.

What will you do this year for our Lord? As an individual? As a church? As an Association?

#### CHRISTIAN EDUCATION

The time has come when the people need, more than ever, to see that their children receive their education in Christian colleges and schools, and it is time that parents take a stand for what is, or is not taught in our local schools, and that they secure Christian school teachers as far as humanly possible. For the training they receive,—When a child will more or less influence their lives in the future. But where should Christian Education begin? I say, it should begin in the home, only Christian parents can mold the lives of their children in Christian living: Proverbs 22:6 "Train up a child in the way he should go and when he is old he will not depart from it." (Eph. 6:4, 2 Tim. 3:15).

Southern Baptists financial support of their colleges and schools increased from \$9,925,956 in 1955 to \$11,742,769 in 1956, or an over-all gain of 18.3 per cent, and enrollments in their seventy colleges, seminaries and schools reached 57,335, with nearly two-thirds of these (39,723) enrolled in senior colleges and universities.

Included among the students preparing for church vocations there were 10.435 ministers, 2,019 education directors, 1,012 music directors, and 2,293 mission volunteers.

# **Construction Mounts**

The efforts of the colleges and schools to prepare for the increased enrollments ahead are reflected in the increase of total property values from \$143,814,980 in 1955 to \$169,091,523 in 1956. Practically all of our institutions are constructing new dormitories and classroom buildings.

Wake Forest College moved to its new Winston-Salem (N. C.) campus in June, 1956, and Furman University began using some buildings on its partially-completed new campus in Greenville, South Carolina, in 1957. Construction continues on the new campus of Howard College at Birmingham, Alabama, which will be occupied in 1958.

# Faculty Shortage Approaches Acute State

Increasing difficulty in recruiting qualified teachers in the colleges continues to become more serious.

Baptist colleges face a serious threat to the quality of instruction unlesss vigorous efforts are made to interest more qualified Baptists in college teaching as a career. It is suggested that the names of persons so qualified be sent to the office of the Education Commission of the Southern Baptist Convention at Nashville, in order that they may be registered for possible placement in Baptist colleges.

Final tabulation of the 1956 April Emphasis ("Prepare for Leadership") revealed that 651,615 tracts and leaflets were distributed to the churches, and more than eighteen million printed pages of supporting materials were published in Convention-wide periodicals.

We welcome the Baptist Bible Institute of Florida into the Florida Baptist Convention at Graceville, Florida.

## Stetson University

Stetson University is the only Baptist institution of higher learning located within the bounds of the Florida Baptist Convention. It enrolled 1624 students during the 1956-57 academic session, and has 153 devoted Christian scholars and administrative officers on its faculty. A new student union building, costing in excess of \$1,250,000, was opened to the students at the commencement of the 1957 session. A new \$500,000 Law Library is under construction on the campus of the College of Law in St. Petersburg.

In checking the reports from the churches to our association, we find that there were 258 baptisms, plus 270 by letter, or a total of 528 new members received into the membership of our churches during the year. May these numbers be an incentive for a more diligent witness in the incoming year.

The Evangelistic Conference held each year in Jacksonville has done much to stir the fires of evangelism. The conference this year will be held January 14-16. Every church would be wise to send their pastor to this conference.

The goal for our Southern Baptist Convention this year is 475.000 converts to the Master. The theme of evangelism is: "A Warm and Workable Program of Evangelism to Every Member." That simply means that the goal is that every member be a personal soul winner. Let us rise up to do the one thing that Christ has left for us to engage in.

Dr. Paul Meigs has come to our State to lead in the work of Evangelism. We feel that he is God's man for this task. He plans to hold an associational-wide Evangelism Clinic in each association this year. Let us under God, rise up and follow his leadership and reap the harvest of souls that will perish if we neglect.

# COOPERATIVE PROGRAM REPORT

#### **1957 Associational Meetings**

Billy Graham wrote on March 20, 1956, in a letter to E. S. James, editor of the **Baptist Standard**, "Concerning the Cooperative Program, I believe it is the greatest means ever devised by the church for the giving of one's tithe. In private and public conversation, I support the Cooperative Program without hesitation." This conviction is shared not only by an internationally known evangelist, but by the rank and file of Southern Baptists from the Great Lakes to the Gulf, and from Maryland to California.

Mission gifts through the Cooperative Program increased nearly \$1.3 million in 1956 over 1955 throughout the Southern Baptist Convention. 1955 gifts were \$35.7 million and 1956 gifts were \$37 million. This is a 3.6% increase. Florida's increase for the same period was from \$1,584,450 to \$1,758,622, or an 11% increase.

More and more churches are finding that the best way to increase Cooperative Program giving is on a percentage of the chuch's total budget, including building fund. The Southern Baptist Convention, meeting in Chicago last May, adopted a goal of each church increasing its percentage to missions to the Cooperative Program by 2% of the total budget (not 2% of the present Cooperative Program gifts) per year between now and the Jubilee Year, 1964. The Florida Baptist Convention meeting in Lakeland, November 8-10, 1955, voted that each cooperative Program by at least 1% of its total budget receipts each year.

Already destined to play a vital role in helping to increase church income for all causes is the Forward Program of Church Finance. 43 churches which used the Program by May 20, 1957. reported that their number of tithers jumped from 9 thousand to 17 thousand, and their weekly pledges from \$44 thousand to \$72 thousand. These same 43 churches increased their Cooperative Program gifts from \$500 thousand to \$700 thousand.

#### **RECOMMENDATIONS:**

Therefore, aware of the proven value of the Forward Program, and conscious of the eternal good that would result from using this program, we recommend:

(1) That our association support the annual Church Leadership Conference held in our association the last week in January each year, and any other conferences or clinics that may be held in our association on the Forward Program of Church Finance.

(2) That our churches proceed to use the Forward Program too subscribe their annual budgets, and follow the entire program.

(3) That each church seek to increase its gifts to world missions through the Cooperative Program by at least 1% per year of its total budget (not 1% of present Cooperative Program gifts) until a 50-50 division is reached.

# MISSIONS REPORT

# Foreign Missions

Accelerated advance in world missions characterized this past year. Appointments totaling 121 during 1956 and 49 from January to May brings the number of foreign missionaries in active service to 1154. The appointment goal for all of 1957 is 130. The Board expects to reach its Advance Program goal of 1750 missionaries by 1964.

Southern Baptist missionaries entered three additional countries during the past year, and eleven additional mission stations brought to 211 the number of centers in which the missionaries of the Foreign Mission Board live.

Mission work is carried on through a varying number of institutions on each mission field—churches, schools, hospitals, publications, good will centers. But all are interactive and the goal of each is evangelization. Whatever their institutional duties, all missionaries participate in the work of the churches on their stations.

The ministry of the hospitals is carried on through personal contacts with patients and their families, devotional services, distribution of literature, and follow-up visitation after patients leave the hospital.

The Foreign Mission Board received \$12,733,681 from all sources during 1956. Contributions for foreign missions accounted for \$12,474,638 of that amount.

Funds from the Lottie Moon Christmas Offering for the fiscal year (May 1, 1956 to May 1, 1957) amounted to \$5,240,745.39.

Contributions for world relief totaled \$67,122 during 1956.

The Advance Funds from the Cooperative Program (75% of funds after Convention-wide budget is reached) have increased steadily year by year. The 1956 funds amounted to \$2,407,709.64.

## **Home Missions**

The 1957 report of home missions must of necessity deal with the 1956 figures. At the beginning of 1957 the Home Mission Board reported 1,180 missionaries, an increase of 81 over the previous year. Professions of faith reported by the missionaries numbered 39,458, an increase of 1,983 over the previous year.

The Home Mission Board's income for 1956 was: from the Cooperative Program, \$2,027,369.87; Annie Armstrong Offering, \$1,574.890.61; and from designated gifts, \$127,761.01; total \$3.-730,027.49.

Among new personal additions at the headquarters office are Clovis A. Brantley as assistant secretary in the Department of Direct Missions, William B. Mitchell, superintendent of Jewish work, and Wendell Belew, director of church-sponsored mission work.

Among major emphases during 1957 the Board will continue its effort to enlist every church in an evangelistic ministry and every member to participate in soul-winning. Conservation of results will be pursued. All work of the Board is in full co-operation with all other agencies of the denomination. The "30,000 Program," with its challenge to constitute 10,000 new churches and establish 20,000 additional mission stations in seven years, will receive major emphasis not only throughout the year but for the duration of the Third Jubilee of Baptists.

Increased loan funds are greatly needed. Minority groups: Indians, Negroes, and language groups will receive major attention. The Board has set a goal of 1,050 missionaries serving minority groups by 1964.

The City Mission Program is to be enlarged with the entry by the Board into a new major city every year if possible; the rural church program had major emphasis in 1956 and efforts will be intensified constantly; pioneer areas call for extensive interest and work; special groups and needs, such as the deaf, the Jews, migrants, broken homes, juvenile delinquents, and a ministry to military personnel, challenge the best leadership of the Board's missionaries.

Promotion and education made great demands on the Home Mission Board's staff because of increased interest. Filmstrips, motion pictures, maps, mission study books, tracts, picture packets, publicity, the magazine, and all other projected and published materials have been improved and the demands have been tremendous. Schools of Missions and assignment of home missionaries to fulfill increasing demands have afforded missionary information and inspiration.

The Chaplains Commission reported 421 chaplains on active duty and 11.074 professions of faith recorded in their ministry.

Home missionaries were instrumental in starting 729 new missions and constituting 296 new churches

The greatest need of the Board is expressed in the single statement: We need your prayers and personal interest, a larger proportion of the church budget dollar, a wider interest in tithing, missionary volunteers committed to home missions, and a share in every Southern Baptist's consecration.

#### State Missions

Once again we are asking our people to pause and really study state missions. We are told that Florida presently stands thirteenth in population and will be in eighth position, if the forecast is realized by the mid-1960's.

We are told that Florida's population, counted unofficially, is 3,800,000 on the first of this year. This places Florida thirteenth in the United States. In 1900, Florida was the second smallest of the southern states and ranked thirty-third in the nation. An official estimate on July 1, 1955, gave Florida 3,452,-000 and ranked Florida as sixteenth, ahead of Minnesota, Kentucky, Tennessee, and Alabama. Ey the end of 1955, Florida had passed Georgia, Virginia, and Wisconsin, and was third largest in the south. North Carolin and Texas are still ahead, or as so reported by the Florida State Chamber of Commerce.

What does this all mean? It means that if the forecast is true, Florida will likely pass Missouri, North Carolina, Indiana, Massachusetts, and New Jersey, to reach eighth position. This is by 1965. By 1970, Florida will have a permanent population of 6.119,000. This simply means that Florida is having an unprecedented period of growth. Thousands upon ten thousands of people are pouring into Florida every year, and Baptists must be alerted to the unprecedented opportunity within our yery own borders.

Certainly we must continue to put great emphasis on new work, but we cannot afford to neglect our well established departmental and institutional activities within the state. Our budget for the closing year 1956-57 was \$1,600.000. We divided this budget 50-50 between state and southwide causes, with the Southern Baptist Convention bearing equally with the Florida Baptist Convention the cost of operation, promotion, etc. Out of Florida's \$800,000 of the \$1,600,000 budget, we cared for all of our work and expanded our work as we had means to do it. The only reason that more expansion was not undertaken was because the support was not in evidence. We have for years operated on a well balanced departmental and field mission program, and we will continue to operate this kind of a program, for only such a program is wise and safe.

We must look forward to our advanced program. We cannot advance, until our churches catch a vision and will join with the state office in such an advanced program. To assure that we will be able to make the advance, our new program of church finance, which is being offered to all of our churches, will solve our problems only if our churches will follow the plans. Our office in Jacksonville offers whatever help is asked of us and we are able to give. We are yours to command. The future of Florida is as bright as the promises of God. What we need now as we've needed in the past is more laborers, better cooperation, more faith, and a greater vision. Let's move together, for Baptists, as always, go forward when they go together.

There are many other publications that deserve a special word that will have to be omitted. If you want to improve the Spiritual level of any community, the literature of Southern Paptists is a source of help that is invaluable.

# REPORT OF COMMITTEE ON FLORIDA BAPTIST CHILDREN'S HOME

The work at the Home has entered a new phase. For the first time in its history, a department of social service has been established which meets the requirements of the State Department of Public Welfare. There are three graduate case workers on the staff, each with a master's degree in social work from an accredited college or university. This will enable us to do foster home placement and provides a better counseling service for the children who need it. It will also make it possible for us to give help to more children without increasing the number of cottages at Lakeland. We can extend our mother's aid program to the fullest and give a better service to those who must have care in private homes.

The increase in assistance to children through the case work department is evident from the report of the social service division of the Home. It shows that we assisted 293 children, which is the largest number ever helped in a given year.

The Home at Miami was opened August 28th. It is a branch

of the Florida Baptist Children's Home in Lakeland and in no way is it a separate children's home. We have completed two cottages which are now occupied by children and workers. We will build two more when the funds are available. The completed unit will have four cottages for children, an office, and a home for the manager.

The branch home is well located. It is near a church and a school which eliminates the problem of tansportation and gives our children excellent facilities for spiritual and mental development. The workers and children attend church at the Wayside Baptist Chapel in Kendall.

Those who work at the Home are highly gratified at the progress made in the care of children. There is no service more important than giving a child christian training. Loving care and christian training have changed the lives of hundreds of boys and girls who have lived in our Home.

We wish to emphasize the importance of a continuation of your help to our children. Let us help by assisting them through the cooperative program and the Thanksgivinrg offering.

#### THE FLORIDA BAPTIST FOUNDATION

The Florida Baptist Foundation has been serving the Florida Baptist Convention since 1947 in emphasizing the wider aspects of stewardship—stewardship of our possessions, not simply during a lifetime, but also stewardship concerning the things we accumulate and leave behind. We believe this to be a sound basis upon which to view this overall responsibility and would commend to our people this practice. In a very significant sense ALL we have is from God and in respect of ALL we have we should plan our stewardship program.

The Foundation does not primarily seek funds for its own use. The Foundation is a service arm of the Convention and the Convention provides funds for its maintenance. The Foundation seeks, primarily, to assist the avrious agencies and institutions of our State and Southwide fellowship.

Again let us emphasize the matter of "Will-Making" as a means by which the larger stewardship of possession may be carried out. Along with the provisions made for loved ones, we may make provision for Kingdom interests by this means.

We call attention to the matter of Annuity contracts which we are now able to arrange with the Relief and Annuity Board of the Southern Baptist Convention. By this means an Annuitant may have the income from his purchase of such a contract for his lifetime and still have the privilege of designating the "gift portion" of the Annuity to an Agency or Institution in which his interests lie. Besides this, the purchaser is relieved of the necessity and responsibility of reinvesting his funds so as to be assured of his income. The Relief and Annuity Board, through its very competent and consecrated group of investment specialists, sees to all this and by its contract with the Annuitant assures him of the rate of income he will receive.

#### AMERICAN BIBLE SOCIETY

"The Bible speaks today" is more than a slogan. It is the experience of millions of people around the world. It challenges us to action. The Bible must speak to more people in this year in which missions are being especially emphasized, and also in all the years which lie ahead. If the people of the world are to know Jesus Christ, the one hope of man and nations, they must have the Bible. Each person must have the Bible in his own language, because it speaks to his heart as no other language can possibly speak.

The Bible is the essential tool of missions and evangelism. The missionary uses it in all his work. The Bible itself is a missionary. It goes where the human missionary cannot go. It remains after he has gone and keeps on speaking to a man's heart. The American Bible Society helps missionaries translate the Bible. It publishes without note or comment and distributes without profit, usually below cost. For the blind it supplies Scriptures in raised-letter systems and on Talking Book records.

#### 38 MINUTES OF FIFTY-EIGHTH ANNUAL SESSION

During 1956 the American Bible Society distributed throughout the world more than fifteen million volumes of Scriptures. The Society supplied over 13,000 Bibles and other Scriptures to Hungarian refugees coming to the U. S. A., and joined in supplying many more to refugees in Austria and other countries. The Society donated nearly one million Scripture volumes for distribution by Chaplains to our Armed Forces, as a vital link between the home churches and the men in service. The Society translated the Bible into more than 1,100 languages. The entire Bible has been translated and published in 210 languages; a complete Testament in 270 more; and at least a Gospel or other complete book in 629 additional languages.

By virtue of the fact that Southern Baptist missionaries depend on the American Bible Society for Scriptures they need for distribution to their people, Southern Baptist churches support the Society. The writer of Hebrews says, "Let us consider one another to provoke unto love and unto good works." In keeping with this spirit, Southern Baptists contributed to the Society during the year 1956 \$120,732. This amount was exceeded only by our Methodist friends who contributed \$174,447.

In view of the great work the Society is doing through our missionaries, it seems but fair that every Baptist church should support the Society. The committee, therefore, urgently requests that every church in our association make a contribution to the Society during the next associational year. The gifts should be sent to our state Baptist office in Jacksonville marked "for the American Bible Society."

The State convention of the Southern Baptist States are now operating over thirty Senior colleges and Universities, over twenty junior colleges and several academies. In the senior colleges we have some 40,000 students. These institutions represent a great investment for the instruction of our Baptist. However, we have not yet reached the need or appeal for those who are interested. We need more great endowments also we need continued contributions.

We would not be complete without stating something about our own needy state regarding Baptist schools of higher learning. Florida, one of the fastest growing states of the union, can not boast at all about its Baptist Colleges. We only have the one a senior college, Stetson University, located at DeLand, Florida. We are, indeed, proud of this school and its great work, but the need in Florida is not taken care of in this one institution. We undestand that Florida Baptist have invested less in christian education than any other state in this area. My brethren we have a need in this field, let us resolve to give it more aid. We are beginning to do some other christian educational work in Florida—let us do more.

Christian education work is without end. Our beloved Southern Baptist Convention is giving support to five great Southern Baptist Theological Seminaries. We will probably never know the great work that these Seminaries are doing. My brethren if these institutions are to serve their average or perhaps their maximum it will take the whole-hearted support of all Baptists and the Convention too.

We have a total of five great Southern Baptist Theological Seminaries in our Convention with a total enrolment of 6,196 for the year of 1956-57. A list of these Seminaries follows with the enrollment of each.

Southern Baptist Theological Seminary. Louisville, Kentucky, will celebrate its centennial in 1959, has a critical class room shortage, but doing a great work, enrollment of 1713 for 1956-57.

New Orleans Baptist Theological Seminary, New Orleans, La. Expenses very reasonable. No school indebtedness. Four great schools. Enrollment 1043 for term 1956-57.

Golden Gate Baptist Theological Seminary, Berkley, Calif. Has had fast growth. Good building program started. Doing a great work. Enrollment 348 in 1956-57.

Southeastern Baptist Theological Seminary, Inc., Wake Forest, N. C. Has a fine program of instruction. Experiencing good growth. Need campus improvements. Enrollment 681 for term 1956-57.

Southwestern Baptist Theological Seminary, Fort Worth, Texas. Will celebrate its Golden Anniversary in 1958. A great institution. Doing a great work and making great progress. Three emphases have been stressed this year: A Bible-centerd scholarship, an evangelistic spirit, and missionary opportunities. Enrollment 2.411 in 1956-57.
