IN MEMORY OF JOHN RICE COLLINS



Like so many wonderful people before him, John Rice Collins found his way from South Carolina to Madison County, Florida. Born in Barnwell in that state, in 1899, Reverend Collins, served two years for his country during World War I.

It was his good fortune to marry Miss Gracia Elack, also of Barnwell, June 30, 1923. The early 1920's found the young couple in Jacksonville, Florida, where John was engaged in Railroading as a flagman for 12 years.

But the Great Depression was covering the land and John cast his lot with a Federal Development in Cherry Lake and came here as a homesteader in 1986.

The year following, John was touched by the Master and called to his special work as a minister. From this point, the face of John Collins was most familiar on the North Florida and South Georgia Scenes. It has been said and truly, that Brother Collins, beginning at his home church of Cherry Lake, filled more pulpits as pastor and evangelist in Florida, Georgia, and South Carolina, than any man for a comparable period.

The wonderful family, coming to his and Sister Gracia's home were three daughters, Mrs. Johnnie Grace Bland, Mrs. Miriam Whitlock, and Mrs. Juanita Burnette. A devoted family man of the first order, he was practically a father to his nephew Stanley Baxley. The grandchildren are lovely and giving promise of many bright lives to come.

Suffering some health problems, Brothe: John retired from the active pastorate in 1966 but his spirit, restless for Christ, kept him ever on the move, preaching, testifying, loving people. After preaching at the morning hour at Brewer Lake, he was called in the late afternoon, June 11, 1972. His blessed influence will rest over us and point us to better service in The Master's Cause. "Blessed are the dead who die in The Lord."

HISTORY OF MIDDLE FLORIDA BAPTIST ASSEMBLY



On April 25, 1955, 40 pastors and laymen, two missionaries, and a few women, met at the Mayo Baptist Church for the purpose of forming a temporary organization to construct an assembly for our people of North Central Florida. A deed for eight (8) acres of land, located on Pickett Lake in Lafayette County, was given by Mr. and Mrs. Delmar Sapp.

A motion was made and carried that the assembly would be owned, operated and controlled by the people of the following associations. Suwannee, Beulah, Harmony, Lafayette, Santa Fe, Middle Florida and Florida. The name would be Middle Florida Baptist assembly.

By October 1961, two (2) dormitories, 18'X64' had been erected, with 50 bunk beds and bathroom facilities in center of each building and a kitchen and dining area building 24'X64' furnished with a gas stove, hot water heater, sinks and counters, and a 65 ft. refrigerator had been installed.

Mr. and Mrs. Sapp gave an additional four (4) acres of lang to the Assembly. In 1962, a piano was purchased, and a good road was built to the Assembly grounds.

In 1963, through the goodness of Bro. Ezra Smith, Gainesville, Florida, we constructed two (2) more dormitory type buildings, 16' X68', with terrazo flooring.

In 1968, a new fence was built around the assembly grounds, a 40 lb. bell was given, a flag pole and two large flags. A gas heater was installed in the kitchen, dining area. A four foot attic fan was given by Mayo Church.

Plans were begun for a Chapel, to be named "Dave Alderman Chapel," in honor of our beloved brother who served as our District Missionary for 22 years and who helped pioneer the Assembly. Bleacher type seats were erected at the lakeside, for morning watch and campfire services.

In 1970 ground was broken for the new chapel and in 1971 it was nearly completed. With red brick exterior beige roof and red cedar panelling across the front, it will seat about 300.

By September of 1971 it had been paid for at a cost of \$16,000.00. A 600 pound capacity ice maker and a new cold water fountain had been installed.

During the year of 1972, the chapel was air conditioned at a cost of \$1,600, a new vinyl floor covering was installed, new pews and a piano purchased. The kitchen was enlarged and new floor covering was put on it. A hot water heater was installed in the boys cabin. Choir and pulpit furnishings and floor covering for the chapel were donated by Mr. and Mrs. Delmar Sapp, also a new 80 ft. deep well.

During the year of 1972 every association that has an interest in the Assembly, used the facilities. It has been the best year yet.

We look forward to using the assembly grounds and the Dave Alderman Chapel for the boys and girls of North Central Florida. This is missions at our doorstep.

OF THE SEVENTY-THIRD ANNUAL SESSION

OF THE MIDDLE FLORIDA BAPTIST ASSOCIATION

MET WITH MAYO BAPTIST CHURCH

REPORT OF WOMAN'S MISSIONARY UNION

With this watchword for the year, Woman's Missionary Union has been concerned with two special emphases, mission action and family missions. Two new items were made available for these emphases, a book explaining mission action and a book giving guidance to families for mission action, mission study and mission support.

Woman's Missionary Union participated in the evangelism rallies, providing a conference for women on witnessing through mission action. A total of 1,100 women in Florida attended these conferences, with 30 of these being in our association. This provided an opportunity to lay plans for leading in the REACHING PEOPLE emphasis in Florida for 1972-73, when mission action will be featured as a method for reaching the hard-to-reach.

The annual session of Florida WMU convened at First Church, Daytona Beach, April 25 and 26. The theme was "Peace". Walker L, Knight, editor of HOME MISSIONS, brought a series of Bible meditations on the theme. Missionary speakers from all over the world brought messages. People from churches in Florida shared testimonies of ways they are seeking to bring peace on earth through making Christ known. EVANGELISM DEPARTMENT

"The greatest untapped resource in evangelism is a trained laity, committed to Jesus Christ, filled with the Holy Spirit, and sharing the good news of Jesus Christ". With this basic foundation for the year, the Evangelism Department has been active in involving and training church people in evangelism. This has provided a major thrust in the REACHING PEOPLE emphasis in Florida for 1971-72, and provides the foundation for an even greater thrust in the coming years.

The Evangelism Department shared with associational leadership in promoting the Associational Evangelism Workshops Rallies in all 47 associations, providing conferences for church staffs on preparation for witness training and for Sunday School, WMU, and Brotherhood leadership on witnessing through mission/outreach actions.

The beginning of the Lay Evangelism Schools in Florida has given dynamic thrust and motivation for training and involvement in personal witnessing. In the 60 local church Lay Evangelism Schools, over 7,800 Baptists have been trained in the elementary concepts of living the victorious life and of sharing effectively their personal faith. Advanced training in 5 Leadership Training Schools has provided a growing nucleus of 275 potential directors for witness training. This year our association reports 169 baptisms for the year, which is an increase of 63 from last year. The PINETTA Baptist Church has led us in evangelism with 33 baptisms. Our churches reported 159 additions by letter and statement for a grand total of 328 additions to the churches of our association.

Our Association had an Evangelism Workshop at Macedonia Church on February 8, 1972 which was very helpful to everyone who attended. It was led by State Workers who did a very good job of informing our Laymen and Pastors and Leaders of our Association, doing their work more effective.

U.C.A. is an agency made up by representatives of Baptist, Methodist, Presbyterian, Nazarene and other evangelical denominations. The Agency works in churches schools, homes, camps, assemblies, through research, visual aids, publications, legislative information, for prevention, rehabilitation, and commitment to total abstinence as a positive step in Christian living.

U.C.A. is funded primarily by Florida Baptist through the Annual State Mission offering. Over two hundred churches include U.C.A. in their budget. FLORIDA BAPTIST FOUNDATION

The Florida Baptist Foundation, an agency of the Florida Baptist State Convention, serves Florida Baptists by assisting individuals and their attorneys in preparing wills favoring Florida Baptist causes, and in establishing trusts where the earnings go to Baptist causes.

The executive secretary-treasurer of the Foundation is available to associations, churches, groups of Baptists and individual Baptists to disseminate information and give assistance in this field.

Recent major accomplishments include:

1. Received and invested \$92,441.30 in new permanent money for Baptist causes during the period from October 1, 1971, to July 1, 1972. The audited report of the Flor-

ida Baptist Foundation as of September 30, 1971, showed assets of \$1,154,159,75, or an increase of \$410,436,69 over the assets reported September 30, 1970. This means the Foundation has received and/or earned more than one-half million dollars in the period of 21 months from September 30, 1970, to July 1, 1972.

Managed the investments with a view to security, earnings and appreciation.
 Worked with many individuals and their attorneys in the preparation of wills favoring Baptist causes.

FOREIGN MISSIONS

MISSIONARY SUPPORT The sending out and maintaining of missionaries is primary in Southern Baptist overseas missions through the channel of the Foreign Mission Board. At the close of 1971 the Boardhad an overseas missionary staff of 2,526. This included 169 missionary associates, 5 special project medical personnel, and 125 missionary journeymen. Appointments during the year totaled 226 (120 Career, 28 associates, 67 journeymen, 2 special project medical workers, and 9 career reappointments).

Southern Baptist Missions (organizations of missionaries) and national Baptist groups in dozens of countries continue to call for reinforcements in missionary personnel. Some requests are still not filled, even though they have been repeated for several years and are still urgent.

EVANCELISM AND CHURCH DEVELOPMENT Underlying all our missionaryendeavors is the ultimate purpose of leading people to new life in Jesus Christ and the cultivation of New Testament churches, Organized churches with which Southern Baptist missionaries are related on mission fields now total 6,045, of which more than 70 percent are self-supporting. Work and accomplishments reported are largely those of national churches, leaders, and conventions, with the assistance of missionary co-workers and resources from Southern Baptists.

The program of evangelism and church development includes many types of ministry: radio and television, English-language churches, lay-leadership training stewardship promotion, camps and conferences; work with women, men, and youth; music, and religious education.

SCHOOLS AND STUDENT WORK The training of national leaders is a prerequisite to strong indigenous churches, Educational institutions under Baptist auspices in various lands may include all levels from kindergarten through university. Of special importance is the development of pastors and other church leaders through theological schools and in programs below the full seminary level.

PUBLICATION WORK Publication ministries are an integral part of Southern Baptist overseas missions, as all kinds of Christian literature are provided for purposes of evangelism and the developing of vigorous church life. Our missionaries are related to publishing centers in 23 lands and to informal literature production programs in a number of other countries. Reading clubs, libraries, and correspondence courses continued to provide means of reaching thousands of people with the gospel.

HOSPITALS AND MEDICALCARE The program of hospitals and medical care serves the physical needs of thousands of people who would otherwise be neglected and often opens strategic doors for evangelistic witness. During 1971, missionaries and national workers engaged in this ministry treated nearly 56,000 inpatients and saw more than 941,000 outpatients.

Construction of the Baptist hospital in Bengalore, India, progressed during 1971. In Paraguay, a medical team at the Baptist hospital performed the first heart valve replacements in the nation. Day clinics in local churches and mission points were helping to meet health needs in several countries.

BENEVOLENT MINISTRIES Benevolent ministries include agricultural programs, good will and community centers, children's homes, and direct relief work. During 1971, So. Baptists, through the Foreign Mission Board, provided funds for victims of disease, war and natural disasters in several countires.

Good will and community centers in 16 countries reached people in varied ways; literacy classes, home-making courses, Bible study clubs, recreation programs, and evangelistic services. The 20 children's homes maintained by Baptists in mission lands cared for more than 1,000 boys and girls last year.

CONTRIBUTIONS At the end of 1971, So. Baptists' contributions for foreign missions totaled \$33,719,447 (a per capita gift of \$2,80, nine cents more than in 1970). The 1971 Lottie Moon Christmas Offering goal was \$16,750,000 - an increase over the \$16,220,105 contributed (as of May 1, 1971) through the 1970 offering.

Approximately 50 percent of the Southern Baptist Convention Cooperative Program funds are made available annually for foreign missions. This is the basis upon which sustained advance can be built. Still needed urgently on overseas fields are land, buildings, and equipment, amounting to several million dollars' worth.

HOME MISSIONS Many of the nation's longstanding problems dominated the news of 1971 in home missions. Such problems as crime and violence, hostility and alienation, alcoholism and drug abuse, racial tensions and family problems, plus war and economic stress burdened concerned Christians. Many were encouraged, however, by what seems to be a spiritual awakening among youth and by a freshly exposed hunger for God. A favorable climate strengthens our Christian witness.

Those who serve Christ in this nation are placed in the midst of one of the great evangelism and mission fields of the world,

MISSIONARIES NUMBER 2,229

The rising cost of living and a slowdown in giving affected the mission force, which numbers close to the same figure as one year ago. Two-thirds of all missionaries are jointly supported by state conventions, and only one-third are entirely supported by the Home Mission Board.

EVANGELISM LAUNCHES TV, BUS, AND RENEWAL EFFORTS

In cooperation with the radio and Television Commission, the Division of Evangelism will premier in October a weekly television presentation featuring Kenneth Chafin, the Spring Street Singers, and special guests in an unapologetic presentation of the faith leading to personal commitment.

DISASTER RELIEF PROVIDED

In the wade of Hurricane Fern which hit the Texas coast in the fall of 1971, the Board contributed \$1,000 in disaster relief.

CRISIS WORK CONTINUES

Several programs continue to give attention to ministries in areas of critical human need, in keeping with the "Crisis Statement" adopted by the Convention in 1968 and reaffirmed the following year.

STUDENT SUMMER PERSONNEL

A total of 960 student summer mission personnel were under appointment in 1971, 693 sponsored by the Home Mission Board and 267 ESU. Eighty-seven of the 693 sponsored by the Board received no compensation and 21 paid their own travel expenses.

90 NEW LANGUAGE CONGREGATIONS

were started among Arabs, Hungarians, Rumanians, Spanish, Slavic, Portuguese, Estonians, and Yugoslavs.

ASSOCIATIONAL SERVICES

Bulletins have strengthened the work within the associations.

INFLATION HAMPERS WORK

Income for the Home Mission Board, primarily through the Cooperative Program and the Annie Armstrong Easter Offering, continues to exceed \$15 million, but the increase each year amounts to less than three percent while operating costs have increased by six percent annually. Slight increases in salaries and fringe benefits have eaten away at continued expansion of home mission work.

Cecil Etheredge, missionary personnel secretary, said reduced funds have slowed the appointment of many qualified people.

"The hardest 'no' we have to say is to the mission interns who have prepared themselves for years for this type of service", he said.

CAMPS AND ASSEMBLIES

The camps and assemblies Department is a service organization of the Florida Baptist Convention with the definite assignment of providing for those attending any type of group meeting at either Lake Yale Baptist Assembly or West Florida Baptist Assembly.

Major accomplishments in 1971-72 were as follows:

LAKE YALE BAPTIST ASSEMBLY:

1. Provided accomodations for 114 groups with a total attendance of 19,476.

2. Completed the carpeting of all motel unit rooms.

3. Purchased an additional 80 acres of ground to the south of our present property. This will be developed for trailer, tent and rough camping.

WEST FLORIDA BAPTIST ASSEMBLY:

- 1. Provided for 47 groups with a total attendance of 5,346.
- 2. Installed air-conditioning and heating in dining hall, kitchen, and staff building.
- 3. Purchased new tables and chairs for the dining hall.

MIDDLE FLORIDA BAPTIST ASSEMBLY AT PICKETT LAKE:

1. Provided accommodation for over twenty groups with a total in excess of 1,000.

- 2. The chapel was air-conditioned, a new vinyl cushioned floor covering installed, new pews purchased, and a new piano bought. Our chapel is second to none,
- 3. The kitchen has been enlarged and new floor covering installed,
- 4. A hot water heater was installed in the boys cabin,

Other improvements will be made as the funds become available. The facilities were used for the first time by churches in Gainesville and Lake City. Things are looking real bright for the future of our assembly grounds. I think that the Board of Directors and officers are to be commended for the leadership they provided this year. Please consider putting the assembly grounds in your church budget. This is Home Missions at its best.

SEMINARIES AND COLLEGES REPORT

Most of the Southern Eaptist Colleges and Seminaries continue to grow numerically and expand their facilities. Much emphasis is being placed in institutional selfstudy, culminating radical changes in the religious education curriculum. The leveling off of student enrollment is felt by all colleges and Seminaries according to the 1972 annual reports. While some show a decline in enrollment still others have increased their enrollment by as much as 30%

Southern Baptist's have 43 Baptist Senior colleges and Universities in 16 states and 13 Junior Colleges in 7 states according to the 1970-71 report with a total of 94,167 students. All our Seminaries and Colleges have shown a substantial growth. New Orleans Seminary enrolled 749; Midwestern Seminary in Kansas City, Mo. enrolled 334; Southwestern, Fort Worth, Texas 2,295; Golden Gate, Mill Valley, Calif. 338; Southeastern, Wake Forest, N.C., 621; Southern Seminary, Louisville, Ky. est. 1,500; making a total of 5,837.

Most all Colleges and Seminaries are experiencing a belt lightening due to needed funds for the growing student population and rising cost in operation. All agree that the Cooperative Program will continue to be their main life-line. Gratitude was expressed by all for our prayerful and financial support and the sending of students. All solicite our continued support in the future.

CHRISTIAN LITERATURE/OR THE FLORIDA

BAPTIST WITNESS

Because information is necessary for intelligent study, actions and cooperation, Baptist state papers are important. This type of media continues to fill a strategic place in the life of Southern Baptists. Although each paper is owned and produced by separate state conventions, they are a primary source of unity which enables an autonomous people to cooperate, in a spiritual ministry designed to declare and exhibit the gospel to a lost world.

Confidence on the part of Baptists in this ministry of the printed page is evidenced

by the fact that the circulation of the 33 state papers has reached an all-time high of 1,650,807. This is made possible through those local churches who see the need and right of each member having the opportunity to be informed.

The FLORIDA BAPTIST WITNESS, our own state paper, as of August 1, 1972, enjoys a circulation of approximately 64,000. Nine hundred seventy-two churches, out of the 1,481 churches in the state, are now using one or the other of the group subscription plans to send the WITNESS each week to at least a part, if not all, of the families in their membership.

Circulation to a great degree determines the effectiveness of the WITNESS. All the work, effort and expense mean little if the paper is not widely distributed.

The most economic and sensible way to distribute the WITNESS is to provide for every family to receive it through the church budget plan. The paper is mailed to the members's home. It serves as a weekly reminder of that family's relationship to the church.

The wise pastor sees the state paper as his associate in the task of educating his people in denominational activities. The WITNESS helps the leadership of the church in promoting evangelism, stewardship and missions. It also helps to indoctrinate and enlist the membership for service.

I have been reading the Baptist Witness for over 50 years, and it is better than ever. I urge every pastor and Baptist in this Association to read it. Put it in your church Budget.

SUPERINTENDENT OF MISSIONS REPORT

AN ASSOCIATIONAL COVENANT

Being led, as we believe, by the Holy Spirit, to enter into covenant as an association of churches, we join ourselves together through this larger fellowship;

To watch over one another in love and to nurture the spiritual welfare and fellowship of all churches in the association;

To provide a forum for the consideration of our Christian faith and the evaluation of those points of doctrine and policy which affect our life together;

To assist the churches in planning, conducting, evaluating and improving their programs of work designed to reach their objectives;

To carry out the Great Commission of our Lord both within and beyond the bounds of our association; and

To facilitate the exchange of information and assistance between the covenanting churches, and the Florida Baptist and Southern Baptist Conventions and their agencies, and to maintain interaction with community agencies and other Christian bodies.

As I attempt to relate to you now in words my annual report as your Supt. of Missions, I must lift up to God my GRATITUDE and THANKSGIVING for the privilege of working with YOU this past year.

During these past twelve months, I have visited with every pastor in our district so as to be helpful in any way with his ministry in the local church, I believe that the PASTOR is the KEY person in the heart of our Lord's work. I also believe that as a pastor leads his people to be involved in the associational work will he find many new ways and ideas to lead his church for greater outreach and witnessing opportunities.

Within the district which is approximately 140 miles long and 65 miles wide, I have traveled 27,676 miles. The majority of these miles have been in attending the on-going associational program meetings. I am eternally grateful for the privilege of preaching and speaking some 220 messages within the district . . counciled with 18 church pulpit committees in their attempt to secure a Southern Baptist pastor . . happy that I could sit down with many of our pastors concerning their work in

their church . , helping in the Associational Sunday School Clinics . , with Church Training Briefing Meetings , , with Assn, Brotherhood Workshops . , possibly this question . , "What Does a Supt. of Missions Do?" . , and answered adequately by Mr. Datrell Tapley will give you some idea of the joy of my work with you, "From the questions asked and the suggestions made, I must assume that there

is a rather hazy understanding of the role of the superintendent. For your information, I will share with you what I do and am available to do.

I CARE

It is a little difficult to fit this into a statistical report. I care for the welfare of the pastors and the churches, I am concerned when there is heartache, I am glad when there is victory. I pray for the churches and pastors and seek ways to better their lot. Sometimes the main thing that a church or pastor needs is for someone to care.

I AM AVAILABLE

I am available to each church to supply the pulpit, teach study courses, survey mission needs, try to find methods that will help in church growth, counsel with pulpit committees, preach revivals, lead mission Vacation Bible Schools and anything else that I am capable of doing. But I can do these things only by invitation or permission.

I TRY TO BE INFORMED

I seek information concerning the direction that our denomination will take, new methods in church work, the present condition of the churches in the area and the condition of the pastors. (The burdens that some pastors carry are enough to kill an ordinary man, Fortunately, our pastors are not ordinary men.) I seek to be an able student of the Bible. I try to prepare messages that will be a blessing. I try never to embarrass a pastor by doing a poor job in the pulpit. All of this requires time to study.

I WORK

I visit churches and pastors; I help committees in the associations; I help plan associational programs; I look for the untouched mission needs; I work at encouraging others; I counsel with pulpit committees; I attend most of the meetings in the four associations, and I do many things in my work as the needs arise.

If the above does not fit your concept of what the work of the superintendent should be, I would be happy to hear your suggestions".

Articles of Faith

L The Scriptures

We believe that the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction; that it has God for its author, salvation for its end, and truth, without any mixture of error, for its matter; that it reveals the principles by which God will judge us; and therefore is, and will remain to the end of the world, the true center of Christian union, and the supreme standard by which all human conduct, creeds and religious opinions should be tried.

II. God

There is one and only one living and true God, an intelligent, spiritual, and personal Being, the Creator, Preserver, and Ruler of the universe, infinite in holiness and all other perfections, to whom we owe the highest love, reverence, and obedience. He is revealed to us as Father, Son, and Holy Spirit, each with distinct personal attributes, but without division of nature, essence, or being.

III. The Fall of Man

Man was created by the special act of God, as recorded in Genesis. "So God created he them" (Gen. 1:27). "And the Lord God formed man of the dust of the ground, and breathed into his nostrils the breath of life; and man became a living soul" (Gen. 2:7).

He was created in a state of holiness under the law of his Maker, but, through the temptation of Satan, he transgressed the command of God and fell from his original holiness and righteousness: whereby his posterity inherit a nature corrupt and in bondage to sin, are under condemnation, and as soon as they are capable of moral action, become actual transgressors.

IV. The Way of Salvation

The salvation of sinners is wholly of grace, through the mediatorial office of the Son of God, who by the Holy Spirit was born of the Virgin Mary and took upon him our nature, yet without sin; honored the divine law by his personal obedience and made atonement for our sins by his death. Being risen from the dead, he is now enthroned in Heaven, and, united in his person the tenderest sympathies with divine perfections, he is in every way qualified to be a compassionate and all-sufficient Saviour.

V. Justification

Justification is God's gracious and full acquittal upon principles of righteousness of all sinners who believe in Christ. This blessing is bestowed, not in consideration of any works of righteousness which we have done, but through the redemption that is in and through Jesus Christ. It brings us into a state of most blessed peace and favor with God, and secures every other needed blessing.

VI, The Freeness of Salvation

The blessings of Salvation are made free to all by the gospel. It is the duty of all to accept them by penitent and obedient faith. Nothing prevents the salvation of the greatest sinner except his own voluntary refusal to accept Jesus Christ as teacher, Saviour, and Lord.

VII. Regeneration

Regeneration or the new birth is a change of heart wrought by the Holy Spirit, whereby we become partakers of the divine nature and a holy disposition is given, leading to the love and practice of righteousness. It is a work of God's free grace conditioned upon faith in Christ and made manifest by the fruit which we bring forth to the glory of God.

VIII. Repentance and Faith

We believe repentance and faith are sacred duties, and also inseparable graces, wrought in our souls by the regenerating Spirit of God; hereby being deeply convinced of our guilt, danger, and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession, and supplication for mercy; at the same time heartily receiving the Lord Jesus Christ as our Prophet, Priest, and King, and relying on him alone as the only and all-sufficient Saviour.

IX. God's Purpose of Grace

Election is the gracious purpose of God, according to which he regenerates, sanctifies and saves sinners. It is perfectly consistent with the free agency of man, and comprehends all the means in connection with the end. It is a most glorious dis-

play of God's sovereign goodness, and is infinitely wise, holy, and unchangeable. It excludes boasting and promotes humility. It encourages the use of means in the highest degree.

X. Sanctification

Sanctification is the process by which the regenerate gradually attain to moral and spiritual perfection through the presence and power of the Holy Spirit dwelling in their hearts. It continues throughout the earthly life, and is accomplished by the use of all the ordinary means of grace, and particularly by the Word of God.

XI, Preservation

All real believers endure to the end. Their continuance in well-doing is the mark which distinguishes them from mere professors. A special Providence cares for them, and they are kept by the power of God through faith unto salvation.

XII. A Gospel Church

A church of Christ is a congregation of baptized believers, associated by covenant in the faith and fellowship of the gospel; observing the ordinances of Christ, governed by his laws, and exercising the gifts, rights, and privileges invested in them by his word, and seeking to extend the gospel to the ends of the earth. Its Scriptural officers are bishops, or elders, and deacons.

XIII. Baptism and the Lord's Supper

Christian baptism is the immersion of a believer in water in the name of the Father, the Son, and the Holy Spirit. The act is a symbol of our faith in a crucified, buried and risen Saviour. It is a prerequisite to the privileges of a church relation and to the Lord's Supper, in which the members of the church, by the use of bread and wine, commemorate the dying love of Christ.

XIV. The Lord's Day

The first day of the week is the Lord's day. It is a Christian institution for regular observance. It commemorates the resurrection of Christ from the dead and should be employed in exercises of worship and spiritual devotion, both public and private, and by refraining from worldly amusements, and resting from secular employments, works of necessity and mercy only excepted.

XV. The Righteous and the Wicked

There is a radical and essential difference between the righteous and wicked. Those only who are justified through the name of the Lord Jesus Christ and sanctified by the Holy Spirit are truly righteous in his sight. Those who continue in impenitence and unbelief are in his sight wicked and are under condemnation. This distinction between the righteous and wicked holds in and after death, and will be made manifest at the judgment when final and everlasting awards are made to all men.

XVI, The Resurrection

The Scriptures clearly teach that Jesus rose from the dead. His grave was emptied of its contents. He appeared to the disciples after his resurrection in many convincing manifestations. He now exists in his glorified body at God's right hand. There will be a resurrection of the righteous and the wicked. The bodies of the righteous will conform to the glorious spiritual body of Jesus.

XVII. The Return of the Lord

The New Testament teaches in many places the visible and personal return of Jesus to this earth. "This same Jesus which is taken up from you into heaven, shall so come in like manner as ye have seen him go into heaven." The time of his coming is not revealed. "Of that day and hour knoweth no one, no, not the angels in heaven, but my Father only" (Matt. 24:36). It is the duty of all believers to live in readiness for his coming and by diligence in good works to make manifest to all men the reality and power of their hope in Christ.

XVIII. Religious Liberty

God alone is Lord of the conscience, and he has left it free from the doctrines and commandments of men which are contrary to his Word or not contained in it. Church and state should be separate. The state owes to the church protection and full freedom in the pursuit of its spiritual ends. In providing for such freedom no ecclesiastical group or denomination should be favored by the state more than others. Civil government being ordained of God, it is the duty of Christians to render loyal obedience thereto in all things not contrary to the revealed will of God. The church should not resort to the civil power to carry on its work. The gospel of Christ contemplates spiritual means alone for the pursuit of its ends. The state has no right to impose penalties for religious opinions of any kind. The state has no right to impose taxes for the support of any form of religion. A free church in a free state is the Christian ideal, and this implies the right of free and unhindered access to God on the part of all men, and the right to form and propagate opinions in the sphere of religion without interference by the civil power.

XIX. Peace and War

It is the duty of Christians to seek peace with all men on principles of righteousness. In accordance with the spirit and teachings of Christ they should do all in their power to put an end to war.

The true remedy for the war spirit is the pure gospel of our Lord. The supreme need of the world is the acceptance of his teachings in all the affairs of men and nations, and the practical application of his law of love.

We urge Christian people throughout the world to pray for the reign of the Prince of Peace, and to oppose everything likely to provoke war.

XX. Education

Christianity is the religion of enlightenment and intelligence. In Jesus Christ are hidden all the treasures of wisdom and knowledge. All sound learning is therefore a part of our Christian heritage. The new birth opens all human faculties and creates a thirst for knowledge. An adequate system of schools is necessary to a complete spiritual program for Christ's people. The cause of education in the Kingdom of Christ is coordinate with the causes of missions and general benevolence, and should receive along with these the liberal support of the churches.

XXI. Social Service

Every Christian is under obligation to seek to make the will of Christ regnant in his own life and in human society; to oppose in the spirit of Christ every form of greed, selfishness, and vice; to provide for the orphaned, the aged, the helpless, and the sick; to seek to bring industry, government, and society as a whole under the sway of the principles of righteousness, truth and brotherly love; to promote these ends Christians should be ready to work with all men of good will in any good cause, always being careful to act in the spirit of love without compromising their loyalty to Christ and his truth. All means and methods used in social service for the amelioration of society and the establishment of righteousness among men must finally depend on the regeneration of the individual by the saving grace of God in Christ Jesus.

XXII, Co-Operation

Christ's people should, as occasion requires, organize such associations and conventions as may best secure co-operation for the great object of the Kingdom of God. Such organizations have no authority over each other or over the churches. They are voluntary and advisory bodies designed to elicit, combine, and direct the energies of our people in the most effective manner. Individual members of New Testament churches should co-operate with each other, and the churches themselves should cooperate with each other in carrying forward the missionary, educational and benevolent program for the extension of Christ's Kingdom. Christian unity in the New Testament sense is spiritual harmony and voluntary co-operation for common ends by various groups of Christ's people. It is permissable and desirable as between the various Christian denominations, when the end to be attained is itself justified, and when such co-operation involves no violation of conscience or compromise of loyalty to Christ and his Word as revealed in the New Testament.

XXIII. Evangelism and Missions

It is the duty of every Christian man and woman, and the duty of every church of Christ to seek to extend the gospel to the ends of the earth. The new birth of man's spirit by God's Holy Spirit means the birth of love for others. Missionary effort on the part of all rests thus upon a spiritual necessity of the regenerate life. It is also expressly and repeatedly commanded in the teachings of Christ. It is the duty of every child of God to seek constantly to win the lost to Christ by personal effort and by all other methods sanctioned by the gospel of Christ.

XXIV. Stewardship

God is the source of all blessings, temporal and spiritual; all that we have and are we owe to him. We have a spiritual debtorship to the whole world, a holy trusteeship in the gospel, and a binding stewardship in our possessions. We are therefore under obligation to serve him with our time, talents and materialpossessions; and should recognize all these as entrusted to us for the glory of God and helping others. Christians should cheerfully, regularly, systematically, proportionately, and liberally contribute of their means to advancing the Redeemer's cause on earth.

XXV. The Kingdom

The Kindgom of God is the reign of God in the heart and life of the individual in every human relationship, and in every form and institution of organized human society. The chief means for promoting the Kingdom of God on earth are preaching the gospel of Christ and teaching the principle's of righteousness contained therein. The Kingdom of God will be complete when every thought and will of man shall be brought into captivity to the will of Christ. And it is the duty of all Christ's people to pray and labor continually that his Kingdom may come and his will be done on earth as it is done in heaven.

RULES OF DECORUM

1. The Moderator shall preserve order in the Association, which shall be opened and closed by prayer. He shall decide all questions of order and propriety.

2. All members of the body shall respect the authority of the Moderator, but any member shall have the right to appeal to the body from his decision.

3. The Moderator shall have the same right of speaking as any other member of the body provided he appoints some member to fill the chair; but he shall not vote except when there is a tie, when he may cast the deciding vote.

4. No more than one member shall speak at a time. Any member desiring to speak shall rise from his seat and address the Moderator and when recognized by the chair may speak to the subject, but not more than twice on the same subject without permission of the body.

5. No member shall leave the body while in session without permission of the chair.

6. All motions in order must be disposed of by the body, unless withdrawn by the one who made the motion.

7. When a question is taken up, after allowing time for deliberation, the Moderator shall take the vote of the body and then announce the decision. If a division is called for the Moderator shall take the vote by calling on the members to rise and stand until they are counted. After the count is made on both sides the Moderator shall announce the result.

8. The Clerk shall enroll the names of the Messengers, and keep a regular record of all the business of the Association. He shall have the Minutes printed and distributed to each church, according to the amount of money sent up.

9. The Treasurer shall receive and manage the funds of the Association, taking receipts of all disbursements thereof, and present an annual report of all funds received and disbursed, for insertion in the Minutes of the Association.

10. This decorum may be altered or amended by two-thirds vote of the members present at any annual session of the Association.

Constitution

ARTICLE I - NAME

The name of this organization shall be "The Middle Florida Baptist Association,"

ARTICLE II - OBJECT

The object of this Association shall be to foster a harmonious and efficient spirit of cooperation among the churches of it's constituency and to cooperate with sister churches of the Southern Baptist Convention in carrying out the missionary, educational and benevolent program of Christ's Kingdom to the ends of the earth.

ARTICLE III - MEMBERSHIP

Section 1. The Association shall be composed of messengers duly elected by the churches affiliated with this body.

Section 2. Each church in the Association shall be entitled to representation in its sessions as follows: Two messengers for the first fifty members or less and one additional messenger for each additional 25 members or fraction thereof, and all ordained pastors who are members of or pastors of any of said churches, together with the elected officers of the Association, who are members of the churches.

ARTICLE IV - OFFICERS

The officers of this Association shall be a Moderator, Vice-Moderator, Clerk and Treasurer. They shall be elected annually by ballot from nominations made from the floor at the last session of the Association, taking office at the close of the annual session.

If any vacancy occurs in any office between sessions, the Executive Committee shall elect an officer to fill vacancy for the unexpired term.

The Moderator shall be elected to serve two or more years in succession. All officers shall serve without salary except Clerk and Treasurer, whose stipend shall be referred to the Budget Committee.

ARTICLE V - OTHER OFFICERS

The Nominating Committee shall at the September Executive Committee meeting recommend for approval, subject to election at the annual session, the heads of the various departments namely: Sunday School, Church Training, Music, Evangelistic Chairman, Stewardship Chairman and such other departments as shall be authorized by the Association.

ARTICLE VI - COMMITTEES

Section 1. All committees shall consist of three members except the Executive Committee, Association Mission Committee and Calendar Committee.

Section 2. The Executive Committee shall be composed of the Associational Officers, heads of the Associational Organizations, pastors and one lay member from each church to be recommended by the individual church and chairman of standing committees.

Section 3. The Standing Committees shall be: (1) Assembly Ground, (2) Budget and Finance (3) Calendar of Activities (4) Committee on Committees (5) Missions (6) Nominating (7) Obituaries (8) Program (9) Resolutions (10) Time, Place and Preacher (11) Assignment.

Section 4. Members of the Standing Committees shall be nominated by the Committee on Committees and elected by the Association to take office at the close of the annual session.

Section 5. The Missions Committee shall be composed of five members who shall

serve for five years with one-fifth retiring each year.

Section 6. The Calendar Committee shall include the heads of each department.

Section 7. The Program Committee shall also include the Moderator and Clerk. Section 8. The Budget and Finance Committee shall cooperate with the heads of each Associational Organization and Treasurer in preparation of a budget for the ensuing year.

This committee shall determine the sum per resident church member to be requested from the churches for funds to carry on the work of the Association.

ARITLCE VII ~ RIGHTS OF CHURCHES

This body shall recognize and respect the Scriptural rights of the churches composing it, and shall in no wise exercise authority over them. Churches may be at liberty to sever connection with this body at any time by giving written notice to the Executive Committee or Annual session.

ARTICLE VIII - PETITION

Petition for membership shall be referred to a committee on petitionary letters at any Executive Committee meeting prior to the annual meeting of the Association, and shall be subject to approval at the annual session of the Association.

ARTICLE IX - ARTICLES OF FAITH

The Articles of Faith of this Association shall be the same as those adopted by the Southern Baptist Convention at their annual session in 1925 and shall be the basis of fellowship and cooperation.

ARTICLE X - AMENDMENTS

This constitution may be altered or amended at any annual meeting of the body and must secure a two-thirds majority vote of the messengers present and voting.

A HISTORY OF MAYO BAPTIST CHURCH

Early in 1894, 19 members of Half-Moon Lake Baptist Church with Rev. H.M. Frier as pastor, organized the Mayo Baptist Church, electing Dr. R.L. Goodbred, clerk. The same year the church was received into the Lafayette Association of Baptists. This was the year Mayo was designated as the county seat. Charter members included families of Wm.E. Bowman, Henry Koon, Rev. Zachariah Dees, J.C. Ramsey, Polk, Trammel and Scarborough, Rev. Zachariah Dees became pastor the following year. The initial building was built on a site given by W.T. Dees and wife, (Present location of the Edward McCray residence) Jan. 14, 1898. This building was destroyed by a hurricane in 1898 and never rebuilt.

It appears from 1898 until June 18, 1909 Baptists worshipped in the Mayo Methodist Church on alternate Sundays, operating a union Sunday School. In 1905 the present building site was secured from the same donors and plans made for building. On June 18, 1909 the new building was dedicated, free of debt, Rev. C.B. Cole was pastor one Sunday a month, and served Perry three Sundays. During this eleven year interim, R.W. Phillips, R.F. Hacker, D.B. Harrell, W.L. Savage, and Rev. Dees served only one Sunday a month.

Rev. J.B. Rodgers, Ovedio, Fla., was called to be pastor in Dec. 1909. The membership was 86. Early in 1910 a Baptist Sunday School was started with M.D. Rich the first Supt. R.R. Ware was church clerk, Mrs. H.T. Wilkes, first W.M.U. President, Ministerial Students from Columbia College, Lake City, pastored during the teens. They included W.T. Saunders, W. Ira Sanders, J.T. Jenner, Scott Patterson (Longtime missionary of Foreign Mission Board), G.H. Newton, Blanchard D. Law, and E.C. Dickens. The church withdrew from the Lafayette Baptist Association and united with Middle Florida Baptist Association in late 1909.

Late in 1919 Rev. D.F. Barry of Madison accepted the pastorate now reporting 111 members. Two years later the first resident pastor was called in Rev. J.F. Russell serving the church half time. During his pastorate Irwin Radford was ordained as a deacon. After six years Rev.Russell was followed by Rev. E.R. Denny as interim for several months. Rev. S.P. Morgan from Texas was called in July 1927 and served less than a year and was followed by Rev. Gus Padgett of Ft. McCoy who because of distance served but six months prior to the call of Rev. A.M. Parker, of Pinetta in early 1930. During this year Deacon R.R. Ware died. H.L. Winderweedle was ordained deacon Sept. 13, 1931. While three-fourths time preaching was desired it was agreed to continue twice a month. During the next six years the first B.Y.P.U. came into being with Miss Werna Townsend as Director, followed a year later by Guy McClain, when changed to Training Union. Rev. W.T. Newsome of Live Oak pastored for two years until Rev. A.M. Parker was recalled in September. 1937 and served until mid-1939, Rev. Roscoe Hall was called and remained only six months.

Seeking to have a full-time ministry, Rev. Julian Dyess was called in February

1940. Due to existing conditions it was necessary that Brother Dyess divide his time with Hatch Bend Baptist Church. Guy McClain was ordained a deacon December 13, 1940.

The first Brotherhood was organized with the aid of Mr. Upchurch on March 11, 1942. Rev. Dyees resigned in 1943 to enter Military Service. Mr. and Mrs. M.F. Folsom deeded the Manachi home to the church for a pastor's home with a reverter clause in the deed. After the church purchased the Lester Summersill home at corner Pine and Fletcher streets the Manachi home was reverted to the Folsoms, in 1948.

It was in 1944 that the church attained it's first membership of 200. During this year Rev. Horace C. Harvey of Cordele, Ga., was pastor, and was succeeded by Rev. Mark Scarborough from Tennessee. In 1947 the first Bulletin service was begun. Rev. Scarborough served just one year and was followed by Rev. Dave O. Alderman present District 5 Missionary, who served a six month interim period prior to the calling of Rev. M.B. Archibald who served until October 1948. Leon Land and W.G. Croft, Jr., were ordained deacons late in 1946. The Summersill home was purchased for a pastorium, Nov. 1947.

Rev. S.V. Cofield of Newberry, Fla., was called February 16, 1949. Starting in 1951 and continuing through 1953 the present Sunday School Annex was built and finished. Guy McClain, Oneal Boatright, J.D. Garden, Chas. Ware, Harvey Croft and Leon Land along with many others made the project a reality. Rev. Cofield retired on January 1,1957 and resignation was received regretfully and he was asked to serve on three months as interim pastor, during such time Rev. E. Wilbur Carter was called and began service April 1957. While Rev. Carter was pastor, the Choir was organized and robes secured. With Mack Suggs as chairman, Harvey Croft, Guy McClain, J.D. Garden, D.W. West, W.G. Croft, Jr., M.M. Jones and Curtis Goodwin as a planning committee the present sanctuary was designed and built with accessory rooms.

April 17, 1961, Rev. Carter resigned with Rev. S.V. Cofield being called as interim pastor again. May 17, 1961, Rev. Ted M. Jones was called from the Archer Baptist Church and assumed duties July 1, 1961. The sanctuary had just been completed. Since then it has been carpeted and air-conditioned and the Conn Electric organ installed. The last two items were gifts along with many others. More recently the church has been advised of the gift of a neon Bulletin Board to be placed in the front of the church property.

Sunday, Sept. 30, 1962 the church had its Homecoming and the dedication of the new building. It was one of the most successful days in the history of the church. Five former pastors were present to make this a most memorial occasion. In October Floyd Koon and William F. Hart were ordained as deacons. One of the most interesting items of business was transacted on October 9, 1963 when the deacons made the following recommendation: "That the Harvest Offering be used to install a public address system in the nursery". The motion passed.

To demonstrate the wonderful Christian spirit always evident in this great church, at a called business meeting in February 1964 the church voted to give Rev. Cofield, a former pastor so affectionally loved and appreciated by all, the Christmas offering, except a part to finish the Lottie Moon Christmas Offering quota. This offering was made to him to help pay his hospital expenses. The amount was \$182.50.

In keeping with contemporary events, in May 1964 the church observed a National Day of Prayer in accordance with the President's Proclimantion. A prayer service was held at the church from 11:00 A.M., until 12:00 noon. Later the church went a step further and passed a motion opposing an amendment being added to the constitution providing for prayer in the public schools. "We did not oppose prayer in public schools, but opposed an amendment to the constitution".

Rev. Ted Jones offered his resignation in August of 1965 to become pastor of the Haywood Cates Memorial Church in Tallahassee. His resignation was effective Sept, 12th. In October 1965 Rev, Harold Harllee was called as pastor. At this time a stove and refrigerator were purchased for the pastorium.

In Jamuary of 1966 the church licensed Bro. A.E. Wimberley into the gospel ministry, He was ordained in March with the Rev. Dave Alderman bringing the message. In Sept. 1966 the annual homecoming was observed.

October 11, 1967 Martin Trawick was placed on the active deacon list. A year later, October 1968, a rotation system for the Board of Deacons was submitted to become effective January 1, 1969. There will be six active deacons from which two will become inactive each year to be replaced by two men selected by the church. This has proven to be a very effective means of supplying our church with qualified and capable deacons.

In the summer of 1969 the church voted to air condition the Sunday School rooms. Shortly afterwards in keeping with the missionary emphasis of the church, we gave \$1,000,00 to the Dave Alderman Chapel at the Assembly Grounds at Picket Lake.

In August of 1970 Rev. Harold Harllee submitted his resignation to become effective in October. Rev. V.C. McDonald was asked to serve as interim pastor. In January 1971 Rev. William F. Ivey was called as pastor, and he arrived on the field in February. The pastorium was completely remodeled including central heat and air conditioning, paneled throughout, and fully carpeted.

In April 1971 the church purchased a new Hammond Console organ and one Hammond Speaker. This organ has done much to enrich the quality of music and create a worshipful atmosphere in our services. At this time a youth choir was begun that has been a blessing to us all. In September 1971 A.H. Spilman was placed on the active deacon list and Curtis Hilton was ordained as a deacon.

In April new tables and chairs were purchased for our annex. In August a donor purchased new hymnals for our adult choir. The church also purchased binders at this time.

We are tremendously proud of our long and meaningful history. For over 78 years this church has been a faithful witness for our Lord and Saviour. The love, loyalty, and dedication of the saints of old challenge us to greater levels of spiritual commitment. We eagerly and expectantly look forward to the exciting challenges and experiences of tomorrow as we faithfully discharge the responsibilities of today.

A HISTORY OF THE ELIZABETH BAPTIST CHURCH 1972

DOUGLAS W. MITCHELL - PASTOR



The Elizabeth Baptist Church was constituted in 1831. The church is located about ten miles east of Monticello. It was the second church to be constituted in Jefferson County.

Reverend Jesse Goodman was the first pastor. His wife's name was Jane Littleton. Some of the original members were James Walker, Elizabeth Walker, Jesse Walker, Charles Walker, Sarah Walker, and Caroline Kinsey. Early deacons were Jesse Walker, Joseph Kinsey, Joel Kinsey, Joel Walker, A.J. Whitehurst, S.P. Hartsfield, S.M. Scruggs, J.M. Hamrick, G.B. Walker, and W.B. Walker.

In 1832, Reverend Richard J. Mays of Madison County, Florida, was called as pastor. The Middle Florida Baptist Association was organized in his home at Clifton in Madison County. Elizabeth was a member of the Florida Baptist Association until the Middle Florida Baptist Association was organized. At that time, Elizabeth became a member of the Middle Florida Baptist Association,

A new church building was constructed in 1900. This one room building is our present auditorium. There were two previous buildings.

In 1928, M.J. Fowler was pastor. Services were held each fourth Sunday with 134 church members. This was the year that "Women's Work" started. There were six members to begin with: Mrs. Ethel Lewis, Mrs. Lillie Walker, Mrs. Lizzie Standley, Mrs. A.P. Hartsfield, Mrs. Emma Walker, and Mrs. Lizzie Ryan,

In 1930, a pulpit and aladdin lamps were purchased. Sister Emma Hamrick and Sister Sadie Stubbs gave material to build four Sunday School rooms. Members of the church donated their labor. On July 5, 1931, the new Sunday School rooms were dedicated with Reverend Aldrich delivering the dedication sermon. The building committee was made up of W.J. Hamrick, I.W. Shepherd, and Glosen Walker.

On September 20, 1931, Elizabeth celebrated its 100th anniversary. L.N. Addrick preached the message, Mrs. Lizzie Standley read the church history.

In the early forties, a mission was organized. Services were held on Saturday nights and Sunday afternoons. The wood frame building the services were held in was on the George Demott farm. After the close of World War II, it was disbanned and several families came into Elizabeth from the mission,

In 1948, four more Sunday School rooms were built. Brother A.M. Parker was the pastor.

In 1949, a Brotherhood was started. Norman Hartsfield was president.

In 1950, water was pumped from Mrs. Lellie Walker's to the church. The church was painted on the outside and concrete steps were erected at the side and rear of the building.

On August 26, 1951, the church voted to have services every Sunday beginning October 1, 1951,

A new attic fan was installed in July of 1952,

In 1953, additional Sunday School rooms, a dining room, and a kitchen were built. In 1957, the pulpit area was remodeled and new furniture was purchased. The auditorium and the adjoining four rooms were remodeled.

In 1959, W.J. Hamrick gave the carpet to the church in memory of Mr. and Mrs. Alfred Hamrick.

In 1960, gas heaters were installed throughout the church.

In 1967, Mr. and Mrs. J.W. Shepherd started the Elizabeth Baptist Church Cemetery Trust. This Trust is used to maintain the cemetery. An additional acre of land was deeded by Mr. B.J. Hamrick to the cemetery.

In February of 1967, Mr. and Mrs. H. M. Warren deeded the church one acre of land for a pastorium. The well was dug in 1967. A loan of \$10,000 was secured from the State Mission Board. In September of 1969, there was a special Fund Drive and \$3,000 was donated for the pastorium. L.T. Carter was the contractor. The pastorium was completed in May of 1970. On the building committee were Herbert Demott, Chairman, Allen Lightsey, Norman Hartsfield, Madge Shelley, and Walter Bailey, pastor.

In 1968, new oak flooring was put in the auditorium and the four adjoining Sunday School rooms.

In 1970, central air and heat was installed in the auditorium and six of the Sunday School rooms,

The church library was started in 1968.

The church has used different places of baptism. Some of these places include the Aucilla River, Lake Logan, Silver Lake, and the First Baptist Church of Monticello.

Church discipline has changed through the years. In the early years, members were dismissed for non-attendance and non-Christian conduct.

At the time this history is being written, (October 1972) the church is in the process of deciding whether to brick the outside of the building or cover it with some type siding.

The Lord has used the witness of the church through the years to win many souls and to enlist many into Christian service. We are grateful to God for the church. Our prayer is that God will continue to use Elizabeth Baptist Church in His service.


