#### Report on Education.

We live in an age of schooling, alias training, alias education. The schools are for training and training for education; but, alas, we often have distinctive designations rather than resultant effects.

And yet, to our schools of all grades we must look largely for the education of our children. It should not be forgotten, however, that illiteracy percentages are often professional "Hob-Goblins" conjured up to work the secret combinations of public treasuries. Illiterate and uneducated are not necessarily synonymous. Education is the mind drawn out to the full capacity of efficiency, whether that be done in the schools with books, or in the school of thoughtful experience. Hence it is that some of the most notable instances of human power have been men almost or entirely ignorant of letters: Of them, as of our Savior, it may be said, "How knoweth this man learning, having never learned?" There is education in spite of illiteracy.

Nevertheless, since many of our ablest and truest men have given the best that is within them to, the effort to adapt our schools to educational purposes, it must be that here we should find our most efficient servants in so great an undertaking as the education of our youth. Admittedly much improvement is needed.

In the effort to educate, not to specialize, whether in or out of the school room, Baptist principles form "First Aids" to success. Having nothing to dodge, being ready to face facts always, seeking to know and obey "the truth, the whole truth and nothing but the truth," the mind is best freed from "hoops and bands" as it is drawn out to full capacity. Baptist obligation is, therefore, first in importance. Because we can do it best, we should be at it most earnestly.

Nor have Baptists been negligent of their opportunity and obligation. We have been conservatively progressive. On the one hand we have never set an educational standard for the ministry; on the other hand every legitimate effort to furnish opportunity for the highest literary attainment for both pulpit and pew has been encouraged. As a result we have always had men of distinguished literary attainments laboring side by side with equally noble, and sometimes equally efficient men, whom the world in its shortsightedness calls "ignorant and unlearned." Men brought up at the feet of the Gamaliels have worked shoulder to shoulder with the "men of Galilee." We believe this to be the Gospel plan. Without violating any bible principle, we are able to employ the best brains, the highest culture, and whatever wealth we may be able to control for the advancement of the kingdom of Christ. All over this land, and in many other countries, we have well equipped and fairly well endowed colleges and universities for literary work. We have also what we believe to be the best theological seminary in the world at Louisville, Ky.

Here in our own state we have institutions which, while young and inadequately endowed, are well worthy our patronage and support. Columbia College at Lake City is rapidly proving her claim to an enviable position as a school of higher education, and is reported as starting the year's work most auspiciously.

Dr. L. W. Warren is now in the field in an attempt to raise much needed endowment for Columbia College. His success so far has been remarkable. Let us be swift to encourage and help him in every way possible.

As we look to the future, let us give all the support we can to Christian Education, especially as attempted by our own denomination.

#### Report on Sunday Schools.

We, your committee on Sunday Schools, respectfully submit the following report:

We find by the report of 1911, that there was an attendance of 645 pupils and teachers, in fifteen of our Sunday Schools, against the membership of 1,355 members in nineteen churches of Alachua Baptist Association.

This shows that out of twenty-six hundred children of Baptist families, only about one-fourth of the children attend Sunday Schools.

The number of scholars baptized from our Sunday Schools show only one conversion to each Sunday School.

As the salvation of our children depends upon them being brought in touch with our Sunday Schools, We, the committee, urge the parents of the different churches to attend with their children our Sunday Schools, so that more effective work may be done, and the attendance in our Sunday Schools increased.

#### Report on Missions.

The subject of Missions should be the deep concern of every Baptist. Jesus said before he left the world: "As My Father hath sent Me, even so send I you." Ghost." These are our marching orders. When we study the history of our work and see the progress we have made and how God has so wonderfully blessed our mission work, it ought to stimulate us into activity. Still if there were no visible results the command to go and preach the Gospel is the same. The opportunity is laid upon us as never before. Has there been such an opportunity as now? The wealth of the South is increasing at a rapid rate. The nations of the world are pouring into our country as never before. They are ready to hear the Gospel. Will we give it to them? Our Foreign and Home Boards, fostered by the convention, are a great work and should have the sympathy and support of all Baptists. We are asked to raise \$10,000 for each of these two boards this year.

Your committee would specially emphasize the importance of our State Mission work. The great number of foreigners pouring into our state daily should awaken us into a state of activity as never before, and if we can get them under Baptist influence and give them the pure Gospel they will prove a blessing to our country; if not, just the reverse.

The Baptists are decidedly the leading denomination of our state, numbering over 50,000. We have on the field 71 missionaries who are doing work in every Association in the state. Our efficient Secretary, S. B. Rogers has put forth and is putting forth strenuous efforts to evangalize the state. In order to do this he has been forced to borrow money to keep the workers on the field. Unless the churches rally to the support of the State Board we will go to the convention with a big debt. We would recommend that our pastors preach on missions more, and urge their people to give as the Lord has prospered them.

#### Woman's Missionary Union.

During the session of the Alachua Association, the Woman's Missionary Union, auxiliary to that body, held a very interesting and instructive meeting in the Methodist church on Friday the 11th inst.

In behalf of the Ladies' Aid Society of the Brooksville church, Mrs. John Law kindly and cordially welcomed the Union to their town.

A very comprehensive program had been prepared.

The meeting was opened with devotional exercises conducted by Mrs. J. O. Abbot, one of the vice presidents.

Several interesting articles, referring respectively, to foreign, home and state missions, were read and commented upon.

Mrs. Abb Crenshaw, of Coleman and Mrs. J. Q. Abbot, of Leesburg, were unanimously re-elected vice presidents for the ensuing year. Mrs. Hughes of Center Hill, was appointed as a delegate to the W. M. U. of

the State convention, which meets in Lakeland in December.

A collection of \$2.90 was taken for State Missions.

Very few of the societies sent reports to the Union but the amount of \$156 15 was reported from the following: Brooksville, \$49.30; Lady Lake, \$16.00; Leesburg, \$71.85 and Oxford, \$19.00.

After prayer and singing "God Be With You Till We Meet Again," the meeting adjourned.

## Constitution of the Alachua Baptist Association.

Article 1. This body shall be dominated the Alachua Baptist Association.

- Art. 2. It shall be composed of such churches as hold the doctrine of human depravity, the atonement of Christ, election of eternal life, regeneration and persevereance of the saints, baptism by immersion of the persion in water, administered to none except professed believers, and the Lord's Supper intended for those only who have been regularly admitted in the visible church.
- Art. 3. We take the only living and true God, in three persons, Father, Son and Holy Ghost to be one God,
- Art. 4. We take the scriptures of the Old and New Testaments to be the only rule of faith and practice, both in the concerns of religion and the general of life, and particularly for transacting the affairs of our churches.

- Art. 5. We take Jesus Christ to be the great head of the Church, and the only one given; that the government under Him is with the Body, and is the privilege of each individual member; that spiritual discipline, with an eye single to the glory of God, must greatly conduce to the final prosperity and union of the churches.
- Art. 6. In view of the increase of fraternal love, knowledge, usefulness, and efficiency which must accrue from an association of churches, in cordial union upon the principles of the gospel, we have sought to be united, that by individual and collective action we may best subserve the great objects of the Redeemer's kingdom. And the concurrence of two-thirds vote of the body will dissolve the connection.
- Art. 7. This Association shall have power to withdraw its connection from any church which shall act contrary to the teachings of the Holy Scriptures.
- Art. 8. New churches wishing to be admitted into this body shall petition by letters and messengers, and upon examination, if found orthodox and orderly, shall be admitted by receiving the right hand of fellowship of the Moderator.
- Art. 9. Each church shall be entitled to two messengers, and one additional for each twenty-five members, one fractional part thereof, in excess of fifty.
- Art, 10. Every query sent to the association by any church in its union shall be read and put to a vote by the Moderator, whether it shall be debated, and if there shall be a majority in favor it shall be taken up and debated, but if not, it shall be withdrawn; provided, always, that those be first considered which effect the union of the churches.
- Art. 11. Every motion made and seconded shall come under the observation of the association, unless withdrawn by the mover.

- Art. 12. Every member who speaks shall rise from his seat and address the Moderator, and shall not be interrupted while he is speaking unless he depart from the subject.
- Art. 13. No person shall speak more than three times upon one subject without permission from the body. The constitution of this body may be altered or amended by the concurrence of two-thirds of its members.
- Art. 14. No person shall absent himself from the association without leave of the Moderator.
- Art. 15. It shall be the first business of this Association to provide for the general union of churches; second, to provide for the destitution of the churches and districts by missionary aid; third, to keep up a correspondence with other associations of like faith and order, that a chain of communication may be preserved among the churches; fourthly, to give the churches the best advice they can in matters of difficulty, and if communication should be broken between any of the sister churches, to inquire into the cause, and the best means to remove the difficulty; but if the breach cannot be healed, to withdraw from such church or churches as walk disorderly, until they may be reclaimed; and, fifthly, to regulate all matters pertaining to its business, to provide for printing its minutes, and appoint the time and place of its next meeting.

#### By-Laws.

- 1. The officers of this body shall be a Moderator, Clerk, Corresponding Secretary, and Treasurer.
- The Moderator, Clerk, Treasurer and Corresponding Secretary shall be chosen by ballot at each session of the association, and shall remain in office until their successors are elected.
- 3. It shall be the duty of the Moderator to preside over the meetings of the association, and the duty of the Clerk to keep record of the proceedings and prepare the minutes for the press.
- 4. It shall be the duty of the Corresponding Secretary to conduct the correspondence of the association, and make a report of the same at each regular meeting of the body. It shall be the duty of the Treasurer to keep all the funds of the association, subject to the order of the Executive Committee.
- 5. There shall be an Executive Committee appointed at each meeting of this association, of five brethren, whose duty it shall be to supervise and conduct all matters pertaining to this association during the year.
- 6. Churches wishing to dissolve connection with this body must submit their reasons during its session.
- 7. It shall be required of the Executive Committee to hold a meeting for business at each session of the association, before its adjournment.
