Constitution

Article 1. This body shall be denominated the Alachua Baptist Association.

Art. 2. It shall be composed of such churches as hold the doctrine of human deprayity, the atonement of Christ, election to eternal life, regeneration and perseverance of the saints, baptism by immersion of the person in water, administered to none but professed believers, and the Lord's Supper intended for those only who have been regularly admitted into the visible church.

Art. 3. We take the only living and true God, in three persons, Father, Son and Holy Ghost, to be one God.

Art. 4. We take the Scriptures of the Old and New Testament to be the only rule of faith and practice, both in the concerns of religion and the general affairs of life, and particularly for transacting the affairs of our church.

Art. 5. We take the church of Christ to be a congregation of faithful persons, who live in fellowship, and have given themselves to the Lord and to one another in cordial agreement to observe holy discipline, in conformity with the requirements of the Scriptures.

Art. 6. We take Jesus Christ to be the Great Head of the Church, and the only one given; that the government under Him is with the body, and is the privilege of each individual member; that spiritual discipline, with an eye single to the glory of God, must greatly conduce to the final prosperity and union of the churches.

Art. 7. In view of the increase of fraternal love, knowledge, usefulness, and efficiency which must accrue from an association of churches, in cordial union upon the principles of the Gospel, we have sought to be thus united, that by individual and collective action we may best subserve the great objects of the Redeemer's kingdom. And the concurrence of two-thirds will dissolve the connection.

Art. 8. This association shall have power to withdraw its connection from any church which shall act contrary to the teachings of the Holy Scriptures.

Art. 9. New churches wishing to be admitted into this body

shall petition by letters and messengers, and upon examination, if found orthodox and orderly, shall be admitted by receiving the right hand of fellowship of the moderator.

Art. 10. Each church shall be entitled to two messengers, and one additional one for each twenty-five members, or fractional part thereof, in excess of fifty.

Art. 11. Every query sent to the association by any church in its union shall be read and put to vote by the moderator, whether it shall be debated, and if there shall be a majority in favor it shall be taken up and debated, but if not, it shall be withdrawn: provided, always, that those be first considered which affect the union of the churches.

Art. 12. Every motion made and seconded shall come under the observation of the association, unless withdrawn by the mover.

Art. 13. Every member who speaks shall rise from his seat and address the moderator, and shall not be interrupted while he is speaking unless he depart from the subject.

Art. 14. No person shall speak more than three times upon one subject without permission of the body. The constitution of this body may be altered or amended by the concurrence of two-thirds of its members.

Art 15. No member shall absent himself from the association without leave of the moderator.

Art. 16. It shall be the first business of this association to provide for the general union of churches; second, to provide for the destitution of the churches and districts by missionary aid: third, to keep up a correspondence with other associations of like faith and order, that a chain of communication may be preserved among the churches; fourthly, to give the churches the best advice they can in matters of difficulty, and if communication should be broken between any of the sister churches, to inquire into the cause, and use the best means to remove the difficulty; but if the breach can not be healed, to withdraw from such church or churches as walk disorderly, until they may be reclaimed, and, fifthly to regulate all matters pertaining to its business, to provide for printing its minutes, and appoint the time and place of its next meeting.

BYLAWS.

- The officers of this body shall be a moderator, clerk, corresponding secretary and treasurer.
- 2. The moderator, clerk, treasurer and corresponding secreatry

shall be chosen by ballot at each session of the association, and shall remain in office until their successors are elected.

It shall be the duty of the moderator to preside over the meetings of the association, and the duty of the clerk to keep record of the proceedings and prepare a minute for the press.

4. It shall be the duty of the corresponding secretary to conduct the correspondence of the association, and make a report of the same at each regular meeting of the body. It shall be the duty of the treasurer to keep all the funds of the association, subject to the order of the executive committee.

5. There shall be an executive committee of five brethren appointed at each meeting of this association, whose duty it shall be to supervise and conduct all matters pertaining to this association during the year.

Churches wishing to dissolve connection with this body must submit their reasons during its session.

7. It shall be required of the executive committee to hold a meeting for business at each session of the association, before its adjournment.

The association completely organized was welcomed by Pastor Martin, Bro. M. E. B. Robinson, Sunday school superintendent, and Mayor Wicker of the town of Coleman in a most happy, jocund and cordial manner, which was responded to by Elder Simpson S. Mathis of Dunnellon.

After announcements and singing "How Firm a Foundation," adjourned to 9 a. m. Prayer and benediction by Dr. Rogers.

Thursday Morning.

Devotions, led by the chair, whereupon the discussion of organization, order of business, reading annual reports, etc., was entered into by Elders Spicer, Corbet and Kingsley. Ruled and ordered that the church letters be read at 6:45 p. m.

The first to report was the committee on missions.

Missions.

The lack of space renders it necessary to give only a very inadequate report upon this all important subject.

At no time in the world's history have the calls for and opportunities to worldwide missions been so great. The work of the

kingdom is one. We have been led to make injudicious and sometimes hurtful distinctions. Whether in Jerusalem and the surrounding country, or in the "regions beyond," the story is the same and the object the same. It is only the necessities of operation that call for distinction by names. The spirit is the same. The man who is not a missionary advocate is shortsighted and should not be surprised to find himself at any time relegated to the rear or entirely disqualified. Drones may be important to the hive for a season but when the real working days come they are disposed of.

Therefore, giving to missions its ordinary meaning we misconceive the intention when we think of it as separated from other work of the kingdom and when we minimize its importance.

We think it is safe to say that until the beginning of this terrible European war our mission work, in all lines, was advancing with a rapidity never before known. There were more men on the fields of the world and more money being expended in making the work of these efficient, with results undreamed of by our fathers, who so nobly plasmed for great things, than at any preceding period. Now our work is feeling the dreadful depression and there is fear of a call for retrenchments. Shall this be? The answer is largely with us.

This is no time to yield to discouragements. For the next twenty-five or thirty years the burden of the world's progress must rest very largely upon this country—the United States. Europe will be so impoverished as to be unable to do little more than care for the unfortunate victims of this awful strife. Is there not in this an urgent call to greater activity than we have heetofore known?

Detailed account of the work of the several boards will not be attempted. The boards are well known and have won entire confidence. The need of the hour is courageous and self-sacrificing effort to keep the work up to the high state of efficiency attained and to advance, if possible. All our boards—state, home and foreign—are in pathetic need of funds. They fully recognize the difficulties surrounding and oppressing our people. But it is a life and death struggle. Let us respond to the call as never before; let each return to his home with a strong, determined will to do and sacrifice and give as never before.

B. Y. P. U.

Your committee notes with regret the fact that there are very few B. Y. P. U. organizations in our association. The reports of the churches show that scores of young people have been received into the churches during the past year, but we are doing little to train them.

The daily papers said of the German army a few days ago, "A large per cent of the men now at the front are young men, untrained in military tactics." Commenting upon the situation, it was prophesied that with the implements of warfare in the hands of these untrained men they would necessarily lose ground.

We have a mighty army of young men and young women in our churches, and as our older soldiers fall on the battlefield these young men and women are to man the guns. Yet Satan's emissaries are delighted as they face the prospect of combating an untrained army. This age is extremely a practical one. Men in all vocations of life are demanding results. Success in this age is measured not by effort but results. While training our sons and daughters in banking, engineering, farming, bookkeeping, domistic science etc., shall we neglect to train them in the service of the Kingdom?

We have our various institutions of learning and particularly our own Columbia College, and we spend considerable time regretting that we can not send our sons and daughters there, while the B. Y. P. U., the college of the church, is neglected or antagonized. Let every church erect its own school (B. Y. P. U.) for technical training of our youth in the things of the kingdom of God, that in the not distant future when the affairs of the kingdom shall fall upon their shoulders and the weapons of the Christian warfare fall into their hands, they may be able to march forward against the enemy of right and like the trained soldiers which they will be, follow their Leader to victory in His name.
