PROCEEDINGS

The Alachua Baptist Association convened in its ninety-seventh annual session in the First Baptist Church, Inverness, Florida, November 12, 1943, at 10:00 A. M. opened by singing "All Hail the Power of Jesus Name."

The devotional was given by Bro. Frank Tuttle, in the absence of Bro. W. A. Rector.

A very hearty welcome address was given by Dr. E. D. Jeter.

Bro. C. N. Bennett brought the response in an impressive manner.

It was called to our attention that our beloved Brother Boatwright was in the Georgia Baptist Hospital in Atlanta. A motion was carried that we pause in our session for special prayer on his behalf. This seemed good in the sight of the brethren. Dr. E. D. Solomon led us to the throne of Grace.

A motion was carried that a telegram be sent to Bro. Boatwright expressing our concern and prayer for his speedy recovery.

A motion was carried that the messengers present and those coming later compose the body to transact business for the Association.

A motion was carried that the program as printed be adopted with such changes as may be necessary during the day.

The Moderator recognized the brethren from the State Board as follows: Dr. E. D. Solomon, Dr. J. Harrison Griffin, Bro. Dewey Mann, Field Secretary representing Dr. C. H. Bolton, our Executive Secretary. Bro. and Mrs. J. M. Sentell of Dunellon, Marion Association, were also recognized as visitors. Bro. Tuttle introduced Miss Smith and her mother. Miss Smith spent several years in missionary work. Mr. Fred T. Barnett representing the Temperance Committee was introduced.

The Moderator appointed the following committees: Time, Place and Preacher—Bro. W. A. Rector, Chairman. Nomination—Bro. C. N. Bennett, Chairman. Resolution—Bro. C. K. Byerly, Chairman.

Bro. Dewey Mann, Field Secretary, brought his report of the State Mission Board.

Report of the Baptist Brotherhood of the Association was read by Bro. C. N. Bennett in the absence of Bro. T. J. K. Funderburk, President. Dr. J. Harrison Griffin, State Brotherhood Secretary, spoke on the report, encouraging the brethren in their newly organized work.

In the absence of Mrs. D. M. Edwards, President of the Associational W. M. U., no report was available.

Dr. E. D. Solomon spoke on the Children's Home.

The Annual sermon was preached at this time by Bro. C. K. Byerly.

FRIDAY AFTERNOON

Devotional was given by Deacon V. F. Hollifield.

Bro. C. K. Byerly, Associational Sunday School Supt., gave the report of the Sunday School. Some very encouraging facts was brought to our attention in this report.

Report of the Southern Baptist Hospital at New Orleans, La., was given by Bro. Bob Catledge. Dr. E. D. Jeter, who for some time did mission work in Louisiana with the "Cagans," gave a very interesting and instructive account of the ministry of medicine and the gospel.

No report on the Hundred Thousand Club.

Bro. C. N. Bennett read the report on Christian Education. He then spoke of the needs that exist at our own University; urging, that: we as Florida Baptists should stand by and uphold it in our prayers and gifts.

A report on the Alachua Associational Camp Ground was read by the Moderator sent in by Bro. J. C. Boatwright to the effect that at present there is about (\$50.00) Fifty dollars in the treasury. No actual work has been done on the project for some time due to the lack of funds and a shortage of labor.

By a unanimous vote of the body in session a motion was carried that the office of Clerk and Treasurer be held by the same person.

FRIDAY EVENING

Devotional was led by Bro. Fletcher Weston.

Report of the B. T. U. read by M. E. Hammond, Associational Director. O. K. Radford brought a challenging message urging greater accomplishments in the coming year.

The Session was closed with an inspirational message by Bro. C. N. Bennett.

REPORT OF THE ASSOCIATIONAL BAPTIST TRAINING UNION

The Alachua Associational Baptist Training Union was reorganized during the year and after some difficulty now has a complete organization of officers. Previous to that time both the East and West groups had been functioning and meeting regularly.

The purpose of this work is to promote the Baptist Training Union in each of our Churches and to assist those Churches in any way possible. In order to work toward definite attainments, certain goals were set at our annual one day meeting held in Bushnell last March. These goals included the organization of fifteen new unions and Story Hours in the various departments and three new Training Unions. The Adult and

Intermediate departments have attained their goals and during the year the following number of unions were reported: Adult, 7; Young People, 4; Intermediate, 8; Junior, 8; Story Hour, 3; total unions—30 from ten churches. The goal for Study Course Awards was set at 125 and 161 were issued from seven different churches.

Since reorganization one Executive Committee meeting and one Mass meeting combined with an Officers and Leaders Council have been held in addition to the regular group meetings. It is planned to have regular quarterly Executive Committee meetings in the future for planning the program of activities to be sponsored. These meetings are to be followed by the Officers and Leaders' Council to get the plan before the training unions in the various churches.

In the Spring an Intermediate Sword Drill was held to select a representative to the assembly. Tommy Savory of Inverness won this contest and was placed fourth in the State Contest. In addition to the Intermediate Sword Drill it is hoped that we can select someone to represent us in the Better Speakers' Tournament at the 1944 Assembly.

The Plan adopted for financing the Associational Training Union has been for each training union to make an offering each month. This will be used for postage, travel and other expenses necessary to the promotion of this work.

This report is presented with the prayer that each person who hears it will become more interested and better informed in regard to this work of training all of our church members that each one may be of greater service to his Master. M. E. Hammond, Associational Director.

REPORT OF THE BROTHERHOOD

During His ministry, the Master called men to follow Him that they may become teachers and workers in His Kingdom. That call has continued through the ages to this present day; many have responded, but too few, I'm afraid, are serving.

These are Christian men, inactive, in some cases because of lack of opportunity; their enlistment in the service and support of the entire denominational program is the responsibility of the Churches. The Response of the Church to this challenge

is the Brotherhood; every Church needs a Brotherhood because it needs men.

It is the earnest desire and prayer of the president, that at least every full time Church in this Association have an efficient functioning Brotherhood before the end of another Associational year. This was voted our goal at the last quarterly meeting in Brooksville, the fourth of this month. At present there are three; namely: Brooksville, Bushnell and Center Hill.

The president has endeavoured to contact several Churches asking for the appointment of key men to promote this cause. The response so far has not been satisfactory; however, there is evidence of a growing interest.

The Associational work is less than six months old, being organized at Bushnell last, and with a little more time and prayer, we feel our men will be stirred into activity by the realization of their need, and the need of the Church for their tested judgment in the business aspects of our denominational life and the evangelization of the world.

OUR CONSTITUTION

- 1. This body shall be known as the Alachua Baptist Association.
- It shall be composed of Churches generally recognized as Missionary Baptist Churches.
- 3. It's session (Legislative, Administrative, Promotional and Fellowship), shall be of regularly elected representatives of the churches composing its membership and other members of said churches who may be present and who may be accepted by the elected members on the basic of two Messengers from each church, and one additional for each twenty-five members or major fraction part thereof, in excess of fifty.
- 4. The officers shall be a Moderator, Vice, Moderator, Clerk-Treasurer, BTU, SS, WMU Directors and resident Pastors of the Association, elected annually by the vote of the Messengers.
- 5. The Executive Committee shall be the above named officers.
- 6. The Moderator shall preside over the sessions, keep order, take the vote on all quqestions properly presented and perform such other duties as are usual to such off cer. The Clerk shall keep a record of the proceedings of the body in session, have the same printed and distributed to the churches according to the funds provided and as the body may direct. The Treasurer shall keep an accurate record of all monies received; pay out upon the instruction of the body and make an itemized report of same to the Association at annual session.
- 7. The Executive Committee shall have general supervision of the work fostered by the Association. It shall meet quarterly and plan for the promotion of various interests of the organized work, using its best efforts to stimulate the spirituality and activity of the churches, and shall make report of its work to the Association in its annual session
- 8. The Association shall meet annually at such time and place as may be agreed upon by the body; or when necessity arises, by the Executive Committee.
- 9. Churches may be admitted to membership in this Association by representatives bearing a petitionary letter with statistical data; provided they are found to be orthodox by a committee appointed by the Moderator. Upon a favorable vote of the body, the Moderator shall extend the hand of fellowship on behalf of the Association.
- 10. The Association shall have the right and the power to withdraw felowship from any church in its membership, upon grounds which it may deem justifiable.
- 11. Any Church shall have the right to withdraw from the Association upon due notice to the body.
- 12. Any Church failing to report to the Association, neither sending representatives or letter, twice in succession, shall be dropped from the roll of active members and put on a list of "inactive churches."
- 13. This Constitution may be altered or amended by a two-thids vote of the body in session.
