OUR CONSTITUTION

- 1. This Body shall be known as the Alachua Baptist Association.
- It shall be composed of churches generally recognized as Missionary Baptist Churches.
- 3. Its session (Legislative, Administrative, Promotional and Fellowship), shall be regularly elected representatives of the churches composing its membership and other members of said churches who may be present and who may be accepted by the elected members on the basis of two Mesengers from each church, and one additional for each twenty-five members or major fraction part thereof, in excess of fifty.
- The Officers of the Association shall be the Moderator, Vice Moderator, Clerk-Treasurer. Also the Presidents of the Sunday School, W.M.S., B.T.U., and Brotherhood.
- The Executive Committee of the Association shall be the above named officers, together with all resident pastors in the Association.
- 6. The Moderator shall preside over the sessions, keep order, take the vote on all questions properly presented and perform such other duties as are usual to such officer. The Clerk shall keep a record of the proceedings of the body in session, have the same printed and distributed to the churches according to the funds provided and as the body may direct. The Treasurer shall keep an accurate record of all monies received; pay out upon the instruction of the body and make an itemized report of same to the Association at annual session.
- 7. The Executive Committee shall have general supervision of the work fostered by the Association. It shall meet quarterly and plan for the promotion of warious interests of the organized work, using its best efforts to stimulate the spirituality and activity of the churches, and shall make report of its work to the Association at its annual session.
- The Association shall meet annually at such time and place as may be agreed upon by the body, or when necessity arises, by the Executive Committee.
- 9. Churches may be admitted to membership in this Association by representatives bearing a petitionary letter with statistical data; provided they are found to be orthodox by a committee appointed by the Moderator. Upon a favorable vote of the body, the Moderator shall extend the hand of fellowship on behalf of the Association.
- 10. The Association shall have the right and the power to with draw fellowship from any church in its membership, upon grounds which it may deem justifiable.
- Any church shall have the right to withdraw from the Association upon due notice to the body.
- 12. Any church failing to report to the Association, neither sending representatives or letter, twice in succession, shall be dropped from the roll of active members and put on a list of "inactive churches."
- This Constitution may be altered or amended by a two-thirds vote of the body in session.

Moved and carried that the present Clerk prepare the Minutes of the next session, and that the Clerk elected then, would assume his duties at the close of the next session.

Moved and carried that the Homasassa Baptist Church, organized January 6, 1946, be accepted as a member of this Association.

Moved and carried that the Baptist Assembly Ground be held for another year, and J. C. Boatwright was elected Treasurer for this fund.

Moved and carried that all items except the printing of the Minutes of the Association, be put on a pro rata basis as they are paid from our budget.

REPORT OF THE ANNUAL MEETING OF THE ASSOCIA-TIONAL W. M. U. HELD WITH THE BUSHNELL CHURCH, OCTOBER 16, 1946

As president of the W. M. U. organizations of the Alachua Association, I am grateful for the opportunity of reporting to the Alachua Baptist Association the work of the W. M. U. organizations during the Associational year just closed.

The report of the State Convention held in Jacksonville in January credited us with two full graded unions—one at Wildwood and one at Oxford—one A-1 W. M. S. at Oxford, and every resident woman member of this church contributing to missions during 1945.

We have closed the year with the following organizations functioning:

8 W. M. S. societies with a total membership of 173.

1 Y. W. A., 5 G. A.'s, 3 R. A.'s and 4 Sunbeams, these 13 auxiliaries have a combined membership of approximately 100. The gifts of these organizations toward various activities are as follows:

We have held 5 executive committee meetings—at two of which the committee members met for luncheon.

We have a full quota of Associational officers for the coming year.

Our next annual meeting will be held in Wildwood.

At a meeting held in Inverness September 23rd, the Association was divided into two groups as last year, and known as the Eastern and Western groups, with quarterly meetings for the entire Association, meeting as follows:

Two meetings Sunday afternoon, and two meetings on a week night, to determine which is the best attended.

The group meetings will be held the other two months of the quarter as follows: Eastern group, the first Sunday in the month and the Western group the second Sunday in the month, that there is not an Associational Sunday School meeting.

B. T. U. REPORT

The Alachua Training Union Association is made up of 45 Training Unions in 14 churches of the 17 churches of the Association. 11 Adults, 7 Young Peoples, 10 Intermediates, 11 Juniors, and 6 Story Hour groups.

This is a gain of five Unions and two churches over what was reported last year. New work was started in three churches last year. There are four fully graded Training Unions in our Association, according to the latest information we are able to gather.

The Southwide Simultaneous Training Union Day was observed at Wildwood with 180 present, last December 7th.

An Enlargement program was held in four churches, Inverness, Wildwood, Hebron, and Eden.

Intermediate Sword Drill and Better Speaker's Tournament was held in April, at Inverness with good results and interest.

The State department has furnished us several valuable workers during the year, who have been doing a lasting work in our Association, and for which we are grateful.

A complete calendar of activities for the year 1946-47 has been prepared and will be sent out to all churches and workers in the near future.

This report is offered with a prayer that all who read or hear it will become more interested in Training Union work and thereby become more efficient workers in all our churches for our Master's Kingdom.

There is only one Brotherhood doing any organized work in our Association, and that is at Brooksville, and no report of the work done there the past year was sent in, but T. J. K. Funderburk was elected Association president for the year 1946-47.

RELIEF AND ANNUITY REPORT

The relief department of the Board has approximately 1,300 beneficiaries on its roll from all states in our Convention, and has a budget of approximately \$180,000 a year. This amounts to an average of \$8.00 per month for widows, and \$12.00 per month for aged preachers which in this day of high prices for everything we use, will hardly buy enough medicine for common need for an aged person.

The Board's income for this work is derived from: 1st. The income earned from reserves; and 2nd. Cooperative Program; and 3rd. Offerings from churches; and 4th. from special gifts and legacies.

Special offerings should be taken regularly by all our churches for this department of our Board's work for those who draw this money are not eligible to participate in the Annuity Board offers.

The Annuity Department has 13,000 enrolled ministers and other denominational workers at the present time, but there is still a large number of younger preachers who ought to give this matter some thought and get into the plan before it is too late for them to share in it.

There were 1,742 monthly beneficiaries in this plan at the close of the year 1945.

The Widow's Supplementary Annuity Plan is now available to all who will avail themselves of it, and information and blanks are avaliable from the State Mission Board office for all those interested in this work.

AMERICAN BIBLE SOCIETY REPORT

The American Bible Society is a non-profit publishing society located at Park Avenue and 57th Street, N. Y., who have been publishing the Bible and other religious literature since 1816, and is represented by more than 40 denominations.

The President and Vice-President and most of the Board of managers are laymen and women.

In 1945 it published and distributed more than 12 million copies of the Scriptures, much of which went to our armed forces and to foreign territory. A large portion of these went to the lands and into the hands of those who were at that time called our enemies. It is easy to believe that God's Word in the heart of our enemy is far better than a bullet through his head. We may stop him with the bullet, but when he accepts the Bible message, he is made a brother and co-worker to help us instead of fight us.

Many of the books and Bibles are distributed for less than actual cost of production, and can only be paid for by offerings received from interested friends and churches who will help.

MISSION REPORT

The following Mission reports were given by Rev. F. L. Tuttle. Based on Acts 1:8, and Matthew 28:20.

Associational

In the Alachua Baptist Association we have 17 churches, with a combined membership of 2,784 according to reports, 1945. These churches baptized 137 persons, and were cared for by 15 preachers.

The reports from the churches for the year just ended, 1946, shows 19 churches with a total membership of 2,643 persons. They have baptized 122, and have been served by 17 preachers.

State Missions

State Missions includes all the work supervised by our State Board within the State, such as schools, colleges, orphanages and hospital work in a limited way. It also includes our Sunday School, Training Union, Brotherhood, W. M. U., Regional and Rural work. Florida divides the Cooperative Program receipts on a 40-60 basis, and sponsors all our mission work to the ends of the earth. It collects and passes on to the other agencies most of the monies given by our churches for all outside causes, as well as taking care of the work within our own State. State Missions is the "Home Front" of all our mission work, and no program is stronger than the Home base.

Home Missions

The Home Mission Board is actively working among our Negro population, Mexicans and other Spanish speaking groups, Indians, French, and Italians, Chinese and other language groups. We also have the Cuban Mission work, and work in Panama, Costa Rica and the Canal Zone.

The Home Board sponsors work in 587 churches and missions, and needs 327 more. It has 700 workers and missionaries and needs

389 more. It needs two million dollars for properties, and another million each year for operations.

We must keep Home Missions vigorous as a springboard for our great task of carrying the Gospel to all parts of the world.

Foreign Missions

During the past century the Foreign Mission Board has appointed 1,347 missionaries to foreign fields. We closed the past century with 550 missionaries, supported by five and a half million Baptists, or one missionary for every ten thousand of our membership.

As we enter a new century we face many new and wonderful opportunities in the way of open doors for enlarged work. Let us march on, trusting in the power of the Gospel to bring the message of salvation to all the needy and dying millions of earth.
