REPORT ON CHRISTIAN EDUCATION

Christian Education

"Christian Education is education with Christ in it." Yes, Christ at the center of our educatonal framework. This type of education stems from the home where children hear their father and mother in prayer and teaching in precept and example. Likewise, the church, and the Christian college. These three institutions are bulwarks of our American way of life.

Growing Interest

"Southern Baptists are displaying renewed and increased interest in Christian Education. They are building and supporting Baptist Colleges and Schools as never before. In the institutions themselves, rapid strides are being made in the direction of coordination of effort, increased efficiency and financial stabilization.

The observance in Florida Baptist churches of Stetson

Week, Christian Education Sunday and Home Week reflects the growing interest in Christian Education.

Activities

During the year the Department of Christian Education directed the School of Prophets at the DeLand Assembly and the West Florida Assembly at Panama City, the latter enrolling 97 pastors and 27 laymen. There were brought to both of these schools some of our southwide leaders and many pastors. Such conferences were invaluable.

The Orientation Course for ministerial students was inaugurated last spring, bringing to the campus pastors and denominational leaders to acquaint our young ministerial students with the work and function of our denomination and its many agencies. The extension course for pastors is on the way. Just as soon as funds are available, this program will be put into operation.

Publicity

This department directed the showing of the film, "THE DIFFERENCE" in the churches of Florida this past summer, with Bill Guess, a graduate of Stetson, promoting the showing. Brother Guess did a great job, reaching 19,242 persons, with 144 showing and a total of 323 prospective students. The film was shown in each of our 36 associations.

Religious Center

Within a few weeks, the \$100,000 religious center building on the campus of Stetson University will be completed and ready for occupancy. The building is the gift of Florida Baptists to Stetson University in honor of Dr. William Sims Allen, president emeritus.

On Thursday morning, at 11:00 A. M., November 16th, this building will be dedicated to the purpose of making more real the love of God in the lives of the students and faculty. From its lovely lounge furnished inthe casual Early American style to the quiet dignity of the prayer-rooms decorated in the best of taste through he generosity of Dr. W. A. Hobson, the spirit of Christ will permeate throughout the whole of the activities. This building will house the Ministerial Association, the WYA, the Volunteer Band and the Baptist Student Union Executive Council.

The college day will begin with the strains of hymns sung at Morning Watch and will close with the hymns of the Vesper Services which are a vital part of the religious program at Stetson.

Stetson Moves Forward

.. There are many signs of progress on our Baptist campus.

More and more of our fine boys and girls are looking to Stetson for their education. With a scholarly, Christian, consecrated faculty, the best in Christian Education is being offerred. A sizeable percentage of the student body continue to be ministerial students, or those who have volunteered for mission fields or other phases of full-time religious work.

With the completion of the Religious Center a much better program of Christian Education can be and will be fostered. Thus Stetson continues to place great emphasis on Christian Education.

BAPTIST BIBLE INSTITUTE

This is a Baptist institution. It is a Bible institute serving in the institute field, in which there are many interdenominational and nondenominational chools attracting Baptist students for the ministry. These schools have also received large amounts of Baptist money. B. B. I. is true to the Baptist faith, and is fully cooperative in the whole Baptist program. In this environment we believe men and women can be trained to lead our churches. The school is sending out preachers, pastors missionaries, evangelists, and other Christian workers who know Bible terminology, Baptist organizations and Baptist polity.

God has always worked through human instrumentality. "God's plan is a man." Surely providing trained leadership is the best contribution that can be made to any church or situation. God could have led Israel out of Egypt by his omnipotent power alone but He chose to do it through his great leader Moses. God's revelation comes through men. In fact, human history revolves around personalities. This granted, the Baptist Bible Institute is making an important contribution to our whole Baptist program by training and sending forth true and loyal leaders.

There were 15 graduates last year. These and many others have gone out into pastorates and other places of responsibility. Some of them went on to colleges and seminaries. Every encouragement is given them to continue their studies in institutions of higher learning. We are glad to peport also that an increasing number of these colleges and all our seminaries now recognize work done in the Baptist Bible Institute.

One hundred and nineteen have enrolled already for this

session, among whom are 68 students for the ministry. Many of these had pastoral experience before coming to B. B. I. There are in our student body 24 ordained ministers, 6 of whom have been ordained during this year, and several others will be ordained soon. This institution is situated in the midst of large missionary opportunities calling for help. During the year just past multitudes have been won to Christ and baptized into church fellowship by B. B. I. students and faculty members.

Seven new family apartments have been completed this vear, and the men's dormitory doubled in capacity. A temporary building has been fitted for library use, including a room for the book stacks and a reading room. Improvements have also been made in the main building used for offices and class rooms. While these changes have come, there is still pressing ned for additional buildings for student housing, for the library, and for classroom work.

Being interested in moral uplift, B. B. I. gave assistance in the recent dry victory in Polk County. Office space and typewriters were provided without charge and the institute business manager served as executive secretary for United Drys.

The school now has a radio program over WLAK, Lakeland, in which students and faculty take part four days a week. We appreciate this opportunity for an additional ministry. A trained announcer now teaches radio technique in the Institute.

All can help. Individual friends send checks of \$5 to \$100 monthly. Churches, over the state, have B. B. I. in their budgets. Still others take special offerings for this work. Memorial gifts and bequests are especially invited.

REPORT ON THE FLORIDA BAPTIST CHILDREN'S HOME, LAKELAND, FLORIDA

Since relocating the Institution we have completed five cottages for children, a dairy barn, a house for the farmer, a launrdy, the Gaines Vocational Building, the Administration Building and the Chapel. This completes our building program except for two cottages, one for little boys, and one for little girls. We have been granted permission to ask for a special offering this Christmas. The funds received from this offering will be used to erect one of these cottages. We believe the other can b built by income from private sources.

When these two cottages are finished we shall cease building until a definite need arises and funds are available for the maintenance of additional buildings. We think housing for 150 children will, with good case work, meet the needs of our children for some time.

The finances are in good condition. We have received suffi-

cient funds to meet all expenses. We have been remembered in three wills; Mrs. Annie Lively of Lakeland and Mrs. Scholze of Coral Gables made the institution a beneficiary of their estates. The estate of Mrs. Lively has not been closed. Mrs. Scholze gave two thousand dollars; Mrs. Minnie Norwood of Arcadia, \$653.09.

We have cared for 157 children during the year. Intake and discharge have been greatly accelerated in recent years. This is due to more temporary care and the employment of a case worker, who works with individual children and their families. A close contact is kept with the relatives of many of our children and as soon as they are able to resume responsibility for their care they are returned to them.

The program at the Home is planned to meet the great and pressing need of giving security to children and rehabilitating families whenever possible. Boys and girls who are admitted to our Institution are given good physical care and every opportunity of developing into Christian men and women.

Looking back over the past three years we can see the many blessings that God has granted in our program of child caring. We look to the future with great confidence for a continued and enlarged service to the dependent children of our state. We trust that every church in this Association will have a part is the Christmas offering, that we may build another cottage. The membering that the Master said, "Inasmuch as ye have done it unto one of the least of these my brethren, ye have done it unto me."

REPORT ON TEMPERANCE

Your attention is called to the fact that the per capita consumption of alcoholic beverages in Florida for the year 1948 (counting the population over 15 years of age) was 22.87 gallons, while that of our sister state of Alabama was 8.34 gallons, and that of Georgia was 9.33 gallons. The "playground philosophy" has tended to encourage excessive drinking in our state.

Clearing House

Our office at 1017 South Boulevard, Lakeland, Florida, is a clearing house for all sorts of information regarding the liquor situation. Prompt attention is given to the many letters of inquiry regarding modes of legal procedure which seek to curb or destroy the liquor traffic.

For ten months of the year we mail a communication to more than five thousand religious, educational and social leaders of the state, and among the leaflets and pamphlets furnished these leaders during the past year are the following: The Black Book of Repeal, A Summary of Well-Established Facts In Regard to Alcohol, by Haven Emerson; Massachusetts Heavy Loser, Economic and Moral Effects of Pari Mutuel Gambling, by Ben F. Wyland; We Are At War, by Ted Hightower, and Delusion, by P. E. Selby.

It is disappointing to note that but few orders are received for additional copies of these valuable leaflets and pamphlets. We would urge a larger use of such materials for the purpose of creating dry sentiment in the state.

Sale To Minors

An Act of 1947 (Section 562.1 Florida Statutes) makes it unlawful to sell, give or serve any alcoholic beverages (including beer) to persons under 21 years of age. The dry forces of the state should be constantly on the alert to discover violations of this law, and offenders should be brought before the courts for punishment.

Closing Hours

While state law requires the closing of all saloons on week-days at 12:00 midnight, with permission to reopen next morning at 7:00; and while state law also requires the closing of whiskey saloons (not beer saloons), from 12:00 midnight on Saturday, with permission to reopen on Monday morning at 7:00, it is well to remember that both the City Commissioners and the County Commissioners are authorized by law to modify and to change these provisions of the state law. In too many cases, the hours of sale both for week-days and for Sundays have been extended by City and County Commissions. We report with satisfaction, however, that three counties—all dry counties, Clay, Hardee and Polk, have enacted county ordinances closing beer saloons on Sunday.

Zoning

There is no state law fixing the distance that must separate saloons from churches and schools and residential areas, within the area of incorporated towns and cities. The municipal authorities, however, have full authority to create "dry zones" within their territory.

Outside of incorporated towns and cities, no whiskey saloon can be established within 2500 feet of an established church or school (This provision does not apply to beer saloons). Remember however that the County Commissioners under authority granted by the Legislature of 1947, may create "dry zones" in the rural areas. The latest zone to be thus created was in Pasco County, and extends from the southern boundary of the city limits of New Port Richey southward to the Pasco-Pinellas County line, along Federal Highway No. 19, and for a distance of one-half mile west and one and one-half miles

east of Highway No. 19, including the community of Elfers.

Local Option

It is interesting to note that 71 per cent of the area of Alabama is dry, and that 54 per cent of the population live in dry territory. The drys in that state have only lost three of the 23 local option elections held in that state since 1946. In North Carolina the drys have only lost three of the 12 elections held in that state since 1937. More than 40 counties in North Carolina have outlawed the sale of beer and wine since 1948, having already closed the whiskey saloons.

The drys of Florida have won nine of the 15 local option elections held since October, 1945. It is not to our credit, however, that at the present time not one constructive effort is being made by the drys for calling a local option in Florida. The wets are circulating a petition for calling such an election in Polk County—dry since 1887.

DeSoto County voted to remain wet on April 26 of 1949 by a majority of 324. The dry majority in the Hardee County local option election on November 15 of the same year was 595, this same county having voted dry two years before by a majority of 230. Wakulla County had voted earlier in 1949 to remain dry by the small majority of 11.

Plans are under way for testing the constitutionality of Question Number 2 on the present local option ballot. This new addition to the ballot gives the wets a strong talking point and an unfair advantage in local option elections, and we believe that it is clearly unconstitutional, being in conflict with Article XIX of the Florida State Constitution.

Films

We are now circulating four temperance films in the state, with the following number of showings during the past year:

Where Does It Get You. 52 Times
Skid Row 24 Times
Vicious Circle 14 Times

There is no rental charge on these films, the applicant simply paying the postage one way.

Legislation

Your Executive Secretary sought the passage by the last Legislature of two bills: (1) A measure making the state Sunday law apply to beer saloons; and (2) a law making the 2500 feet law (now applicable to whiskey saloons) applicable to beer saloons, in the rural areas. These proposed laws were

reported unfavorably by the sub-committee of the Committee on Business Regulations of the House.

Union of Forces

We are happy to report that the National Temperance Movement, with which United Florida Drys is affiliated, voted some months ago. in a convention assembled in Chicago, to merge its forces with those of the National Temperance League of America, and the uniting convention will be held in Oklahoma City, Oklahoma, beginning on the afternoon of November 19, and continuing until noon of November 22. This means that there will be no further confusion in Florida with respect to competing and overlapping temperance organizations. United Florida Drys continues to be the only official organization representing the Churches of the State in the fight against the organized liquor traffic.

Call for Action

Let us launch a forward movement of all our forces against the liquor traffic so deeply intrenched in Florida. May we suggest the following notes of advance:

- 1. Place adequate supplies of temperance leaflets and pamphlets in the hands of the people.
- 2. Make wider use of the four temperance films now being circulated throughout the state.
- 3. Proceed to organize a Good Citizenship League in every county, for purposes of Education, Legislation, Law Enforcement and Local Option.
- 4. Seek through constituted municipal and county authorities for the passage of ordinances limiting the hours of sale for alcoholic beverages, especially on Sundays.
- 5. Seek through County Commissioners the enactment of ordinances creating dry zones, for the protection of church, school and residential areas. Enlist City Commissioners in behalf of the same kind of legislation for the incorporated towns and cities.
- 6. Call together a small group of interested citizens and discuss the advisability of calling a local option election in the wet counties of the state.

REPORT ON FOREIGN MISSIONS

Foreign missionaries reported a total of 13,322 baptisms during the year 1949; a reasonable estimate for China, from which no report was received, would bring the total to approxi-

mately 15,000.

The Board appointed 67 new missionaries during 1949. Fifty have been appointed during the first four months of 1950. The total number of active foreign missionaries now under appointment is 753. Missionaries are stationed in 24 countries and assist national Baptists in several more.

Foreign Mission Board receipts for 1949 totaled \$5,319,261., not including \$120,345.15 received for world relief.

New Areas

A missionary couple transferred from Colombia in the spring of 1949 to open Venezuela's first mission station at Caracas. In the spring of 1950 a new church building is being constructed in Caracas and another Venezuela station is being opened in Barquisimeto.

Costa Rica became a foreign mission field by transfer from the Home Mission Board early in 1949.

Bangkok, Thailand; and Baguio, Philippine Islands, became temporary mission fields for Chinese language students. Early in 1950 a veteran China missionary couple arrived in Seoul, Korea, to spend a year in survey work for a new field.

A missionary couple has been appointed for work in Ecuador where Southern Baptists have had no work before, and two other couples now in language school in Colombia will probably choose Ecuador as a mission field. After language study, the missionaries expect to locate in Guayaquil or Quito, some of them this year.

New Institutions

Southern Baptists' first international theological seminary opened in September, 1949 at Ruschlikon/Zurich, Switzerland. Twenty-eight students from 15 nations are enrolled. Italy's new Baptist Bible school opened at Rivoli in October, 1949, and a woman's training school is under construction in Rome to open in the fall of 1950. Hawaii's first Baptist high school opened in September, 1949.

Construction is in progress in Asuncion, Paraguay, on Southern Baptists' first hospital in Latin America. A second missionary doctor has received license to practice in Colombia, making a second mission hospital possible in Latin America.

Two missionary doctors have been appointed for Arabia where Southern Baptist mission work has been delayed for lack of a doctor. One doctor is already on the field learning the language. A hospital is in prospect for the Hadhramaut or Yemen in southern Arabia.

The theological institutions in the Latin American area are being reorganized to give two strong institutions for Spanish America and two for Brazil, or Portuguese America. The seminary in Buenos Aires, Argentena, is already being reorganized and the second for Spanish-speaking republics may be established at Cali, Colombia. The Rio de Janeiro and Recife seminaries will continue to serve Brazil.

New Projects

For the first time Southern Baptists are using mission airplanes for transportation. The two in use are both in Brazil, one based at Corrente and the other at Fortaleza. Distances once requiring weeks of boat or mule-back travel are covered in a few hours by plane.

A co-operative farm is being established at Petach Tikva, near Tel Aviv, Israel, by a group of Baptists of Slavic origin aided by Southern Baptists.

REPORT ON HOME MISSIONS

The annual report of the Home Mission Board for 1949 magnifies the fruits of evangelism. In Simultaneous Evangelistic Crusades, led by the three workers in the Department of Evangelism of the Home Mission Board, 7,780 baptisms were reported with 11,875 additions to the churches participating in crusades personally directed by staff members. The year of evangelism reported by Southern Baptists showing 334,862 baptisms brings joy to all Southern Baptists. The Department of Evangelism has occasion for special rejoicing, both in fruits already reported and in evangelistic crusades being consummated in the greates effort for evangelism made by any religious body. Baptist chaplains reported 4,893 professions of faith. Not counting the above reports, home missionaries during 1949 reported 35,913 conversions.

New Churches and Missions

During the year the reports showed 165 new churches constituted and 577 new missions opened. Most of the missions will grow into churches. Thus from year to year the number of new churches constituted will grow as emphasis is given to the establishment of missions.

New Buildings

During 1949 fifty new buildings were either completed or were under construction. Fifty-four pieces of home mission property were improved. Appropriations for building projects during the year amounted to \$751,896.85.

Missionary Personnel

A total of 779 regular missionaries served the Home Mission Board during the year and 251 summer student workers gave ten weeks of mission service, making a grand total of 1,030 workers. Missionaries contacted 177,139 in personal work,

delivered 81,039 sermons and addresses, taught 22,987 classes, conducted 1,817 revivals, distributed 57,419 Bibles and Gospels and made 258,818 religious visits. They worked in 1,541 Vacation Bible schools. There are 44 kindergartens in operation.

Literature

The rural series of graded home mission studies prepared in 1949 has met with the best response of any mission study series. Peak printing of the magazine was 121,000. Subscriptions have dropped and an appeal is made for help in getting the magazine into more homes. Millions of pages of tracts and free literature have been distributed.

A Crusade For Home Missions

At its last annual meeting the Home Mission Board launched a five-year Crusade in response to the need revealed by a survey of the fields and the necessity for strengthening and sustaining the home base for a great world-wide mission program.

The needed strength will come from three sources: more members, more churches and more effective witnessing.

The first emphasis, therefore, in the new crusade is soul-winning. During 1950 and 1951, the Evangelistic Department is directing evangelistic crusades throughout the Convention territory and in the outposts of Alaska, Panama, and Cupa. This is a concerted effort to reach a large number of the 39,000,000 unchurched people in areas served by the Board. More Christians will mean more strength.

In 1951 and 1952, following this soul-winning effort, the crusade will be directed especially in establishing new churches and mission stations. There are 21,000,000 people in areas served by the Board who are not within easy reach of any Baptist church that can serve them. New converts won in the evangelistic crusade will need new places of worship.

Within this five-year period an effort will be made to lead in constituting 5,000 new churches and 10,000 new mission stations. A survey of cities, suburban areas, rural districts, mountain regions, underprivileged sections, and language groups, reveals a need far in excess of this goal. The strength of Baptists has always been in the number and strength of the churches.

Throughout the five-year period, but receiving special emphasis in 1953-54, the Board will lead in a crusade to make the witness of Baptists more effective, especially in needy areas. The work among the language groups, underprivileged, juvenile delinquents, migrants, and isolated people will receive special emphasis. Efforts to reach the 1,500,000 "unattached"

Baptists, to revitalize 1,000 inactive country churches, and to create a greater loyalty on the part of all our constituency are included in the crusade goals.

To accomplish these tasks, the Home Mission Board will need 1,027 missionaries (an increase of 248), an annual operating budget of \$2,000,000, and a total of \$3,500,000 to meet capital needs.

Make America safe and our constituency strong in missionary service by winning the lost, building strong churches and stimulating an effective Christian witness. Join in the Home Mission Crusade.

STATE MISSIONS REPORT

In Florida, State Missions has an important place in Baptist life. Jesus has set the example and given the command to advance. This is "Favored Florida's" marching order!

State work in Florida consists of preaching the gospel to the ends of the earth. We employ 38 full-time missionaries for Florida. They teach, preach, hold Bible institutes, direct vacation Bible schools, and direct assemblies.

Then too, State Missions has to do with helping educate more than 2,000 students, care for many homeless and destitute children. We take care of the spiritual development of hundreds of our Baptist boys and girls who are away from home attending college, through churches in college centers.

Through State Missions, Florida Baptists provide for the education and training of more than one hundred ministerial students, and assist some two hundred others who are preparing for full-time Christian service and for the mission fields.

Florida Baptists have been entirely too slow in starting new missions and organizing new churches. Last year we aided fourteen such places. We need to open fifty new mission stations now! This year we have spent \$10,500.00 in such endeavor.

The advance program of the Kingdom of God in Florida waits on a proper understanding and rightful undergirding of our State Mission Program.

Each year Florida Baptists observe a "special" day known as State Missions Day. Our plea is for you and your church to observe State Missions Day, October 22, 1950. Give your people an opportunity to make a worthy State Missions offering which is desperately needed. Can we depend on you? Get your special offering envelopes from Dr. Jno. Maguire.

REPORT OF ALACHUA ASSOCIATIONAL W., M. U.

We began the year with fourteen societies. Late in November, after careful study and preparation, a group of Floral City women met and organized a Woman's Missionary Society. It is the president's privilege to install their officers.

Four quarterly meetings were held—the annual meeting at Brooksville as an officers' clinic; the January meeting at Inverness with Miss Irene Chambers, Home Mission field worker, as guest speaker; the April meeting at Webster, a delightful home talent program, and the July Youth Rally with our auxiliaries in charge and featuring Miss Helen McCullough, educational missionary to China.

Our executive committee meetings held quarterly at Dade park proved most helpful and enjoyable.

Progress was made in the overall program throughout the year—a gain of one society, an increase of 62 in membership, only eight new tithers were reported, 26 mission study classes were held which was eight more than last year. Special season of prayer gifts amounted to \$912.22, allotted as follows: Home Missions \$276.92; State Missions \$254.35; and Foreign Missions \$380.95.

BROTHERHOOD REPORT

The Baptist Brotherhood of our Baptist denomination has made rapid strides in the past year. Throughout the entire south there has been more of an awakening to the advantages of Brotherhood work than possibly ever before. The Southern Baptist Convention changed the official title and posicion of the Brotherhood work from a Committee to a definite Commission which puts it officially within the family of organizations of Southern Baptist work.

In Florida there has been a sizeable increase, both in number of Brotherhood organizations and total membership. In our state office we have seen a change of associates. Mr. George Linney left to go to Georgia to become Assistant Administrator of Georgia Baptist Hospital. His place has been taken by Mr. Julian L. Stenstrom, a Stetson University graduate, and a native Floridian who is well versed in Baptist work. He has been given the title of Associate-in-charge of Brotherhood Work. This means that Mr. Stenstrom for all practical purposes is the State Brotherhood Secretary. Mr. C. A. Holcomb, who is head of the Music-Brotherhood Department of the state, remains in that position but this division of work merely means a distribution of responsibility so as to better do the work. All of this means that we now have one man giving full time to Brotherhood work and another man giving some of his time. This in itself is a step forward.

REPORT OF THE RELIEF AND ANNUITY BOARD

Rev. O. G. Hall

The reports, reviewing the work of the Relief and Annuity Board, presented at the annual meeting of the Board in Dallas, on March 8th, showed 1949 to be a year of continued progress and enlarged service to our Southern Baptist constituency.

Officers of the Board were re-elected: Dr. Wallace Bassett, president; Dr. Walter R. Alexander, executive secretary; Dr. Robert S. Jones, associate secretary; and Mr. Orville Groner, treasurer-investments.

Total income for 1949 was \$4,269,496.13, with total benefits paid, amounting to \$1,375,209.25. Total assets of the Board as of December 31, 1949, were \$17,613,434.86.

The relief department again spent more than it received in 1949. Southern Baptists gave \$225,376.33 for relief of aged ministers and widows of ministers, while the department spent \$242,066.37 in an effort to prevent suffering and want, among our old preachers. We would urge every church in the association to follow the Calendar of Denominational Activities of the Southern Baptist Convention and take a fellowship offering for ministerial relief, preferably at the observance of the Lord's Supper or at such time as convenient for the church.

There is much need for greater promotion in all states. As yet there are too many pastors who do not have the protection offered by the Ministers Retirement Plan and the Widows Supplemental Annuity Plan. Many of our pastors are retiring without any retirement benefit and are throwing a burden upon the relief department beyond its resources. Your state office desires the assistance of pastors, and others who have this protection, to assist in the work of enlistment, bringing others into the plans provided for them.

The broadened Social Security bill, passed by the United States Senate on June 20, 1950, excluded all employees of churches, and church related groups, from the Social Security program. The bill, as first drawn by the committee, included such employees, but at the insistence of Southern Baptist leaders, the committee changed the bill to exclude them. The Southern Baptist Convention, meeting in Chicago, passed a strong resolution, requesting that religious groups be excluded. Now that the Senate has granted the request of Southern Baptists, it becomes imperative that all lay employees, such as educational directors, church secretaries, janitors, etc., be enrolled in one of the plans of the Board, that they not be made to suffer because of the historic position of Baptists on complete separation of church and state.

REPORT ON AMERICAN BIBLE SOCIETY

The Psalmist says— Psalms 119:105. "Thy word is a lamp unto my feet, and a light unto my path." The Bible is Gods word. The nations must have its light to guide them out of the dark abyss of turmoil and strife into which they have fallen, or the end of civilization may be upon us.

The American Bible Society has taken its place along with other great Christian movements to help spread the word of God. It aids in translation of the scriptures into the language of the people so that it may be read without the help of an interpreter, it publishes them without note or comment, and distributes them at no profit, often below cost, at home and abroad, in the great cities, and in remote areas, to the Armed Forces, in Hospitals, anywhere and everywhere that men will accept Gods word.

Russia is the number one problem today, her little people are being oppressed, their freedom being denied them, they can no longer worship God according to the dictates of their conscience, at least not publicly, they need and, we have reason to believe, they want the Bible. How to get it to them is the great problem. The Iron Curtain being clamped down so tightly it is hardly possible to get it to them, although some agencies claim that they have access to her people with the scripture. Let us take warning from an editorial in the Baptist Witness of October 12, and investigate before we contribute to any person or organization for the distribution of Bibles to Russia, as the American Bible Society is one of the oldest and most reliable Bible distribution agencies in America and has now already printed, as of June 1st, 1950:

ready for distribution to Russia as soon as a way can be found.

Japan having lost faith in her Emperor as her God, has turned to the Bible. General McArthur estimates that it will take Thirty Million Copies to meet her needs, he urgently calls upon America to supply this need. The American Bible Society has shouldered all of the responsibility that she feels she can carry, having distributed 3,000,000 Japanese Scriptures in 1950, and pledging distribution of 5,000,000 in 1951. They need and must have our help in this worthy undertaking if

the goal is to be reached.

In 1949-50 the American Bible Society distributed through its own work at home and abroad, nearly 9,000,000 volumes of the Scriptures, another 2,000,000 were produced through gifts of materials and money to Bible Societies of other countries, bringing the total to nearly 11,000,000 for the year.

Southern Baptist gave \$78,384 of this amount. The need and the challenge this year is greater than ever, may we prayerfully lay the needs of the Society upon the hearts of our people and strive toward a worthy goal for 1950-51.

MUSIC REPORT

The work of music in the Southern Baptist Convention and the state of Florida has progressed marvelously in the past twelve months. We have seen the publication of several more of the Music Training Course books which were greatly needed to carry on the work of training our church musicians. In addition to this there has come from the presses of the Baptist Sunday School Board in Nashville, the first issue of our own Baptist music magazine. It is known as 'The Church Musician.' The first issue was October 1. This magazine is to be published monthly and may be ordered along with all other Sunday School and Training Union literature. On the order blanks now being sent out from the Sunday School Board a place is provided for the ordering.

This magazine every month should be in the hands of every pastor, every church music director, church organists or pianist and every choir member as a minimum for each church. The magazine will have 32-pages plus cover each month, 16 pages being filled with articles concerning Southern Baptist music work and 16 pages taken in the publication of music of all types from special arrangements to anthems and hymns that can be used by the choirs of Southern Baptist churches. We heartily recommend this magazine to our people. The use of this magazine will keep many of our people from desiring the use of inferior publications that are coming from commercial presses day by day.

In Florida the Music-Brotherhood Department of our state convention has been fostering a music education program in many churches, has taken workers into several churches during the year, has led in providing leadership conferences and associational schools of music, sponsored music camp for young people and provided music in assemblies. Six regional Music Festivals were held in the spring culminated by the State Music Festival held at Stetson University. This idea is to be carried out on a larger scale in 1951. We urge our churches to participate in these activities.

OUR CONSTITUTION

1. This body shall be known as the Alachua Baptist Association.

2. It shall be composed of churches generally recognized as

Missionary Baptist Churches.

3. Its session (Legislative, Administrative, Promotional and Fellowship), shall be regularly elected representatives of the churches who may be present and who may be accepted by the elected members on the basis of two messengers from each church, and one additional for each twenty-five members or major fraction thereof, in excess of fifty.

The Officers of the Association shall be the Moderator,
 Vice-Moderator, Clerk-Treasurer. Also the Presidents of the

Sunday School, W. M. S., B. T. U. and Brotherhood.

5. The Executive Committee of the Association shall be the above named officers, together with all resident pastors in the Association.

- 6. The Moderator shall preside over the sessions, keep order, take a vote on all questions properly presented and perform such other duties as are usual to such officer. The Clerk shall keep a record of the proceedings of the body in session, have the same printed and distributed to the churches according to the funds provided and as the body may direct. The Treasurer shall keep an accurate record of all monies received; pay out upon the instruction of the body and make an itemized report of same to the Association at annual session.
- 7. The Executive Committee shall have general supervision of the work fostered by the Association. It shall meet quarterly and plan for the promotion of various interests of the organized work, using its best efforts to stimulate the spirituality and activity of the churches, and shall make report of its work to the Association at its annual session.
- 8. The Association shall meet annually at such time and place as may be agreed upon by the body, or when necessity arises, by the Executive Committee.
- 9. Churches may be admitted to membership in this Association by representatives bearing a petitionary letter with statistical data; provided they are found to be orthodox by a committee appointed by the Moderator. Upon a favorable vote of the body, the Moderator shall extend the hand of fellowship on behalf of the Association.
- 10. The Association shall have the right and the power to withdraw fellowship from any church in its membership, upon grounds which it may deem justifiable.
- 11. Any church shall have the right to withdraw from the Association upon due notice to the body.
- 12. Any church failing to report to the Association, neither sending representatives or letter, twice in succession, shall be

dropped from the roll of active members and put on a list of "inactive churches."

13. This Constitution may be altered or amended by a twothirds vote of the body in session.

REPORT ON COOPERATIVE PROGRAM (Stewardship and Tithing)

Last year Southern Baptists recorded an increase in stewardship and giving. Their total gifts through the churches were 14.6% higher than the preceding year. Gifts to missionary and benevolent causes were increased 2.3%, or about one-sixth as mush as the increase in total gifts. We rejoice in the growth in support of local church programs, and the erection of new and needed buildings. We would call attention, however, to a trend to increase these things at the expense of growth in missionary and benevolent works. Faithful Christian stewardship would indicate the need to watch carefully this trend, and to do something to correct it.

The Cooperative Program is our Baptist plan for support of all the work of the Kingdom as undertaken by Baptists. Through it "every member gives to everything". The humblest member in the smallest church in the remotest section of the country has an important part in the greatest work in the world—when he gives through the Cooperative Program.

Southern Baptists have adopted a plan for stewardship education and enlistment which has already worked wonders in churches which have tried it. It is called Tithers Enlistment Visitation. It is a program in which tithers visit others to tell them about Christian stewardship, give their own testimony, and say, "Will you not join me in tithing?"

We recommend that: every pastor lead his church to observe Tithers Enlistment Visitation and that all our churches cooperate in its use; that our people be urged to give more support to all our missionary and benevolent work through the Cooperative Program; and that we seek to raise the level of giving and deepen the spiritual life of all our people through emphasis upon Christian stewardship and tithing.
