S. Enrollment, 1.542: 1960 enrollment, 1.542.

#### REPORT ON TRAINING UNION

#### WOMAN'S MISSIONARY UNION REPORT

The Woman's Missionary Union of Apalachee Association has 9 Missionary Societies of Women, 1 Y. W. A., 8 Girls' Auxiliaries, and 7 Sunbeam Bands with a total enrollment of 372. All of these organizations were active this past year and reported to the Association.

There were 4 quarterly meetings held this past year. They were January 30 at Bristol, April 11 at Corinth, July 20 at Lake Mystic, and October 10 at Providence. The average attendance for these 4 meetings was 61.

A total of 29 Approved Mission Study Books were taught this past year with 183 reading at least one book. All organizations participated in planned Community Mission Activities each month during the year. The societies promote giving through the Cooperative Program and other mission offerings. 149 reported that they were tithers.

Three seasons of prayer for Foreign, Home, and State Missions were observed this year. The Lottie Moon Offering for Foreign Missions reported was \$3,694.94. The Annie Armstrong Offering for Home Missions reported was \$2,959.17. The State Mission Offering is incomplete at this time since it is due this month.

In addition to these special emphases, we support the Children's Home and Baptist Bible Institute. This past November we observed a special B.B.I. Day with all of our societies contributing money, clothing, and food to the school. 21 from our association attended Chapel services and enjoyed the noon meal with the school on this special day.

The quarterly meetings for the coming year are as follows: February 2, Bristol; April 10, Poplar Head; July, Corinth; October 9, Lake Mystic.

Other special events coming up this year are: G. A. Houseparty, Pensacola, November 3-5; Leadership Training for Adults and Youth Workers, Blountstown, November 9; B.B.I. Day, November 14; Week of Prayer for Foreign Missions, November 27-December 1; Girls' Auxiliary Workshop, Ocala, February 16-17.

Our Association was represented at the convention in St. Louis this past year. We were also represented at the State Leadership Conference at DeLand. A number of our women also attended the Day of Instruction in Tallahassee.

The new year ahead presents to us another challenge to promote missions among the women and children of our churches. and we sincerely enlist your prayers and support in this endeavor.

#### **BROTHERHOOD REPORT**

On April 1, 1961, Robert W. Galbraith become Associate Brotherhood Secretary. He replaces Thomas M. Knotts, who recently resigned to become pastor of the Hobson Memorial Baptist Church in St. Petersburg, Fla. The objective of the Brother-hood is a job for every man in the church, and this has been the goal toward which we worked during the year 1960-61.

A total of at least 1200 men attended the two Brotherhood Encampments this year, with about 600 in each. The encampments major on inspiration, information and fellowship.

The Royal Ambassador camps were superb this year. Having real missionaries were the high lights of the camps. Missionary education is at the core of all Royal Ambassador work. Every boy who had not made a profession of faith prior to his coming to camp made such a profession. 78 boys made some sort of commitment, to go as a missionary, to become a minister, or go into the field of religious education. Of this number, 22 professions of faith were made.

This October marks the beginning of the new and enlarged Royal Ambassador program of work. There are three primary divisions for various age levels:

- 1. Crusader Quest for boys 9, 10, 11.
- Pioneer Trail for boys 12, 13, 14. Ambassadors for boys 15, 16, 17.

In each of the age groups will be included a program of these 4 things:

- Fun with skills and crafts.
- Being a good steward.
- Being a good citizen.
- 4. Helping with World Missions.

In all of these four areas, a boy's relationship to his local church is emphasized.

To help in all these areas of Brotherhood work, the Department sponsored the Brotherhood University in which were taught: The Associational Brotherhood Manual, The Guidebook for Church Brotherhoods, Effective Christian Witnessing, The Crusader, Pioneer, and Ambassador Programs of Royal Ambassador work. Leaders from every section of the state attended.

The Brotherhood Department cooperated with the other departments of State work in training and planning meeting in each Association for the respective Associational officer.

Fifteen regional meetings will be held to acquaint the Brothershood leadership with the new Royal Ambassador program.

# UNITED CHRISTIAN ACTION REPORT

The Beer and Liquor Traffic in Florida says, "We'll Get Your Children!" As many churches remain largely complacent and seemingly unconcerned, more and more Baptist homes agonizingly awake to discover it could—and has—happened to them. How many Baptists and other young people in your community are drinking beer, wine, or liquor? Smoking? Practicing lower and lower moral standards? Why? Could it be that too many churches are turning "soft" and most adults merely offer pious platitudes or dodge the real issues in the face of this alcoholic epidemic of spiritual and physical destruction?

Encouragingly, there are signs on the horizon that some pastors and parents are sick and tired of being subjected to the pressures and spiritual degradation of the liquor, gambling, and indecent literature traffic and are launching a bold counter offensive in their local communities. Working with the conviction that "When You Save A Child, You Save Both A Soul and A Life," a rebirth of the moral crusades of old appear underway.

The concern and cooperation shared by Baptists in Florida have made possible the program and activities of United Christian Action, Inc. Organized by representatives of ten denominations to present Christian solutions to Alcohol, Gambling, Indecent Literature, and related moral problems, UCA serves concerned Florida churches in the areas of Education, Legislation, and Rehabilitation. Your Prayer and Financial support makes it pos-

sible for UCA to serve YOU and YOUR Church in the following ways:

- 1. ALERT, our 8-page monthly paper features up-tc-the-minute news of and Christian solutions to current moral problems in Florida, a special 2-page bulletin board poster, Alcohol education techniques for churches and schools, documented facts and figures to reinforce our historic position of TOTAL ABSTINENCE.
- 2. LEAFLETS, PAMPHLETS, CARDS, POSTERS—more than 1,000,000 attractive, accurate information sheets and periodicals prepared and printed in our office, and widely distributed free to young people and adults.
- 3. LOCAL CHURCHES AND CONCERNED CITIZENS in counties and towns throughout Florida are assisted by our staff in preparing for and facing liquor and gambling elections, zoning and hours-of-sale ordinances and other front-line battles for moral and spiritual survival. In the past year, VICTORIES were won by defeating efforts of the gambling traffic to open a Jai Alai Gambling Fronton in Brevard, and defeating the liquor traffic attempts to legalize liquor in Dry LaFayette and Bradford counties. Outstanding progress was made at the 1961 session of the Florida Legislature in a vigorous drive to ban alcohol advertising and to remove beer-liquor sales from grocery and drug stores. Strong plans are already underway to secure final passage of these measures in 1963.

4. SPEAKERS for worship services in churches, study services in youth camps, schools, and community organizations are provided for week day and Sunday services throughout the year.

UCA provides the opportunity for Christians of evangelical denominations to protect our homes and guard our churches from the following destructive forces now operating in Florida: (figures for 1960)

- 1. The Liquor Traffic, with 17,000 legalized joints, sold over 74 million gallons of beer-wine-or-whiskey. Cost in dollars—over \$450,000,000; cost in human souls—at least 200,000 alcoholics, plus 400,000 problem drinkers, plus 900,000 "social" drinkers.
- 2. The Gambling Traffic, now operating 17 gambling dog tracks (more than all other 49 states combined), 5 gambling horse tracks (recent legislature authorized 2 more), 5 Jai Alai Gambling Frontons. 6,300,000 people paid admission last year to gamble away \$350,000,000.

3. The Obscene Literature Traffic, thoroughly putrifying the minds and bodies of multitudes of youth.

The above, and their allied corruption, are now producing staggering crime, delinquency, welfare, traffic and family problems which are resulting in declining public and private morals, spiritual decay and death.

UCA is deeply grateful to those Baptists who did care enough to share of their leadership, undegirding prayers, and financial support. Our program would not have been possible without this help. In 1960, from all those churches who participated in the Annual State Mission Offering, UCA received \$8,250; from individual Baptist churches, through budget or special gift support—\$15,343.88; from Women's Missionary Societies—\$371.10; from associations—\$570.45.

Directed by a Board of Directors and Advisory Councils of 250 of Florida's finest pastors and lay leaders representing 10 denominations, with Dr. Harold G. Sanders as current President, UCA serves you with a full time staff composed of Rev. Phil Padgett as Associate Director and Jack Eppes as Executive Secretary. Dr. Durward Long is Director of Education on a part time basis. State headquarters are located at 1705 Gary Road, Lakeland, Florida. We shall be more than happy to provide a more detailed annual report to any who desire.

# THE COOPERATIVE PROGRAM AND WORLD MISSIONS REPORT

#### "World Missions Waits on Stewardship"

Jesus commissioned His disciples to, "Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Spirit. . .," as told to us by Matthew 28:19.

In fulfilling this commission of our Lord we are bound to the task at Home, in our State, as well as to the ends of the World.

As we look at our accomplishments in the past year and our goals for the coming year we see that in our—

#### State

Which is a very definite pat of the overall World Missions program, an effective program promoted through the various departments of our State Baptist Convention. Such as Sunday school, Training Union, etc. Also, our State Missions includes work with the Children's Home, Retirement Centers, schools and colleges—Stetson University and Baptist Bible Institute, Camps and Assemblies, Florida Baptist Witness, and State Board of Missions, which directs the Missions work of the State Convention. There were 46 new missions started and 26 new churches organized through these concerted efforts.

Our State Missions Program is to be financed cooperatively, therefore, every Baptist Church in our State must be challenged to give to the Cooperative Program that this important work might continue unhampered.

#### Home Missions

Our Home Missions Program promotes new Churches throughout the area of our Southern Baptist Convention, wherever there is need. This program of work is promoted through the movement of the Home Mission Board known as the 30,000 movement and such efforts as the Pioneer Missions work in the Northern and Western sections of the United States.

As of January 1, 1961, 11,817 missions and churches have been started. In 1962 an effort will be put forth to start 6,000 more. Our work of the Home Missions will be extended to include work in Hawaii and Puerto Rica. Work in Cuba is still advancing despite the tense situation there.

Detroit was allotted \$100,000.00 for loans with which to purchase sites and buildings in the "Big Cities" program. Detroit has been added to Chicago, New York, San Francisco, and Seattle as areas needing special efforts in financing new churches and missions.

The Program of Soul Winning, promoted through our local churches with emphasis under the direction of the Division of Evangelism, C. E. Autrey, director. There were reported by the churches of the Convention 386,469 Baptisms for the year.

There are serving in various phases of Home Mission Work a total of 664 Southern Baptist Ministers as Chaplains for military, institutions and industry in the United States. An additional 768 serve as chaplains in various other types of work. The Chaplains Division reported 14,053 professions of faith.

There are 2,035 missionaries serving, the largest number to serve in the History of the Home Mission Board. There were reported by these workers 51,463 baptisms. There is an urgent need for more than 270 workers now to fill requests, some vacant for two years because qualified personnel have not been found.

#### Foreign Missions

The number of foreign missionaries in active service now stands at 1,500,137 of these being appointed during 1960 and 31 from January to May, 1961. The Board expects to have 2,000 missionaries under appointment by the close of Baptist Jubliee Advance in 1964. At the end of 1960, there were 786 urgent requests for new missionaries.

Southern Baptists now have missionaries in 45 countries and separate entities: Argentina, Bahamas, Brazil, Chile, Colombia, Costa Rica, Ecuador, France, Gaza, Gahana, Guam, Guat mala, Honduras, Hong Kong, Indonesia, Israel, Italy, Japan, Jordan, Kenya, Korea, Lebanon, Liberia, Macao, Malaya, Mexico, Nigeria, Northern Rhodesia, Nyasaland, Okinawa, Pakistan, Paraguay, Peru, Philippines, Portugal, Singapore, Southern Rhodesia, Spain, Switzerland (international seminary), Taiwan, Tanganyika, Thailand, Uruguay, Venezuela, and Vietnam.

Southern Baptist foreign missions reached out to three additional countries in 1960.

In the field of World Evangelization National Pastors number 2,447. The 3,399 churches and 6,522 chapels and mission points reported a Sunday School enrollment of 389,138. There were 31,107 baptisms during 1960, and church membership reached 452,975. (These figures include estimates for China.)

In the educational phase of the foreign work, there are 1,023 schools, which enroll 159,352 students, and are served by 5,347 national and 299 missionary teachers. Among the schools are 37 theological institutions with 1,378 students and 4 women's training schools with 275 students. Other schools range from kindergarten to college.

Medical mission institutions include 18 hospitals and 72 clinics and dispensaries with a total of 1,233 beds. There are 55 missionary and 78 national physicians, plus 60 missionary and 249 national nurses. These facilities served 286,907 patients during the year.

Our Foreign Mission Board has seventeen publishing centers which turned out 19,720,423 pieces of literature during 1960. These included periodicals, tracts, and books. Sixty-two missionaries and 419 nationals serve on publication staffs.

# Cooperative Program

World Missions cannot go on unless God's stewards are faithful.

Through the Cooperative Program churches may give and feel an Important part in all phases of World Missions. But as we look back over the gifts of Southern Baptists we can only ask the question, "Have we realized the important part that is ours?" For Southern Baptists with a membership of 9,731,591, only gave in 1960 \$480,608,972 to all causes. Based on an estimate of the total income of all Baptists in 1960 of \$12,000,000,000, just our tithe would have been over \$1,200,000,000. This means that Southern Baptists only gave approximately 3% of their income, which is FAR from a tithe.

Considering the great need and what Baptists are doing presently much truth is seen in the phrase, "World Missions Waits

on Stewardship."

#### Recommendations

We recommend:

1. That every church in The Apalachee Association include the Cooperative program in its plan of giving.

2. That churches consider a definite plan of increase each

year.

3. That the Apalachee Association endeavor to lead all churches to promote a Tithers Covenant campaign aimed at reaching every church member in order that our total program may go forward unhampered.

#### FLORIDA BAPTIST FOUNDATION REPORT

In Scripture much stress is laid upon faithfulness—faithfulness in work, worship, witness—faithfulness in personal devotion and, particularly, faithfulness in the stewardship of the manifold goodness of God.

It is scarcely a debatable matter when one affirms that the only true freedom man ever enjoys touches vitally the freedom of mind to think, the freedom of heart to espouse and the freedom of love to nurture and support. All of these are inherent in the purposes of Christ and His gospel and are a part of the Christian witness.

The business of any agency such as the Florida Baptist Foundation is to constantly emphasize these truths and seek to strengthen and support the forces leading to an ever wider acceptance thereof

The Foundation is, therefore, primarily an agency seeking to strengthen all the causes of our faith all around the world, by encouraging our people to commit their substance to these causes by the Scriptural tithe during lifetime and by Will or Bequest or Trust to serve when the earthly stewardship has passed.

Since the above is true it is only a matter of elementary prudence for a faithful steward to "plan" his estate well. Some people, after they have worked hard and conserved diligently to accumulate property, give, far too little thought to plans for protecting and disposing of their property after death. Such

failure is often due to one or a combination of circumstances; namely, misunderstanding, lack of knowledge or pressure from a multitude of daily details or merely a disposition to "put it off." That may easily become fatal to the best use of the fruits of a life's activities.

In the planning of an estate the importance of an experienced attorney cannot be over estimated. By its very nature the creation of an Estate Plan involves many important legal questions requiring the knowledge of competent counsel. The effectiveness of a Trust Agreement may depend largely upon the provisions that are made. And in the field of taxation the knowledge of experienced Counsel is of utmost importance that these accumulations of a lifetime of labor may accomplish their greatest good.

During the year 11 wills have been advised upon and while their value to the Convention Agencies may not be listed, they have been considerable. Information concerning 4 other wills have come to us from several law offices in the State. One Gift Annuity has been applied for and details are being arranged for a second such contract. The gift portions of these Annuities go to State Convention Agencies.

The Foundation continues to handle endowment for Baptist Bible Institute, Florida Normal and Industrial Memorial College and Stetson University and commends these interests to the

generosity of our people.

#### ANNUITY BOARD REPORT

The Relief and Annuity Board no longer exists—name-wise that is. The official name is now Annuity Board of the Southern Baptist Convention.

Total new members in all the Annuity Board's plans in 1960 increased by nine per cent over 1959, with the largest increase, 2,053, being in the Southern Baptist Protection Plan. Total membership stood at 22,578 on January 1, 1961. More than 4,000 of the churches participating in the protection program are paying the full 10 per cent dues. This is an increase of 17 per cent over the previous year.

On April 1, 1961, six states had enrolled more than 70 per cent of their churches and pastors in the protection program. District of Columbia had the highest percentage, 94. Seven states were in the 60's, percentage-wise, and 11 showed a participation of between 50 and 60 per cent. The remaining three were above the 45 per cent mark. Average participation of all states was 63 per cent.

Benefits amounting to \$2.745,613.60 were paid to more than 5,200 retired and disabled ministers and denominational workers or widows during 1960. A little more than 4,200 of these were beneficiaries of one of the Board's retirement plans, and the rest were on the relief rolls. Four hundred forty-six were new annuitants, added in 1960. Since the Board's beginning in 1918, it has paid out benefits totaling \$34,425,100.55.

Fifteen field representatives now serve 22 states in the Convention. The continued increase in new members in the Board's

protection program in recent years can definitely be attributed to the work of education and promotion being carried out by

these men within the local churches and associations.

Rev. Phil Maxwell, field representative for Florida, has his offices at 1105 Sarasota Drive, Tallahassee. #### REPORT ON CHRISTIAN EDUCATION

The text for balance in Christian education is still found in the description of Jesus' growth as expressed in Luke 2:52, "And Jesus increased in wisdom and stature, and in favor with God and man."

The major difference between Christian education and other education is that Christian education goes beyond the development of the mental, physical, and social to develop the spiritual potential of the student's character. This is, of course, the only real justification for Christian educational institutions. Baptists have always been believers in education which earnestly takes God into account and strives to present its truth and training in an atmosphere and context of Christian faith.

Southern Baptists now operate a total of 71 schools, colleges, and seminaries. During the 1960-61 school year, enrollment of regular students reached a record high of 65,338 compared to 61,194 the previous year. In addition, there were 6,462 special and extension students, making a total of 71,800.

Between September, 1959, and August, 1960, a total of 10,336 students were graduated from these 71 schools, an increase of

330 over the preceding year.

State conventions and the Southern Baptist Convention increased gifts to the schools to \$14,880,879, of which \$9,619,618 was for operations and \$5,261,261 for capital projects. Beyond these gifts of the conventions, the schools received \$9,022,464 in gifts, grants, and donations.

Florida has two of these Baptist schools-Stetson University, at DeLand, and Baptist Bible Institute, at Graceville. Florida

Baptists contribute generously to both institutions.

Stetson, the oldest university in Florida, last year reported a regular fall enrollment of 1,672, a small increase over the previous year. Total enrollment of regular students and others for the 1960-61 year was reported as 2,529. It should be a matter of concern that fewer than one-third of these students were Florida Baptists and that only 47 ministerial students were enrolled last year. There were also eight mission volunteers and 19 church music volunteers among the number.

Stetson desperately needs not only the financial support of Florida Baptists but more of their sons and daughters as students. We also need to give regular prayer support to President J. Ollie Edmunds and the faculty.

Baptist Bible Institute, under the leadership of President James E. Southerland, continues to make splendid progress. A devoted and scholarly faculty carries on effective training of those called to the ministry and other church-related vocations, but who did not find it possible to attend college or seminary. Many of the students are not high school graduates. Last year saw a total enrollment of 187 different individuals studying for the ministry, religious education, and music.

The Florida Baptist Convention is each year increasing its budget gifts to Baptist Bible Institute, but until the transition can be completed and all operating expenses be paid from Cooperative Program funds, the churches will need to continue giving

to help meet these costs.

Let us urge our Baptist young people to give prayerful consideration to attending a Baptist school. Christian education is superior education.

Some areas in which your secretary begs your prayers, understanding, and indulgence:

1. Geographically he has seven counties to cover.

2. He is responsible to work in five associations.

3. Although a district office has been established, and two other contact places will be used (the Panama City Office will have a phone) the secretary in order to do the work must spend most of his time out on the field. He cannot sit in the office and get the work done, though he must spend some time in the office. There being no secretary to answer when he is out on the field, seek to understand and keep on trying until you reach him. He intends to give his full time to the work.

4. That he could profitably spend all of his time in any one of the five associations but having five, the time must be di-

vided.

Some areas in which your secretary is justly proud of the churches in District No. 2.

1. Northwest Coast, Rocky Creek, Apalachee, and West Florida Associations were 100% in churches contributing to WORLD Missions through the Cooperative Program.

2. West Florida Association gave the largest percent of the collection plate dollar through the Cooperative Program of any Association in Florida.

3. Apalachee Association gave the second largest percent of their collection plate dollar to missions of the associations in the

Florida Baptist Convention.

4. Northwest Coast Association received the highest number of church study course awards of any association of less than 30 churches in the Florida Baptist Convention.

The following are some areas in which your secretary hopes he can be of help to the area, in keeping with the duties of a field secretary as laid down by the Florida Baptist Convention.

1. Give help to the associational leaders in any way that

help is needed.

2. Challenge the churches to continue to have an ever increasing part in WORLD MISSIONS THROUGH THE COOPERATIVE PROGRAM.

3. Visit the churches as often as possible but especially at their invitation when I can render some specific service that is

needed.

Having come to serve in this position at the invitation of the Florida Baptist Convention and the District Missions Committee, because the Lord seemed to indicate that this was His leading I propose to live within the territory of this district, to give my full time to my work, to try to prayerfully distribute my time and effort within the five associations of the district. Your prayers are sought as we work together as Christian brethren.

# **EVANGELISM REPORT**

President Kennedy in his State of the Union message said, "I speak today in an hour of national peril and national emergency. Before my term shall end, we shall have to test anew whether a nation, governed and organized such as ours, can endure. The outcome is by no means certain."

There are tremendous days in which we live. Billions are being spent for getting men to the moon, while little is spent for getting men to God. Multitudes sit in darkness and despair. They have absolutely no hope because they have not Christ. This number grows daily. The world's population is increasing by 48,000 per year.

Here in favored Florida there is a tremendous population growth with an alarming number who are not Christians. Many of these lost people live in our association. They live near our churches. Business as usual will not suffice for this desperate day. This is the time for total dedication for the task of winning

the multitudes to Christ.

During this past year, our association won and baptized 76. 83 united with the churches by transfer of letters. We lost 103 by transfers, death, etc.

To go forward we must start from where we are. Our association is the best launching place for new frontiers in evangelism and in missions.

Therefore, we recommend:

- 1. That we encourage ourselves in the Lord our God for the resurging interest in evangelism across our Convention.
- 2. That our Association participate in the "Baptist Jubilee Revivals" in 1962 through 1965. Our dates are as follows:

1962—March 11-25 and April 8-22. 1963—March 10-24 and April 14-28.

1964—March 8-22 and March 29-April 12.

1965-March 7-21 and April 4-18.

- 3. That each church participate in the "Baptist Jubilee Revivals" in 1962 (through 1965) and that they have at least one other revival during 1962, with special emphasis in all revivals placed upon personal, face-to-face heart-to-heart soul-winning.
- 4. That all churches make full use of the Revival Plan Book for 1962, 1964, supplied free to all pastors by the Division of Evangelism, Home Mission Board and is available from the State Secretary of Evangelism, 1230 Hendricks Avenue, Jacksonville.
- That our association have an Evangelism Clinic in keeping with the suggested program supplied by our State Secretary of Evangelism.
- 6. That our association recognize the elected associational officers as the evangelism committee, the Chairman of Evangelism to be the Chairman of this committee, and that we pledge our wholehearted cooperation to this committee.
- 7. That our association send the Chairman of Evangelism to Ridgecrest for the annual conference during Home Mission Week.
- 8. That we commit ourselves to the following outline of achievement for 1962:
- I. CHAIRMAN OF EVANGELISM—An evangelistic pastor elected to serve during associational year. Promotes perennial soul-winning in all churches. Serves as Chairman of Baptist Jubilee Revival Committee.
- II. ASSOCIATIONAL EVANGELISM CLINIC—Annual clinic devoting two sessions exclusively to evangelism. Seventy-five per-

cent of churches represented by pastors. Seventy-five percent of churches with at least three members of their church councils present.

III. ANNUAL BAPTIST JUBILEE REVIVAL—Eighty percent of churches participating. Eighty percent of churches observing same dates. Eighty percent of churches with two consecutive weeks of evangelism preaching.

IV. ALL CHURCHES CONDUCTING REVIVALS—Each church conducting a minimum of one revival annually. Fifty percent of churches conducting two revivals annually. Churches sponsoring missions revivals where needed.

V. EACH CHURCH WINNING AND BAPTIZING NEW MEMBERS—Churches endeavoring to increase previous year's baptismal record. Seventy-five percent of churches using the church council. Churches sustaining perennial evangelism programs.
