The Sixty-third Anniversary of the Association will be held with the First Church, Perry, Taylor County, Florida, on Tuesday and Wednesday, October 3rd and 4th, 1905.

The introductory sermon will be preached by Rev. Frank W. Cramer.

CONSTITUTION

-OF THE-

FLORIDA BAPTIST ASSOCIATION.

ARTICLE 1.

This Association shall be known by the name of The Florida Baptist Association. The object of this Association shall be to conduct the work of missions, colportage, Sabbath School enterprise and other work that will tend to the spread of the Gospel.

ARTICLE II.

This Association shall be composed of white male members chosen by the representative church in its union, in the proportion of two members for each church of fifty or less, and one additional delegate for every twenty-five members over fifty. No church, however, shall have more than four delegates.

ARTICLE III.

The letters sent by the churches of each session of the Association shall express their respective members in full fellowship, those baptized, received by letter, restored, dismissed, excommunicated and dead since last session.

ARTICLE IV.

Believing it to be proper, on account of the diversity of opinion among men as to the import of Scripture contained in the Old and New Testaments, to declare our belief and understanding thereof, we therefore append our belief in twelve articles and present them; with our minutes, to the Baptist denomination.

ARTICLE V.

The Association, when convened, shall be governed by a regular and proper decorum. A Moderator and Clerk shall be chosen by the votes of the members present, who shall hold their offices until the next session of the body, and until their successors are elected. The Moderator shall preside at the meetings of the Association, and the Clerk shall record the proceedings thereof and prepare them for the press.

ARTICLE VI.

The Association thus organized shall have no power to lord it over God's heritage nor infringe upon the internal rights of any church.

ARTICLE VII.

Newly constituted churches may be admitted to this union on application by letter and delegates; and if, upon examination, found to be orthodox, shall be received by the Association and the right hand of fellowship extended to the delegates by the Moderator.

ARTICLE VIII.

The Association shall furnish the minutes of their proceedings in proportion to the funds sent up for that purpose by the churches.

ARTICLE IX.

The minutes of the Association shall be publicly read (and corrected, if necessary) and then signed by the Moderator and Clerk before adjournment.

ARTICLE X.

Any amendment of, or change in this Constitution may be made by the votes of two-thirds of the members present at the two reg ular successive meetings of the Association. All other matters of fellowship shall be decided by a majority of votes. In matter of fellowship the Association must be a unit.

ARTICLE XI.

The Association shall have power, first, to provide for the general union of the churches; second, to give the churches advice in matters of difficulty; third, to inquire into the cause of the failure of any church to be represented at the meetings of the Association; fourth, to withdraw fellowship from any church or churches in this union who shall violate the rules of the Association, or who shall depart from orthodox principles of the revealed word of God; fifth, to appropriate the money contributed and sent up to the Association as specified by said churches, and when not specified it shall be appropriated to promote the best interests of the Master's cause; sixth, to adjourn to any future time and place they deem most convenient to the churches in the union.

RULES OF DECORUM

-OF THE-

FLORIDA BAPTIST ASSOCIATION.

- 1. At every meeting of the Association the Moderator shallcall the members to order and cause the Clerk to read the minutes of the previous Association.
- 2. The Moderator shall preserve order, and shall speak on any point of order with reference to the other members, and shall decide questions of order, subject to an appeal to the Association, when requested by any two members.
- 3. The Moderator shall put all questions distinctly in this form: "As many as are in favor (as the question may be) say "Aye." And after the affirmative vote is taken, "As many as are of a contrary opinion say "No." If doubtful which vote is in the majority, it shall be decided by rising and counting.
- The Moderator shall appoint the committees, except in cases of appointment by ballot.
- 5. In all cases of ballot the Moderator may vote. In all other cases he shall not vote unless the Association be equally divided, or unless his vote given to the minority will make the division equal. In that case the question shall be lost.
- 6. When any member is about to speak in debate he shall rise and address the Moderator.
- 7. If any member, while speaking or otherwise employed, transgress the rules of decorum, the Moderator shall, or any member may, call him to order.
- 8. When two or more members shall rise at the same time, the Moderator shall decide who is first entitled to the floor.
- 9. No member shall indulge in unkind remarks in debate, nor shall any member speak more than twice on the same question without leave from the Association, nor more than once until every one choosing to speak shall have done so.
- 10. While any member is addressing the Association it shall be the duty of the Moderator to suppress all private discourse that may be entertained between the members, and require strict attention on the part of the members.
- 11. When a motion is made and seconded it shall be stated by the Moderator before debate.

- 12. Every motion shall be reduced to writing if desired by any member of the Association.
- 13. After a motion is made and seconded it shall be deemed in possession of the Association, but may be withdrawn at any time before being discussed or amended.
- 14. When a question is under debate no motion shall be entertained unless to amend it or to refer it to a committee, or for the previous question, or for adjournment.
- 15. A motion for adjournment shall always be in order, and decided without debate.
- 16. Any member may call for a division of a question when two or more distinct propositions are set forth, and when the substance will admit of division.
- 17. Motions and amendments may be referred to a committee at the pleasure of the Association.
- 18. Every resolution shall receive two statements or readings in the Association previous to its passage. The first shall be for information, and the second when the decision of the Association is to be made.
- 19. These rules may be changed or amended at any full meeting of the Association.
- 20. The Association shall be opened and closed with prayer each day by the Moderator or some other member.
- 21. All queries shall be fairly stated in writing and approbated by two-thirds of the members present before they shall be acted upon.

ARTICLES OF FAITH

-OF THE-

FLORIDA BAPTIST ASSOCIATION.

- Article 1. We believe in one only true and living God, and that there are three in the Godhead—the Father, the Son and the Holy Ghost.
- Article 2. We believe the Scriptures of the Old and New Testaments are the Word of God, and the only rule of faith and practice.
- Article 3. We believe the doctrine of particular and eternal election.
- Article 4. We believe in the doctrine of original sin.
- Article 5. We believe in man's impotency to recover himself from the fallen state in which he is by nature, by his own free will and ability.
- Article 6. We believe that we are justified in the sight of God only by the imputed righteousness of Christ.
- Article 7. We believe that God's elect shall be called, regenera ted and sanctified by the Holy Ghost.
- Article 8. We believe that the saints shall persevere in grace and never finally fall away.
- Article 9. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ; that nothing is baptism except immersion; that believers are the only subjects of this ordinance, and that none but baptized believers are entitled to partake of the Lord's Supper.
- Article 10. We believe in a general resurrection of the dead and a general judgment.
- Article 11. We believe that the punishment of the wicked shall be everlasting, and the joys of the righteous will be eternal.
- Article 12. We believe that no minister has a right to administer the ordinances only such as are regularly called and have come under the imposition of the hands of the presbytery.

SIXTY-SECOND ANNIVERSARY.

TUESDAY MORNING SESSION.

- 1. The Association held its Sixty-second Anniversary with the Concordia Church, Concord, Fla., on October 11th and 12th, 1904.
- 2. At 10.30 o'clock the Association was called to order by the Moderator, Rev. F. M. Wells. Thirty minutes were spent in devotional service, conducted by the Moderator. Revs. W. L. Savage, S. J. Revell and Frank W. Cramer engaged in the service.
- 3. At 11 o'clock Rev. A. J. Reamy, who had been appointed the previous year to preach the introductory sermon being absent, Rev. F. C. Edwards, of Orlando, Fla., managing editor of the Southern Baptist Witness, preached the sermon. Text, Matthew, 6, 33. Theme, "The Christians Hope."
- 4. At 12 o'clock the Association adjourned for dinner, until 2 p. m.

TUESDAY AFTERNOON SESSION.

- 5. At 2 o'clock the Association convened for business, the Moderator in the chair. Sang hymn No. 599. The Moderator read Psalm 19, and prayer was offered by Rev. A. V. Reese.
- 6. In the absence of the clerk, Rev. Stephen Crockett, on motion Rev. Frank W. Cramer was elected clerk pro tem.
- 7. The name of each church was then called and the letters were brought forward and were read by Brn. W. L. Savage and O. B. Hall and the names of Messengers enrolled (see page —).
- 8. After the letters had been read and the messengers had been enrolled, the Association formally organized by electing Rev. F. M. Wells, of Alamo, Fla., Moderator; Rev. Frank W. Cramer, of Tallahassee, Fla., clerk, and Bro. O. B. Hall, of Concord, Fla., treasurer
- 9. Visiting brethren were then invited to seats with us and extended the courtesies of the floor. Brn. F. C. Edwards, of Orlando,

and A. V. Reese, of Crawfordville, responded and were welcomed by the Moderator.

10. Upon the call for "Petitionary Letters," Rev. A. V. Reese, pastor of the church at Crawfordville, Fla., presented a letter from his church asking for admission into the Association.

11. The letter was then read by the clerk, and, on motion by Bro. A. S. White, the church at Crawfordville was admitted to membership in the Association. The Moderator gave the hand of fellowship to Bro. A. V. Reese as the pastor and representative of the church.

12. Upon invitation of the Moderator, Rev. F. C. Edwards, of Orlando, who was present representing the claims of the Southern Baptist Witness and the Florida Ministerial Assurance Association, presented these interests in a very admirable address.

13. The Moderator then appointed the following committees:

- Committee on Bible Schools—Brn. S. J. Revells, M. J. Andrews, R. B. Langston.
- Committee on Ministerial Education—Brn. W. L. Savage, J. W. Smith, Albert Reams, E. L. Reeves.
- Committee on Foreign Missions—Brn. A. V. Reese, Noah Langston, H. C. Billingsley, W. D. Richards, Thomas Crayen.
- Committee on Preaching—The pastor and deacons of the entertaining church and Bro Thos. Syfrett.

14. The following delegates to the State Convention were appointed: Brn. E. L. Wells, W. L. Savage, Frank W. Cramer, A. V. Reese, F. M. Wells, A. S. White, S. J. Revells, A. L. Roberts, J. E. Clements, James Holland.

15. Bro. W. L. Savage was appointed the delegate to the Southern Baptist Convention, meeting in Kansas City, Mo., in May, 1905.

16. The Committee on Preaching announced that Rev. A. V. Reese had been appointed to preach at the evening service.

17. Miss Jennie Spalding, secretary of the W. B. M. U. of Florida, presented the work of that society in a very interesting address.

18. Adjourned to meet at 7.30 o'clock p. m.

TUESDAY EVENING.

19. 7.30 o'clock. Thirty minutes were spent in a devotional service conducted by Bro. S. M. Wells. Scripture reading, Ezekiel, 33, 1-11. Brn. Frank W. Cramer and F. C. Edwards took part in this service.

MINUTES OF THE WOMAN'S ASSOCIATIONAL

MISSIONARY MEETING, HELD IN CONNECTION WITH THE FLORIDA BAPTIST ASSOCIATION, ON TUESDAY, OCTOBER 11, 1904.

On Tuesday afternoon, at 2 o'clock, a Woman's meeting was held in the school house, opposite the church. Miss J. S. Spaulding gave an interesting and instructive talk on Missions, at the close of which, announcement was made for the annual business meeting of the Association to be held the following afternoon.

After a song and prayer on Wednesday afternoon, the women united in a Bible study on Woman's Work. The Vice-President then read a letter from Brother Willingham, Secretary of the Foreign Board, who sent words of greeting and encouragement to the women of the Association, telling something of the great work already accomplished by the women of the church, and what would be expected of them this year.

Work in the Indian Territory was next spoken of and a letter from Miss Perry, one of our Missionaries located in that field, was read by Mrs. A. S. White of Quincy.

An interesting report from one of our workers among the immigrants of Baltimore, was read by Mrs. Frank W. Cramer. A collection was then taken for the Bible Fund, which has been instituted in connection with this work, that the Word may be freely distributed among the immigrants.

Reports were read from the different Missionary Societies by the respective delegates, the following societies being represented:

Tallahassee Providence, Quincy, Moseley Hall, Madison and Carrabelle. The records of the different societies proved that the women of our Association are not idle. More work, however, needs to be accomplished. More spirit and power, more knowledge and zeal are needed to make the woman's work of our Association more effectual and significant. More women need to be awakened and brought into active service. Amount contributed to Bible Fund and Foreign Missions, \$11,00.
