### COMMITTEE ON MISSIONS.

The committee on missions made the following report which was discussed by H. M. King, H. B. Mizell, J. C. Porter, W. T. Hundley, R. M. Williams, J. B. Davis, J. F. Perry, B. R. Moseley.

It is unnecessary for your committee on Missions at this time to discuss the subject in its scriptural obligation, but rather call your attention to the situation that confronts us in our work at present. In our present financial condition we should encourage the pastors of our Churches to make diligent effort to supply the destitutions nearest their respective Churches And our Associational Committee give their first attention to the weak Churches in our bounds

We are not definately informed of the condition of the work in the care of our State Board. In addition to their depleted treasury from general causes they have had the further misfortune of loss of funds already in hand. Of the field in charge of our Home Board the work in Cuba is in the midst of circumstances of cruel and relentless war and all Christians ought to pray that God will at the same time give her people natural liberty and by the power of the Gospel, give them spiritual salvation. In some of the foreign fields fiery persecution rages, and the lowering clouds of war hang over the missionaries and our

earnest prayers should be constantly offered for them. We beleive these are the conditions which in the providence of God immediately precede the final triumph of the Gospel in those lands.

### REPORT ON TEMPERANCE.

The committee on Temperance made the following report, which was discussed by S. C. Tapp, J. C. Porter, R. F. Rogers, B. R. Mose e. . . . . .

The committee on Temperance beg to submit the

following preamble and recommendation:

Whereas the present age is a day of intemperance not only in an alcoholic sense, but in the broadest and true meaning of that term in the active and every day life of our society. Therefore we declare and recommend it to be the duty of our pulpit, first to carefully watch the fabric of society by giving the proper instruction to the young of our land and educating them in and to the great duties and responsibilities of social life, and to call upon the parents of the children of the land to inculcate temperance in its true sense to the youths of the country. We declare and recommend it to be the duty of our pulpit, second to acquaint itself from a scientific standpoint with the great evil effects of habitual alcoholic drink, and to emphatically denounce, and warn the people of the evil thereof. We declare and recommend third, that we as a denomination take our stand by the land marks of our fathers by dec'aring that we will always be found on the side of right, in protecting our hones and social life both in the Church and out of the Church, in the fight for temperance in its broadest and true sense in this day, of fast and reckless living, and immoral life.

We have reason to thank God that the losses are very few. ### REPORT ON EDUCATION

The committee on e lucation made the following report which was discussed by W. M. Halloway, B. R. Mosely.

We, your committee on education beg to report as follows: Education in the highest and most comprehensive sense, embraces the full and harmonious development

of the whole man, the physical, the intellectual, and the spiritual. The training of any one of these faculties to the exclusion of the others, may be productive of results injurious in the highest degree. For instant, the training of the physical powers alone, may produce the physical giant, the athelete or the prize fighters; that of the inteluctual only, thy physical dwarf, the mental dyspaptic, the agnostic, or the atheist; that of the spiritual to the exclusion of the others, the faoatic. Therefore previous to the selection of a school for our boys and girls in general, and our ministerial students in particular, a careful scrutiny of the cerriculum of such schools should show a due consideration of the foregoing physologic principles. It is with pleasure that we recommend Stetson University as being a school which fills all of these requirements, we regard it as a school whose central figure is God, whose aim is His ultimate glory, and therefore, deserves the patronage of our denomination. While we would not ignore the importance of educating the masses, we would call special attention to the necessity of ministerial education. In these days of progress, science and learning and in many instances, we are sorry to say of skepticism, agnosticism or infidelity it is imperatively necessary that we have a liberally educated ministry to counteract these baneful influences, and to be able at all times to give a reason for the hope that is in them. We therefore coupled with a divine call to the ministry take strong grounds for ministerial education, and urge that as far as possible, we as a denomination exert our energies, offer our prayers, and contribute of our substance towards the consumation of W. ### CONSTITUTION.

- I. The Association shall be called the Santa Fe River Baptist Association.
- 2. This Association shall be composed of messengers from Baptist churches, of which they must be members, maintaining the Gospel discipline, and who must present letters from their respective churches certifying to their election as messengers.
- 3 The object of this Association shall be the reunion of the churches, the promotion of the true Gospel, and the dissemination of Bible truth.
- 4. This Association shall meet annually, on the first day of which meeting it shall elect, by ballot, a Modera or, a Clerk and a Treasurer.

5 Any Baptist church newly organized may become a member of this Association by a letter petitioning for membership and giving information concerning organization and presbytery and by whom organized. Any church coming from another Association may become a member of this Association by presenting petitionary letter, accompanied by a letter of dismission from the Association from which it comes.

6. This admits the right of any one of the churches comprising it to withdraw by application for a letter without assigning any reason for so doing. At the same time, this Association claims the right to withdraw from any church which departs from the principles of this by becoming he erodox in faith or disorderly in practice.

7. This Association shall be deemed an advisory council and shall treat the churches comprising it as independent hodies in all matters of self-government, and shall at no time interfere with their rights.

8 This Association shall have an Executive Committee of five, of which the Treasurer shall be a member ex-officio The other four members shall be elected annually by the Association, no two members being from the same church Three shall constitute a quorum for business. The Executive Committee shall elect its own chairman and secretary and shall have power to fill vacancies.

9. The Associational Mission work shall be under the control and supervision of the Executive Committee, and all missionaries shall make quarterly reports to them or whenever called upon to do so.

10. All churches shall be entitled to two messengers for the first fifty members and one additional messenger for each twenty-five members after the first fifty and for the major fraction thereof.

and disburse all funds of the Association, but only by order of the Association or Executive Committee.

12. This Constitution may be amended at any regular meeting of the Association, by a two-thirds vote of the messengers present.
