CONSTITUTION

- This Association shall be called the Santa Fe River Baptist Association.
- 2. This Association shall be composed of Messengers of Baptist Churches of this Association, maintaining the Gospel discipline. Such messengers to be elected by their respective churches. Also all pastors of churches in the Association shall be members by virtue of their office. In case any of the messengers, or their alternates so elected, fail to attend, Association at its own discretion can seat any other members of that church as Messengers until the pro rata share of messengers of that church has been supplied.
- 3. The object of this Association shall be the reunion of the churches, the promotion of the true Gospel, and the dissemination of Bible Truth.
- 4. This Association shall meet annually, on the first day of which meeting it shall elect, by ballot, a Moderator, a Clerk and a Treasurer.
- 5. Any Baptist Church newly organized may become a member of this Association by letter petitioning for membership and giving information concerning organization and presbytery, and by whom organized. Any church coming from another Association may become a member of this Association by presenting petitionary letter, accompanied by a letter of dismission from the Association from whence it comes.

- 6. This Association admits the right of any of the churches comprising it to withdraw by application for a letter without assigning any reason for so doing. At the same time, this Association claims the right to withdraw from any church which departs from the principles of this compact by becoming heterodox in faith or disorderly in practice.
- 7. This Association shall be deemed an advisory council, and shall treat the Churches composing it as independent bodies in all matters of self-government, and shall at no time interfere with their rights.
- 8. This Association shall have an Executive Committee to be composed of one member from each church in the Association, the officers of the Association being ex-officio members. These members, aside from the ex-officio members, shall be efected annually by the churches and their names inserted in the Church letter sent to this Association. The Executive Committee shall elect its own chairman and secretary, and shall have the oversight of the Association work in the period between the annual meetings, and shall have power to fill vacancies on failure of Churches to appoint.
- 9. The Association mission work shall be under the control and supervision of the Executive Committee and all Missionaries shall make quarterly reports to them when called upon to do so.
- 10. All churches shall be entitled to two Messengers for the first fifty-five members, and one additional Messenger for each twenty-five additional members after the first and tor the major fraction thereof. All pastors of churches of this Association shall be members of this Association by virtue of their office.
- 11. It shall be the duty of the Treasurer to receive and disburse all funds of the Association, but only by order of the Association or Executive Committiee.
- 12. This Constitution may be amended at any regular meeting of the Association by a two-thirds vote of the Messengers present.

ARTICLES OF FAITH

Article 1. We believe in only one true and living God, and that there are three in the Godhead; the Father, the Son and the Holy Ghost.

Art. 2. We believe that the Scriptures of the Old and New Testament are the inspired Words of God, and the only rule of faith and practice.

Art. 3. We believe in the doctrine of the original sin.

Art. 4. We believe that man is elected to salvation through faith in the Lord Jesus Christ, and is justified in the sight of God by the imputed righteousness of Christ.

Art. 5. We believe in man's inability to save himself from the fallen state from which he is, either by nature or by his own free will.

Art. 6. We believe that the man must repent to God alone for the sins he has committed.

Art. 7. We believe in the doctrine of regeneration by the Holy Spirit.

Art. 8. We believe that santification is the progressive work of the Holy Spirit, according to the will of God, whereby we are made partakers of His Holiness, through continued use of the appointed means, the Word of God, self-examination, self denial, watchfulness, prayer, and the practice of all Godly exercises and prayer.

Art. 9. We believe that all saints shall persevere in grace and never finally fall away.

Art. 10. We believe that a Gospel Church is a company of Christ's baptized believers, associated by covenant in the faith and fellowship of the Gospel; observing the ordinances of Christ; governed by His laws and exercising the gifts, rights and privileges invested in them by His Word; that only spiritual officers are bishops or pastors and deacons, whose qualifications, claims and duties are defined in the epistles to Timothy and Titus.

Art. 11. We believe that Christian baptism is the immersion in water of a believer in Christ, by one duly qualified

to administer the ordinance.

Art. 12. We believe that the Lord's supper is a provision of bread and wine, representing Christ's body and blood, partaken of by the members of the church assembled for that purpose, and that the Scriptural qualifications for partaking of same are regeneration, baptism, fellowship, unity and doctrine.

Art. 13. We believe that no minister has the right to administer the ordinances only such as are called, and have come under the imposition of hands of the presbytery.

Art. 14. We believe in the general resurrection of the dead, and a general judgment.

Art. 15. We believe in the punishment of the wicked everlasting, and the joys of the righteous eternal.

Art. 16. We believe the first day of the week is the Lord's Day, is a memorial of Christ's resurrection, and should be kept holy, by the observance of all means of grace, both private and public, and by abstaining from all secular labor, except works of mercy and necessity.

Art. 17. We believe in the second coming of Christ and that when He comes He will raise the dead from their graves and judge the world righteously, appointing to the wicked endless sorrow, and to the righteous endless joy.

CHURCH COVENANT

Having been as we trust brought by Divine Grace to embrace the Lord, Jesus Christ, and to give ourselves wholly unto Him, we do solemnly and joyfully covenant with each other to walk together in Him with brotherly love to His glory as our common Lord. We do, therefore, in His strength engage that we will exercise a Christian care and watchfulness over each other and faithfully warn, exhort and admonish each other as occasions may require. That we will not forsake the assembly of ourselves together. But will uphold the worship of God and the ordinances of His house. That we will not omit closet and family religion at home nor, neglect the great duty of religiously training our children and

those under our call for the service of Christ and the enjoyment of Heaven. That as we are the light of the world and the salt of the earth, we will seek Divine aid to enable us to deny ungodliness and every wordly lust, and to walk circumspectly in the world that we may win the souls of men; that we will cheerfully contribute of our property according as God has prospered us for the maintenance of a faithful evangelical ministry among us for the support of the poor and to the spread of the Gospel over the earth. That we will in all conditions, even till death, strive to live to the glory of Him, who hath called us out of darkness into His marvelous light.

SEVENTY-SECOND ANNUAL SESSION

of the

SANTA FE RIVER BAPTIST ASSOCIATION Held With The

FIRST BAPTIST CHURCH, HIGH SPRINGS, FLORIDA FIRST DAY

Tuesday, October 30th, 1928, 10:00 A. M.

- 1. The Seventy-Second Annual Session of the Santa Fe River Baptist Association convened with the First Baptist Church, of High Springs, Florida, Tuesday, October 30th, 1928, at 10:00 a. m.
- The Moderator, E. R. Simmons called the Association to order.
- Devotional service was conducted by T. D. Denman of Melrose.
- 4. R. D. Walker pastor of the High Springs church gave the address of welcome. Response by A. L. Proctor of Alachua.
- 5. Petitionary Letters were called for but none were presented.
- 6. Visitors were recognized as follows: Rev. S. S. Proctor from the New River Association, and Mr. Upchurch representative of laymens work.
- 7. A solo rendered by Rev. Maxie Collins, Jr., was greatly enjoyed.
- 8. The Association entered into the election of officers with the following results:
- 9. On motion of E. A. McDowell the Clerk was instructed to cast the ballot for E. R. Simmons as Moderator.
- 10. On motion of E. A. McDowell, T. V. McCaul was instructed to cast the ballot for E. B. Perry as Clerk.
- 11. On motion of H. C. Peeples, E. A. McDowell was instructed to cast the ballot for E. E. Stokes as Treasurer.
 - 12. On motion duly made and carried the chair was in-

structed to appoint a committee of three on Digest of Church Letters.

- 13. The chair appointed the following committee: T. V. McCaul, chairman; G. W. McCall and E. A. McDowell.
- 14. The annual sermon was preached by J. M. Lewis of Waldo, using as a theme a "Journey from birth to the end of life." Text 2 Kings 2:1-15.
- 15. A motion that the printed programs as presented by the Moderator be adopted as the order of business with the understanding that such changes as might be necessary should be made, prevailed.
 - 16. Recessed for dinner.

Afternoon Session

- 17. The Association re-assembled at 1:45 p. m., and the devotional service was in charge of Jno. Dicks of Lake City.

REPORT ON FLORIDA BAPTIST CHILDREN'S HOME

There is something lacking in the physical constitution of a man or woman who does not love children, and whose heart does not go out in sympathy and love for them, and especially for those who have been left without father, mother and home by the hand of death. The children in our Florida Baptist Children's Home in Arcadia, Florida, belong to the Baptist of Florida, and is the only home supported by the State Convention for orphaned children.

We, as Baptists are under just as much obligation to care for them, both physically and spiritually, as the individual parents have the children born to them in their home. We have now in our home 180 children ranging in ages from infancy to 18 years old. The feeding alone of this number including the eighteen helpers and teachers, amounts to quite a sum. The cost is 10 cents a meal per capita. Then with the salaries for the helpers, clothing and other current expenses demands an income of around \$3,000 a month.

Many societies over the state furnish clothing for some of the children, and a goodly supply of food donations are made, but even with these the financial problem is one which demands the full co-operation of every church in the state.

There are 80 acres in the Home property in Arcadia. The citizens of Arcadia and DeSoto county are paying for 240 acres to give to the Home, which is located about 6 miles north of Arcadia on the highway. There are nine buildings, seven of them two-story. Six of these buildings are dormitory buildings with chapel, dining room, laundry, office, printing office, sewing room and girls parlor on the lower floor. The other three are the superintendent's home, school building and bath building.

All children old enough have regular duties each day. Duties are changed every two weeks, so that the children receive instruction in all parts of the home work. All children of school age are in school and have the privilege of going through the eleventh grade in the Home and finishing the twelfth grade in the county high school. So we see they have equal privileges with other children along the educational line.

The spiritual side of their natures is not neglected. With few exceptions the children who are old enough to understand, are Christians and members of the First Baptist church in Arcadia. The older children alternate in conducting a fifteen minute service in the large dining room each morning before breakfast. They have Sunday School in the chapel each Sunday morning, and preaching service each Sunday evening, attending the eleven o'clock preaching service at the First Baptist church. They have senior, intermediate and junior B. Y. P. U. each Friday evening.

We have a very efficient and capable superintendent in Bro. J. E. Trice, who has at all times the best interests of the children and Home on his heart. For the past year the Convention has allowed the Home five per cent of all money sent through the state office at Jacksonville, to the Unified Program. The management of the Home was given liberty to go afield to raise funds to supplement this amount for the support of the Home. Some Sunday Schools give one Sunday's collection each month to the support of the Home, but the amount received has not met the needs.

We would recommend that each Sunday School in this Association give one Sunday's collection each month, and that each church make a liberal offering beside, to help in this worthy cause.

We would also recommend that each and every Baptist remember the Home and its needs in their prayers, and then "put wings to their prayers" that the work of the Home may be carried on in a way that the finger of scorn may not be pointed at us, and we be told that "ye did it not unto me."

REPORT ON CHRISTIAN STEWARDSHIP

The subject of Christian Stewardship is vital and of primary importance, not only to this Santa Fe River Baptist Association but to each of the Churches composing and constituting this Association; and also to each and every individual member of every Baptist church, whether of this Association or not: but also to each and every individual who has yielded allegiance to Jesus Christ as Saviour and Redeemer whether they follow us or belong to some other of Christ's folds. Because Christian Stewardship as it is now used has come to mean the genuine, true, faithful, loyal followers of Christ, by all those who have studied the meaning of this comparatively modern phraseology. And there are many among us, who walk orderly, as good, and in many cases, fruitful and exemplary Christian lives; and yet they do not fully understand its significance: nor have they ever tasted the sweet pleasures of the Divine favors and blessings which God so freely bestows upon the faithful ones who yield themselves compeletely to His service and endeavor to follow Him closely in all of His commandments and in all of His appointed ways.

While the words Christian Steward or Stewardship are modern you must not get the idea that this is some new thing and therefore has no vital importance or significance to you; for it refers to fundamentals that Abraham (The father of the faithful) yielded to and complied with five hundred years before the Jewish nation was established in that land which God gave to Abraham as a reward for his faithfulness and promised to his seed after him forever if they would remain faithful to Jehovah.

What then is a Steward and Christian Stewardship? A Steward is defined to be (1) A person entrusted with the management of estates or affairs not his own. (2) A person put in

charge of the domestic affairs of an establishment; specifically on shipboard, a petty officer in charge of the service of provisions and passengers rooms.

As it relates to Christ and His Kingdom then it is every one

who has taken up his cross to follow Him.

The Apostle Paul says in I Corinthians Chapter VI and the 19th and 20th verses: "What? Know ye not that your body is the temple of the Holy Ghost, which is in you, which ye have of God; and ye are not your own? For ye are brought with a price; therefore glorify God in your body and in your spirit, which are God's."

Then, when all who profess to follow Jesus shall recognize this true relationship, and shall faithfully administer the trust and honor and obey Him in all things, we may hope to see His

Kingdom established.

In our beloved Association we are sure there are many loving disciples who are making noble sacrifices and giving freely of time, talents and loving faithful service, and tithes and offerings and because of these we ought to thank God for the measure of

peace and prosperity that many of our Churches enjoy.

But if we could enlist each member and individual follower to come up to the full measure of Stewardship in tithes and offerings and loving and devoted service of time and talents how great would be our rejoicing, for, "God would then open the windows of Heaven and pour us out such a blessing that there would not be room enough to contain."

Nine Unions have held one study course each, with 180 awards granted. Four of the B. Y. P. U.'s of this Association have been A-1 for the past year. Tithers reported seventy-five.

Two Associational B. Y. P. U. meetings have been held during the year. Rev. R. D. Walker of High Springs served as president for the past term: Mr. Maxine Collins of Gainesville has been elected for the ensuing term. The meetings have been well attended with much enthusiasm and interest manifested in the work. The Associational B. Y. P. U. stands ready to help and develop B. Y. P. U. work in the Association. Meetings will be held quarterly at various points in the Association.

We have 18 churches in our Association with a total membership of 3034. As stated above only 12 churches have B. Y. P. U.'s with a membership of 500. You see the great need of real B. Y. P. U. work in our Association.

Because of this vast field of much needed B. Y. P. U. work,

the committee desires to recommend the following:

1. That the churches co-operate with the B. Y. P. U. work in enlisting every possibility for membership.

2. That the pastors of our Association be present at the

REPORT ON HOME MISSIONS

The Home Mission Board of the Southern Baptist Convention made its eighty-third annual report of the Convention in Chattanooga last May. Notwithstanding serious falling off in receipts for several years past and necessary retrenchment in the work of the board, the year's work was most encouraging. The faithful sowing of former years brought a glorious harvest of souls won to Christ.

The Board's work is done through the Departments of Cooperative Missions, Independent and Direct Missions, Evangelist Mountain Mission Schools, Cuba and Panama, Church extension, and the Tuberculosis Sanatorium, El Paso, Texas. The Executive Secretary has general supervision of all the work and specially in charge of the Co-operative Missions.

Co-operative Missions is that work done jointly by the Home Mission Board and various State Mission Boards. It has been the one great unifying feature of our mission work and has meant much to the unity of Southern Baptists.

In the Department of Independent and Direct Missions. which is under the sole direction and support of the Home Mission Board, work is done among the foreigners. Indians, negroes, deaf mutes, soldiers and seamen, with Rev. J. W. Beagle, superintendent. The work has been wonderfully blessed during the past year. The same can be said of our Mountain Mission Schools under the direction of Rev. J. W. O'Hara, superintendent, and of the work in Cuba with Rev. M. N. McCall, superintendent, which has been greatly blessed and is growing steadily stronger. The Department of Evangelism as a soul-winning agency has a record unsurpassed. Through the church extension department, Rev. A. J. Barton, superintendent, the home Mission Board makes loans to churches towards the erection of houses of worship at reasonable rate of interest and time. On request, the Board will send free literature, sure as tracts and leaflets, on different phases of the work.

Record of Ten Years

From the annual report of the Board it is learned that in the last ten years 89,300 converts were baptized and 111,015 added to the churches through the labors of our evangelists. We have had during that time 4,165 converts in our mountain schools. 4.146 graduates, and influences have been set in motion which will not cease until our Lord comes.

Ten years ago our Cuban Convention had 57 delegates and their total offerings were \$4,065.21, with membership, 1,919: in 1927 there were 108 delegates at the convention and their offerings for the year were \$21,225.00, and the membership increased to 2,737. The native churches in Cuba during the ten years contributed something over \$125,000. The spirit of evangelism is reported strong.

A summary of the Board's work for ten years shows the following results: Baptisms 344,966, additions to the churches 556.957, prayer-meetings conducted 175.088, churches constituted, 1,905, Sunday Schools organized 6,128, houses built 4,184.

The Home Mission task was never greater and our opportunities never more inviting. The calls are many, and the future, if we are loyal to the Master, has great things in store for Southern Baptists through our great Home Missiong Agency. The challenge is tremendous but our forces and resources are well nigh immeasurable and under the blessing of God must be brought under contribution to the salvation of the lost and the enlistment and development of the saved. May God lead us in this great task of making America Christian and through America saving the world for Christ.

REPORT ON FOREIGN MISSIONS

In submitting this report your committee would mention first, one of the most outstanding occurrences in connection with the Foreign Mission Board of the past year, viz, the going home to his Heavenly reward of our dearly beloved, and venerated corresponding secretary. Dr. J. F. Love, which summons came on May 3rd. 1928, after several weeks of suffering.

This mighty man of God, whose very heart and life were centered in the work into which he had been called, by the body of Baptists of the Southland, gave fourteen years of faithful and devoted service.

Worldwide Evangelism was a theme upon which he wrote much, and in public addresses he never ceased to bring to the people the importance and advantages of this great work. One in writing, has this to say regarding him: "By his wise counsel in conference on the fields in the Orient, South America, Europe, and the Near East, he brought, reassurance and renewed devotion to the Missionaries. His zeal for the gospel was so unflagging that he pressed on without stint of time and physical strength until he lay exhausted and prone in death. Indeed, "There is a prince and a great man fallen this day in Israel."

We feel that a wise choice has been made in the appointment of Dr. T. Bronson Ray, to fill the vacancy; he is a man of God, fully acquainted with the work of the Board, and we know that under his wise guidance the work will go on. May all Southern Baptists stand loyally back of him!

While there have been some discouraging features in connection with this work, among which is the debt, and the necessitated retention in this country of missionaries whose furloughs had ended; the inability to send those who had already completed preparation for this work; and the negative replies to calls for needed assistance and equipment by those now upon the various fields. Yet some cheering features have lent encouragement; through a system of readjustment and painstaking economy the debt was reduced nearly \$80,000 during the short period Jan. 1, to May 1, 1928.

Through the generosity of interested friends, we are glad to report that Dr. Stamps and family are back on their field in China: Brother Fowler and family are again at work in South America. Several others have gone back and a very few new ones have been sent.

From all lands our missionaries report much progress, the awfully disturbed condition of China last year, is a great deal clearer and more promising, and work being resumed in places where the missionary had been driven out.

On Feb. 1, 1928, the Roumanian government granted Baptists full religious liberty of teaching, and treatment on equal footing with all Roumanian citizens.

Our work in Africa has grown and now ranks third in the numbers of our churches.

In all Latin lands south of us wonderful evangelizing opportunities are presented. This was illustrated by the wonderful response to the message of Dr. John R. Sampey, who made two evangelistic tours in Brazil. That this is true may be seen in the fact that 3,000 baptisms were reported on that field last year.

Our hearts rejoice when we learn that 12,542 baptisms were reported on all fields in which our missionaries were working last year.

So brethren, we have much to be thankful for, and would suggest a more prayerful spirit among the churches: a greater knowledge of the work of our Foreign Mission Board: more mission study classes organized: and greater effort in our giving to this noble work.

REPORT ON SUNDAY SCHOOLS

Your committee begs to report that of the eighteen churches in this Association, sixteen have Sunday Schools. Two of these Gainesville and Waldo are Standard and several others lack only one or two points. Attendance reports are something less than 50 per cent of the enrollment in many of these. We therefore recommend that a steady, consistent effort, on the part of both teacher and pupil in personal work to remedy this condition. Let us make each individual responsible for someone else.

Baptisms reported are forty-eight. Let us bear in mind that the Sunday School is the Evangelistic agency of the church and let us strive to have them carry out our Lord's command, "Go ye and disciple all."

We urge our Sunday Schools to if possible, to give the offering of one Sunday each month to the support of the Baptist Orphanage at Arcadia. This report would not be complete without an account of the Annual Sunday School Convention. This meeting was entertained ably by the Sardis Church in a two day session.

While the meeting was mainly inspirational, some timely practical addresses were made. Pastor Dicks of Sardis, deliverd an especially fine address on "the reaching of the home by the Sunday School." Dr. McCaul gave the real keynote of the meeting in a ringing evangelistic sermon. We therefore urge our churches to

send their teachers to the next meeting which will be held at Waldo..

Your committee wishes to recommend an increased emphasis on teacher training, especially in the smaller churches. We would call attention to what we conceive to be a real opportunity on the part of the larger churches, namely, extension work in training classes in the weaker churches.

REPORT ON TEMPERANCE

A woman living in Zanesville, Ohio, recently published the following recipe in the newspapers: Take one regular, natural born fool, add two or three drinks of bootleg liquor and mix the two in a high powered motor car. After the fool is thoroughly soaked, place his foot on the gas and release the brake. Remove the fool from the wreckage, place in black satin-lined box and garnish with flowers.

As a surgeon, I have seen this recipe tried a number of times and it has always proved a success. The motor cars are growing in number day by day, and although there is a marked decrease in liquor under the 18th Amendment it is still necessary for God's people to be on the alert concerning Temperance, if we care to protect these natural born fools as well as our own skins.

You may not agree with me on first thought, my friends, but it seems to me that I see a fundamental law not usually recognized, that is: That in a sense the minority rules. Let the baby develop colic or diptheria and see what happens to the majority of the family the rest of that livelong night. Break that minor part of your anatomy known as the ankle and though your brain and body may function actively, you cannot walk. The whole body is subservient to the broken ankle. Put out your eyes and though you may reason logically and expostulate vociferously, the whole body must grope its way uncertainly, if at all. While this appeals to me as a doctor, yet as a Christian it seems to me to be true of spiritual things.

We, the great majority, have written the Eighteenth Amendment into the Constitution of our great and glorious nation. It is the law. Yet there are a minority who are slaves to a desire for intoxication. Who break the law, who corrupt officials and who are ever trying to undo that which it has taken one hundred years

to accomplish. So we must stop our other Christian activities and minister to those weaker brethren and prevent them from doing harm to their bodies and their souls. There are things we might have and do in our new liberty through Christ Jesus, but these we must lay aside and fight for fear they shall cause our weaker brothers to fall.

And so your committee, on account of this minority, comes again to bring to your attention a matter that is supposed to be already settled. For ten years now, we have had prohibition written into our Constitution, and it is well to inquire how our experiment has prospered. Has it been for good or for evil to our country and to our spiritually weaker brethren? In answer, I desire to quote to you from two men of great learning and extensive observation. Irving Fisher, professor of economics in Yale University finds 'That workers of all kinds since the advent of prohibition. are 10 percent more productive than ever before." This means that by the exercise of prohibition that there has been added to our annual national income, \$3,000,000,000. Now add to that \$2,700,-000.000 saved, that would have been spent for liquor, and we have the stupenduous sum of \$6,000,000,000 saved to our country by prohibition, without counting any savings in the cost of jails, almshouses, asylums, etc., or any economic savings from reducing the death rate. The real wages of workmen have been increased under prohibition 28 percent above the level maintained for more than a quarter of a century. Profits have risen enormously and the prosperity of our country is amazing the whole world." Personal savings, says Prof. Fisher, as shown by savings banks, life insurance and building and loan associations, have increased very largely under prohibition. Prof Fisher concludes by saying that 'Even if prohibition enforcement cost us \$1,000,000,000 a year, it would be well worth while purely as an economic investment.

Now listen, my friends, to a word from Warren S. Stone, Grand Chief of the Brotherhood of Locomotive Engineers. He says "It has been proved that the enormous number of saloons that have ceased to exist have been replaced by groceries, restaurants, shoe stores, clothing establishments, banks, etc. employing far more workers than the saloons did, and the value of land has now-where fallen, but usually has risen. School teachers everywhere reports that children come to school better dressed and better fed than before prohibition. Charity organizations report less work to do. Hospitals report a marked decrease in the diseases caused by drinking liquor. Jails have been closed up in all parts of the country." He concludes by saying "I wish those who expect modifica-

tion of prohibition could go with me as I travel over this broad land and see houses being erected, accounts opened in savings banks families together out in parks, children well fed with shoes to wear, and warm clothing going to school. I wish they could see with me prosperity, happiness, and sunshine where formerly there was squalor and misery." All this, he says is the result of prohibition. We are not going back to the old condition of things with their misery, want and poverty—NEVER AGAIN. "PROHIBITION HAS COME TO STAY."

Is that last statement true, my friends, are we doing our duty as Christians to make it true? We hear the demand for State Local Option and regulating the saloon by law, on every hand. Just as well try and regulate by law a polecat in the Floraida Everglades as a saloon. The only way to regulate saloons is the way we regulate rattlesnakes—by hitting them on the head with a club.

Many of you remember as I do the old days of saloons regulated by law, when men's lives were daily placed in danger and women dared not walk the streets. Are these days to return?

One year ago, there stood in the position I now occupy, a man of brilliant mind, a learned scholar, a Christian gentleman, a devout Baptist, my departed friend, Dr. A. A. Murphree, bringing to you his great message on temperance and his timely warning, With prophetic vision his great mind pierced the future and brought you warning and admonition. May I quote a few of his words? "The fight is still going on, the enemy is astute and his methods insidious. It is daily more apparent that the Christian Churches face the imminence of a battle for the preservation of the prohibition laws. The only proper attitude of Christians towards the liquor traffic is one of unqualified opposition."

His prediction was right, my friends, the time has come, we are face to face with the enemy. Recently a candidate for the highest office in our nation, repudiated his great party's platform and declared in no uncertain terms that he favored a change in the Eighteenth Amendment, so that each state might have local option if it so desired. This man will in all probability have the appointment of a majority of our Supreme Federal Court Judges that now are in favor of prohibition by a majority of only one. He appointed to head this great party a life-long Republican, who gave as his reason for leaving his party temporarily and accepting this great position. "That he might do a bit of constructive work to help rid the country of that damnable farce of prohibition." The issue, therefore is clear cut, the battle is on. The only question now is what are we Christians going to

do about it. I am glad to report that the signs of the times are most encouraging. Reports from all kinds of Christian bodies indicate that they will stand true to Christ's ideals rather than to party and not give by their votes sanction to the tearing down of our Constitution and prostitution of Christian ideals.

Our Baptist Witness has fought a good fight and taken its place as an unplacable foe to this enemy of Christian virtue.

Almost all our Associations have taken action against this candidate ringing true with Christian love for our Country and our weaker brethren. This Association one year ago, unanimously adopting Dr. Murphree's resolutions, pledged itself, listen—"To persistently advocate total abstinence and strict law observance: active and faithful co-operation with officers in enforcing Prohibition: to organize a committee of citizens with co-operation with officers of the law, its specific task—to oppose for public office any candidate whose record for law observance and law enforcement does not stand out clear and above suspicion."

It seems to me that this Association has already taken action and is definitely pledged to oppose the candidacy of alcohol Smith who with Raskob stands out clear and determined to set aside one hundred years of our patient endeavor and tear down our constitution providing prohibition. We recommend, therefore, that as a Christian body, you go forth to this battle equipped like men and women of God or take steps NOW, rescinding your unanimous pledge of a year ago, to oppose any candidate who did not stand for observance and enforcement of the Eighteenth Amendment.
