CONSTITUTION

ARTICLE I-NAME: The name of this association shall be called THE SANTA FE RIVER BAPTIST ASSOCIATION.

ARTICLE II-OBJECTS: The objects of this association shall be: (a) To encourage the spirit of cooperation between the member churches in their Divinely appointed work.

(b) To provide direct missionary activity in reaching unevange-

lized areas within the bounds of the Association, and

(c) To effect a closer cooperation between the Churches and the Florida Baptist Convention and the Southern Baptist Convention, and a greater participation in the Denominational program of missions. education, and benevolence.

ARTICLE III—CHURCHES:

(a) This Association shall consist of Missionary Baptist Churches of regular faith and order, holding regular communication with the Association in its annual sessions, and subscribing to the beliefs of the Denomination and the objects fostered.

(b) Churches presenting petitionary letters from other Associations, and newly constituted churches presenting proper credentials of organization and articles of faith, accompanied by properly accredited messengers, may, by majority vote of the annual session, be

received into membership in the Association.

(c) This Association admits the right of any of the churches comprising it to withdraw by application for a letter without assigning any reason for so doing. At the same time, this Association claims the right to withdraw from any church which departs from the principles of this compact by becoming heterodox in faith or disorderly in practice.

ARTICLE IV-MEMBERS: This Association in session shall be composed of:

(a) All officers elected by the Association,

(b) The Pastors of the Churches in the Association, and

(c) Messengers elected by their respective churches on the following basis, and certified to the Association in session in their annual letter or petitionery letter: Each church shall be entitled to a minimum of three messengers and two additional messengers for every twenty-five members or major fraction thereof over the first fifty members, except that no church shall be entitled to more than ten messengers.

ARTICLE V-OFFICERS:

(a) The officers of this Association shall be: Moderator, Vice-Moderator, Clerk, Treasurer, Sunday School Superintendent, Training Union Director, Women's Missionary Union President, Brotherhood President, Chairman of Evangelism, Music Director, and Pianist.

(b) Officers shall be elected at each annual session, from members of this Association, to take office immediately, except the Moderator and Vice-Moderator, who shall take office at close of final session. The Moderator and Vice-Moderator shall be elected by ballot from nominations made on the floor of the first session of the annual session, and shall not hold office for a period longer than two successive years. All other officers shall be nominated by the nominating committee. If a vacancy occurs in any office between sessions, the Executive Committee shall elect an officer to fill such vacancy for the unexpired term. All officers shall serve until their successors have been elected.

ARTICLE VI-MEETINGS:

(a) The Association shall meet annually at such time and place as the body shall have determined at its annual session. In emergencies, the Executive Committee may make such changes in the time and place of the annual session as will best serve the interests of the Association.

(b) The Sunday School, Training Union, Women's Missionary Union, and Brotherhood officers shall conduct such meetings as are

in keeping with the Denominational program.

ARTICLE VII—COMMITTEES:

(a) The Executive Committee shall be composed of:

(1) All officers elected by the Association,

(2) The Pastors of the Churches in the Association, and,

(3) One additional member from each Church. These additional members to be nominated by their respective Churches and elected by the Association in annual session.

(b) The Program Committee shall be composed of the Moder-

ator, Vice-Moderator, and Clerk.

(c) The following committees, and any other authorized by the association, shall, unless otherwise provided, each be composed of three members appointed by the Moderator: Nominating Committee, Resolutions Committee, Radio Committee, Budget Committee, and Obituaries Committee.

ARTICLE VIII—AMENDMENTS: These articles may be made, altered or rescinded at any annual session of the Association upon a two-thirds vote of the members present, provided however, that one day's notice shall have been given, and that the proposed amendment shall have been presented in writing.

RULES OF DECORUM

SECTION I-DUTIES OF CHURCHES:

(a) It shall be the duty of each Church in the Association to forward with her messengers a written report on the forms provided, specifying the names of her messengers and giving statistical account of the work of the previous year. This report shall be presented on the first day of each annual session.

(b) Each Church shall nominate a layman for membership on the Executive Committee and shall report such nomination in writ-

ing to the annual session.

SECTION II—DUTIES OF OFFICERS:

(a) Moderator: It shall be the duty of the Moderator to preside at all sessions and appoint all committees not otherwise provided for. He shall serve as Chairman of the Executive Committee, submitting a written report of its work to the annual session. He shall also be Chairman of the Program Committee. He shall countersign all checks of disbursement.

(b) Vice-Moderator: It shall be the duty of the Vice-Moderator to perform all the duties of Moderator in his absence. He may also preside at Moderator's request. He shall serve as Vice-Chairman of

the Executive Committee and of the Program Committee.

(c) Clerk:

(1) The clerk shall keep a correct record of the proceedings of the Association, supervise the printing and distribution of the minutes, keep a regular file of the published proceedings of the Association, and deliver same, with all other materials belonging to the office, to his successor.

(2) He shall send to the clerks of the Churches the "Associa-

tional Letter" report forms at least thirty days prior to the annual session.

(3) He shall notify in writing, immediately upon their election or appointment, all persons elected to office or appointed on committees.

(4) He shall serve as Secretary of the Executive Committee, keeping a correct record of its proceedings and notifying its members in writing of all regular and special meetings.

(5) The clerk shall receive remuneration for his service, the sum to be fixed by the association at its annual session. Additional funds may be provided for the expense of his office.

(d) Treasurer:

(1) The Treasurer shall receive and disburse all Associational funds. All receipts shall be deposited in a public bank and all disbursements shall be made by check signed by Treasurer, countersigned by Moderator.

(2) All expenditures shall be authorized by the Executive Committee or the Association in annual session before disbursement

is made.

(3) Permanent records shall be kept, including cancelled checks and bank statements, and shall be delivered to his successor.

(4) Written reports shall be made quarterly to the Executive Committee and annually to the Association in annual session.

(e) Other Officers: The officers of the Sunday School, Training Union, Women's Missionary Union, Brotherhood, and Chairman of Evangelism shall perform the functions usual to their offices, following the plans outlined in their respective Denominational publications. The Executive officer of each department shall present at the annual session, a written report of the work of his department. The Music Director and Pianist shall have charge of the music at Associational and Executive Committee meetings, and shall endeavor to promote the cause of good music at the Churches.

SECTION III—DUTIES OF COMMITTEES:

(a) The Executive Committee shall transact all business of the Association between annual sessions. It shall meet quarterly at a time and place decided upon by the committee, and at other times and places upon the call of its chairman. If a vacancy occurs in any office between sessions, the Executive Committee shall elect an officer to fill such vacancy for the unexpired term.

(b) The Program Committee shall suggest the order of business for the annual sessions. Persons expected to make reports or otherwise take part in the program shall be notified in writing at least

one month prior to the session.

(c) The Nominating Committee shall, by written report at the first session of the annual session nominate all officers of the Association except as otherwise provided. The Committee shall have personally conferred with each nominee at least one week prior to his nomination. The committee shall serve throughout the year and if a vacancy occurs in any office between sessions, shall make nomination to the Executive Committee of an officer to fill such vacancy for the unexpired term.

(d) Other Committees shall perform the duties assigned them.

SECTION IV—AMENDMENTS: These Rules of Decorum may be made, altered, or rescinded at any annual session by a majority vote of the members present, all proposed amendments shall be presented in writing.

SECTION V: The parliamentary law which shall be used in the government of this Association shall be ROBERTS RULES OF

ORDER (Revised).

REPORT OF THE RADIO COMMITTEE

Santa Fe River Baptist Association October 12, 1951

Jesus said to his disciples that they were to preach the gospel in all nations. Since the death of Paul no one has thought that to be possible. Men have taken council of their own weakness and said "my power is limited, I can't do what he has commanded." Today that is not so, any man, with the proper equipment and proper connections can be heard in all nations at one and the same time.

If it is worth while that our government spend millios of dollars to proclaim the values of our American way of life to all nations it is imperative that Christians expend themselves to proclaim the Gospel to all nations. Others are ahead of us. We must step-up our efforts or the voice of the Gospel will be lost in the dine of commercial advertising.

The Baptist Hour is the answer of the Southern Baptist Convention to this world challenge. Inadequate as it is to reach all nations it is the best we have and, here in America, is reaching hundreds of thousands in their homes who cannot or will not attend church services where the gospel is preached. The Baptist hour broadcast is a great and distinctive missionary enterprise.

At our last annual association you instructed your Radio Committee to arrange to broadcast the Baptist Hour over WRUF, beginning Jan. 1, 1951. That has been done and has been continued until now. Next Sunday and on through the following Sundays the messages of Charles Welborn will be heard at 9 a. m. in the territory covered by this station. The Baptist hour has been well received. Numerous cards and letters from listeners anxious that we continue our broadcasts, testify to its place in the lives of the people in these seventeen counties.

Support of the broadcast from our churches has been inadequate to meet the expense of the broadcast. Station WRUF has been most forebearing and lenient and have continued their service to us as our debt to them has continued to accumulate. Some churches have been most generous in their support; others have given very little or nothing.

A good deacon in Williston in Marion Association heard our broadcast, and after some correspondence, led his church to contribute regularly to our fund.

There is evidence that at least three of our neighboring associations where the broadcast is heard, will take definite steps this fall to lend their aid to our effort.

With these encouraging signs we feel that our Radio Ministry will be on a firmer foundation this year and that the time will soon be that we can continue without fear of failure in this important Missionary endeavor.

REPORT OF BAPTIST BIBLE INSTITUTE

The Baptist Institute at Lakeland is well into its ninth year. 130 students have enrolled thus far, which is the same as were enrolled by this time last year. Including the summer term in 1950-51 there were 217 students enrolled. There were 116 preachers in this number not including duplications. All B. B. I. students, of course, are training for Baptist leadership.

The school continues to carry on as a Bible Institute that is thoroughly Baptist. It is not a seminary or college or high school. Its motto is "Help for those who want help." With this in mind, the school is preparing and sending forth leaders who are informed about our Baptist work and are thoroughly loyal to the Baptist program. Graduates and former students are rendering significant service in various parts of Florida and in many other states.

B. B. I. is a place of prayer. Some of the students meet each school morning at 6:45 for a Morning Watch. Members of the Faculty and Staff meet at 7:45 A. M. for their brief prayer session.

There is a fine spiritual atmosphere on this campus.

We are grateful to the Florida Baptist Convention for its approval and financial help. We want also to thank the churches for their gifts through their budgets and also for giving refrigerators to the school. Five of them have been purchased and are being used by student families. Others will be secured as they are needed. We

are grateful also to all who have sent gifts of any kind.

The Institute still has many urgent needs. With the growth of the school comes the need of more adequate buildings and equipment. More room for the young ladies, and especially for families, is desperately needed. Better financial support must be provided. Although it costs about one half as much to attend B. B. I. as to attend other schools, some fine worthy students need help to stay in school. B. B. I. is missionary and all that is done for the Institute is really done for missions. Please remember B. B. I. in your prayers.

REPORT OF RELIEF AND ANNUITY BOARD

The cooperative program represented in our relief and annuity board is another of the tangible ways in which we not only say to our Saviour, "Lord, Lord", but strive to "do as He says". For we remember His words, "Inasmuch as ye have done it unto one of the

least of these my brethren, ye have done it unto me."

It is one thing to teach and preach the Golden Rule, it is a better thing to live it. Christianity like charity should "begin at home" in the manner in which we provide for our servants who have served the Lord through many years and come to retirement age. On a sound, business-like basis we who participate in this endeavor set aside something of our own income and the church puts aside still another portion and the cooperative effort of all together provides for a small but helpful retirement pension and emergency benefits of various sorts.

Since Baptists believe so firmly in the separation of church and state, such a provision as we have in our relief and annuity program is not really an option. It is a must if our brethren are to face old age with tangible security. Since most of our ministers and denominational servants live on very inadequate incomes all of their

lives most of them never have any opportunity even with the best of thrift to provide for old age, especially when there are children to educate and living costs continually rising way out of proportion to salaries paid. There is no cost of living index in pastor's salaries. Many are receiving today exactly the same salary they received before inflation. Few if any of their laymen are receiving today the same salaries or wages they received before inflation. Thus, increasingly, this program becomes more and more imperative. Are you now in the program? Is your church doing its part by your pastor? The reference to the "Inasmuch as ye have done it . ." above we should remember is one of the few detailed pictures Jesus ever gave us as to what would take place at the final judgment. Have we realized how imperative this work is?

Please read the entire report of the Relief and Annuity Board in the last Southern Baptist Annual. You can see therein many of the improvements that we must prayerfully consider in making this program more effective. Let us become better informed and instruct our representatives to boards and agencies to keep on improving

this much needed work.

AMERICAN BIBLE SOCIETY REPORT

Do you know that with every missionary advance the Bible goes forward first?

If the people of the world are to know Christ they must have the Bible for it is the primary source of the knowledge of Jesus. It is the missionaries' chief tool — in fact—the Bible itself is a missionary. A missionary that can go where the human missionary cannot go and can stay when he must leave. It can speak when he is speechless, and speaks unerringly when the human may err.

But if the Bible is to speak to a man it must speak to him in his own language. This involves translation, publication and distri-

bution. All of this takes a great deal of money.

Now in most cases those who need the Bible so badly are either too poverty stricken to afford them; or are in such darkness they are too unconcerned to care. Therefore, someone must be concerned enough to care for them. That "Someone" is the American Bible Society, a missionary non-profit organization, supported by gifts. It aids in translation, publishes the Scriptures without note or comment, and sends these printed missionaries out to speak in far away places in strange sounding tongues, telling the familiar Gospel story.

Of the need there can be no doubt. In Germany alone the Nazi blackout of the Bible and the devastation of war resulted in a shortage of some twelve million Bibles. If Russia's legions of the militant godless are to be halted; if communism's propaganda is to be counteracted, then the best way, and perhaps the only was is with the

Bible

Then look at Japan, a nation of 80,000,000 people. The door there is not only open, but the whole side of the house has fallen in. Their national religion, Shintoism, has been repudiated; and their god, Hirohito, now walks among them as an humbled man. These bewildered people are looking around for something to "latch" on to;

something to have faith in ... and the race is on between Christianity and communism, one speaking peace to the heart; the other crying

peace, peace where there is no peace.

Gen. McArthur, before his dismissal, appealed for 10,000,000 Bibles, a need which the A. B. S. is trying frantically to meet . . . but help is needed —your help. We are spending billions to help democratize Japan when only \$500,000 would help Christianize it.

We can neglect this need and let these people die in their ignor-

ance, but their blood will God require at our hands.

As a proof of good intention the Society asks not that you send your gifts directly to them, but that each church send its gift to the State Baptist Headquarters in Jacksonville marked "for the Ameri-

can Bible Society," and it will be forwarded.

Now I'm persuaded that if this were not a worthy, well investigated organization which does what it promises to do, these good brethren in Jacksonville would not have agreed to forward the offerings. So rest assured every dollar you send will go to help accomplish the purpose for which you sent it.

In 1950 Baptists gave over \$78,000. Next year it should be much more.

SUNDAY SCHOOL REPORT

There are Sunday Schools in each of our churches in the Association, with an enrolment of 4,634. This is an increase of 528 over last year. Twelve churches have participated in Training Courses with 214 awards reported.

Thirteen Daily Vacation Bible Schools reported to the state office with an enrolment of 1,397 and an average attendance of 84.

Four Associational meetings were conducted during the year. Three different persons have acted as Ass'n Supt., Bro. Franklin, Bro. Englemann, and Bro. Davis. The calendar of activities calls for an Associational meeting on Thursday after the third Sunday in each month. A representative of the State office will meet with the Association in December, March, June, and September.

North Central and Eliam (Melrose) Sunday Schools have reached the Standard this year. Also there are eight units standard. Our Association was represented at the State-wide Sunday School Clinic

in Orlando last year and in Tallahassee this year.

REPORT ON CHRISTIAN EDUCATION

As certainly as the command to evangelize is in the Great Commission so certainly is there also the command to teach. The modern day response to that command is our system of Christian schools, colleges and seminaries. Southern Baptists have seen an increased interest in their schools this past year. In all of our institutions of all states there were 54,000 students enrolled last year.

The Cooperative program of Florida Baptists goes to support one institution of higher learning within our state. Stetson University. This institution has for the past year received 18% of all

Cooperative program funds kept in our state.

Our World Mission gifts go to help support of our seminaries for the education of our preachers and other Christian Workers. Two seminaries have been added to our list of institutions in the

past year, bring the total to five:

Southern Baptist, Louisville, Kentucky. Southwestern Baptist, Ft. Worth, Texas. New Orleans Seminary at New Orleans, Louisiana. Golden Gate Seminary at San Francisco, California. Southeastern Seminary at Wake Forest, North Carolina.

These seminaries had enrolled 4,574 students in 1950-51, which is an increase of 284 over the previous year. 2,813 of these were ministerial students and 666 were mission volunteers.

Christian education deserves our hearty support and most sincere prayers.

Religious books, novels, and periodicals are constantly coming from the printing press and are available at our book stores.

Francis Bacon said, "Reading maketh a full man." Christian literature will not only make a man "full", but it will challenge him to stay "full". It is to the Christian what steam pressure is to the engine, what the lever is to mechanics. Christian literature sets in motion and keeps in motion the machinery of Christian experience.

Our Sunday School Board, believing that "people are influenced by what they read", challenges us with periodicals of various types. Among them are the quarterlies and magazines for our Sunday

School and Training Union.

The **HOME LIFE**, "a Christian family magazine", challenges multitudes to devotion and consecration in the Lord's work. The **HOME MISSION** and **THE COMMISSION** keep us informed and inspired by presenting the mission work at home and abroad. However, none of these affect us quite like our own state Baptist papers.

Our own state paper is the **FLORIDA BAPTIST WITNESS**, published weekly by the Florida Baptist Convention. We are informed by the editor's office that the **WITNESS** is now going into 26,400 homes in 494 churches in Florida. This means that only something like 35 per cent of Florida Baptist families receive their state paper. In the Santa Fe River Association, 556 homes in 15 churches receive the paper through either the Budget or the Club plan.

The **WITNESS** should be in every Baptist home in Florida. It will inform, enlist, and inspire our people. We believe that every reader will be a better Baptist and church member, thus rendering a greater service to the Kingdom of God. The **WITNESS** is one agency that seeks to promote every denominational cause, and every church organization. It serves to promote unity and fellowship, and to strengthen our churches in carrying out the program of our Lord.

The most practical and effective method of putting this ministry into the homes of our people is the church budget plan. Include

the Witness in your budget and be an informed church.

HOME MISSION REPORT

In recent years the Convention has added 988,642 square miles of territory to the home mission field and 22,000,000 people.

In the western states, the four western provinces of Cuba, the Canal Zone, Panama, and Alaska there are 75,000,000 people with 25,000,000 of them unchurched.

In 1950 there were 754 missionaries plus 271 student workers for the summer making a total of 1,025. The missionaries reported 32,600 conversions. They made 231,393 religious visits, distributed 87,241 Bibles and portions and 1,130,261 pages of tracts, taught 18,512 classes, conducted 3,958 revivals, opened 598 new missions, and constituted 293 new churches.

In addition to the above accomplishments there were 259 chaplains who reported 6,120 professions of faith, and the evangelistic staff reported 5,989 baptisms in crusades which they personally conducted and a total of 9,922 additions to the churches in those crusades. The radio programs were responsible for many conversions. The number cannot be tabulated.

FOREIGN MISSION REPORT

The Foreign Mission Board has lengthened its cords and strengthened its stakes in all parts of the world during the past year. Funds for Foreign Mission Advance have enabled the Board to establish new stations in almost every country in which it has work, and in four countries in which Southern Baptists have not been represented before. We have never before had as many foreign missionaries on the field as we have now.

Lengthening

The largest number of missionaries ever appointed by the Board in any one year (111) were appointed in 1950, giving a total force of 803 active missionaries. Thirty more have been appointed during

the dirst four months of 1951.

Cour four new mission fields are Ecuador, Peru, Southern Rhockia, and Malaya—placing our missionaries in a total of twenty-eight countries. The other countries are: Arabia, Argentina, Brazil, Chile, China, Colombia, Costa Rica, Gold Coast, Guatemala-Honduras, Hawaii, Israel, Italy, Japan, Jordan, Lebanon, Mexico, Nigeria, Paraguay, Philippine Islands, Spain, Thailand, Uruguay, Venezuela, and Switzerland. (Korea, also, was entered by our missionaries in February, 1950; one of the missionaries forced out by the outbreak, of the war the following June expects to reenter in 1951 to administer relief.)

A total of 15,620 baptisms reported on the foreign field, exclusive of China from which no report came in 1950, lengthen and strengthen

the Baptist influence in those lands.

Strengthening

Two hospitals are under construction in South America where we have never had a hospital before. One of them is being opened in Asuncion, Paraguay, the latter part of 1951; construction began on the other in Barranquilla, Colombia, late in 1950. Our first hospital for medical service among Moslems is located at Ajloun, Jordan. A gift from Anglican missionaries, the hospital will be manned by Baptist personnel in 1951. Medical work has been strengthened all over Nigeria with four hospitals now where only one was maintained for many years.

Strong international theological schools which have been located at strategic points will strengthen our work for years to come. Dr. Josef Nordenhaug's inauguration as first president of the seminary in Switzerland in the fall of 1950 launches that institution into the full stream of European education. Advancing the Argentina seminary to international status assures strong theological leadership for the southern section of Spanish America. Plans for opening a similar institution in Colombia proimse the same service

for the northern section.

Inauguration of agricultural missionary leadership in two mission fields launches a new service which will deepen Baptist influence among people in farming areas. One of the agricultural missionaries is stationed in interior Brazil; the other at a co-operative Hebrew settlement in Israel.

Division of the North Brazil Mission strengthens missionary effort in the equatorial area. The new Equatorial Mission includes the Amazon Valley, far away from Recife, the center for North Brazil Mission work.

The Future of Advance

The Foreign Mission Board's total receipts for 1950 were \$6,014,-

909.49, an advance of \$695,644.45 over the preceding year. Virtually all of the increase came as a result of the allocation to the Foreign Mission Board of all Co-operative Program receipts in excess of \$6,500,000. But in 1951, other commitments of the Co-operative Program make it necessary to change the Co operative Program budget figures to \$7,000,000 before the excess can go wholly for foreign missions. That means Foreign Mission Advance is stopped unless Co-operative Program receipts are higher in 1951 than in 1950.

REPORT ON EVANGELISM

During the Simultaneous Crusade 676 Florida churches baptized 6,688 new converts, 2,688 came by letter, 231 came by statement, making a total of 9,607 additions to our churches. Three associations did not report. In our Association, 18 churches participated with 105 conversions, 49 additions by letter, and 2 by statement, making a total of 156 during the Crusade. The church letters report 338 by baptism, 576 by letter, making a total of 914 during the year. Evangelistically speaking 1951 has been a good year. Also, 1952 can be a climactic year for the Lord.

Florida's program for 1952 is identical with the program of last year. A State-wide Evangelistic Crusade is not being recommended. Instead we are suggesting that there be thirty-seven Associationwide crusades.

The organizational setup remains the same. The Association elects a Chairman of Evangelism and the Regional Missionary acts as Organizer. The committees which functioned during the Crusade

should continue to function.

Plans are under way for the fourth State-wide Evangelistic Conference which is to be held in Jacksonville, January 15-17.

We recommend:

1. That each church have a council on evangelism which shall be composed of the pastor and the heads of the organizations. The function of this council is to plan and promote a program of evangelism a year in advance.

2. That each church conduct two revivals a year, one of which shall be in connection with the simultaneous effort.

ASSOCIATIONAL T. U. REPORT, 1951

Seventeen Training Unions have reported. There are 112 Unions within those. They have a total enrolment of 1522, and an average attendance of 55½. State office total of individual Unions are Adult 26, Young Peoples' 22, Intermediate 25, Juniors 22 and the Primary, Beginner and Nursery units 28. The number of Training Unions requesting awards was 14 with a total of 402 awards. "M" Night was held last December 5 in the First Baptist Church in Gainesville Dec. 5, 1950.

The average attendance at the rallies was 150½, the greatest number other than "M" Night being 163 in the Waldo meeting. We were represented in the District T. U. Convention in Starke by winners in our Better Speakers' and Bible Sword Drill Tournaments.

W. M. U. REPORT

There are sixteen Missionary Societies in the twenty-four churches, reported membership being six hundred sixty-six.

All Executive Board and regular business sessions have been held in conjunction and well attended, as was the methods clinic

held in Micanopy at the beginning of the new year.

Speakers at these meetings were: Miss Regina Sliger, representative of Home Mission Board, at Waldo; delegates to state meeting in Panama City, at Lacrosse; Miss Kathryn Bigham, missionary to China, at Melrose youth rally; and Miss Lila Mae Wynn, student worker in Cuba, and Miss Mary Catherine Adams, missionary to Nigeria, at annual meeting at Eastside, Gainesville.

Five officers and three other members attended the state meeting; and four officers, the Leader's conference in Daytona Beach.

Books were sent to Woman's Library at State Prison; also several boxes to Key West Mission; fifteen boxes valued at \$124.93 to Children's Home; and gifts to Florida girls at W. M. U. Training School.

Food and clothing were given to needy in some communities, five churches reporting directed community missions, two hundred sixty-three women participating. These and others are making continuous definite efforts toward soul winning.

Over one thousand pieces of free literature were distributed. Reported subscriptions to Mission periodicals: Royal Service, one hundred seventy-eight; The Commission, seventy-eight; Home Missions, forty-seven; and the Witness, two hundred ninety-four.

Three churches report Business Women's circles. Mrs. P. L. Geiger, President, presented the Federation at annual meeting and stressed the need for more circles.

There were twenty nine W. M. U. Mission study classes held, three hundred and thirty the largest number of members reported studying in any one quarter. As many others as one hundred sixtyone read a Missionary book in same quarter. There were twelve round tables held.

Two hundred seventy-two tithers were reported, an increase of thirty over last year. Stewardship night was observed by only a few unions.

The work of forty-two auxiliaries, in eleven churches, is under the guidance of Mrs. J. G. Hughes. At the Youth Rally in Melrose four Queens (Melrose) and one Maid (Lacrosse) took part in ceremony as they advanced under the ranking system.

Our quota for Birmingham Headquarters Building Fund, incomplete to the amount of \$24.00 at close of last year, has been paid and oversubscribed by \$18.00.

When you give your money each Sunday in your church-if your church supports the Cooperative Program-you have a part in all of this REGULAR State Mission Work. At the same time, part of your money supports all Southern Baptist mission work to the ends of the earth! (All mission funds should be sent MONTHLY to 218 West Church Street, 206 Florida Baptist Building, Jacksonville 2, Florida.)

Once a year we make an offering for SPECIAL STATE MIS-SIONS. This special offering in the fall is for mission work within the state that is not a part of our Co-operative Program. The Florida Baptist Convention votes each year on the work to be included in

this offering. They also decide how much of the offering will go to each cause. Each year these special objects are different.

Your State Board of Missions has spent \$25,000.00 to aid churches and start new missions during this associational year. We have aided over one hundred ministerial students in getting an education at Stetson University. We have 38 full-time missionaries on the field in Florida.
