MINUTES

OF THE

SESSION ANNUAL THIRD

OF THE

SOUTH FLA., BAPTIST ASSOCIATION,

Held With SHILOH Church, Hillsborough County, commencing on SATURDAY, 20th October, A. D. 1869 .

The Introductory being preached by Eld. J. M. HAYMAN, from 2d Timothy, 2d c., 3d v., -"Thou, therefore, endure hardness as a good soldier of Jesus Christ," took a recess for one hour; after which the delegates came together, and the Association was formed by singing and prayer.

1st. Letters from the Churches were then called for and read; after which, petitionary letters being called for, the fellowing were received, viz :- Newhope, Manatee county; Orange Grove, Orango county ; Midway, Hillsborough county ; Alafia, Hillsborough county; which, being found orthodox in their faith and practice, the right hand of fellowship was extended to their delegates. Also the Church at Lake Harris, Sumpter county, made application for a let2

ter of dismissal, which, being granted, a letter was prepared and handed over to its delegates.

2d. On balloting for regular officers Eld. S. WALDRON was elected

Moderator and E. J. HULL, Clerk.

3d. Invited Ministers of our faith and order to seats with us.

4th. Brethren T. W. WILDER, ALDERMAN CASEY and TURNER were appointed a committee to arrange preaching during this session; Brethren Pylant, Harrell and Jones a committee on finance; Elders W. B. Miller, G. C. Powell and John Futch a committee to arrange business for this body; Elders J. W. Hendry, Pylant and Jones a committee on queries, also on examination of letters; Elders G. C. Powell, A. Wilson and R. N. Pylant committee on publication.

Your committee appointed to arrange preaching during the session beg leave to report: Brother SIMMONS to preach to-morrow (Sabbath) at 11 o'clock, followed by A. WILSON; G. C. POWELL at 2

o'clock, followed by S. Waldron.

Adjourned by prayer, to meet at 9 o'clock Monday morning.

MONDAY MORNING, 4th October.

The Association convened and was opened by singing and prayer. 5th. Ordered, That we again propose correspondence with the Alachua Association by a petitionary letter to be prepared by the Clerk and inserted in the Minutes, and any member of our Association who may be present is hereby authorized to act as our messenger.

6th. Appointed Union Meetings as follows: The first to be held with Orange Grove Church, Orange county, embracing the 5th Sabbath in this month; the second, Midway, Hillsborough county; the third, Alafia, Hillsborough county; the fourth, Newhope, Manatee

county.

7th. The reports of committees on queries and examination of letters, on publication, on nomination, and finance were received and adopted, and will be found marked respectively A. B. C. D. and E.

8th. Resolved, That this Association cannot recognize or tolerate the practice of some churches in restoring excommunicated members over the head of the church which excommunicated the member.—The church which excommunicated, as a general rule, is the only proper tribunal to restore to fellowship.

9th. Whereas, Our country is now rapidly filling up by immigra-

tion, and no doubt among that teeming immigration will be found some calling themselves "Baptist Preachers." Now, whilst we would rejoice at the reception of true and faithful ministering brethren among us, we are admonished by the history of the past to be cautious of "wolves in sheep's clothing," therefore, Resolved, That our Ministers and churches be admonished not to receive any as Baptist Ministers unless they produce their credentials and letters of regular dismission from their respective churches, or give satisfatory reasons for not doing so.

10th. Resolved, That the Clerk superintend the printing and distribution of the Minutes, and that he have Ten Dollars for his ser-

vices

11th. Resolved, 'That the thanks of this Association be tendered to the brethren and friends in this vicinity for their kind hospitality during our stay amongst them.

Adjourned, to meet with Pine Pleasant church, Hillsborough county, near James Alderman's, on Saturday before 3d Sabbath in

November, 1870.
