MINUTES.

FIRST DAY.

OCTOBER 18, 1879.

The Introductory sermon was preached by Elder W. F. Norris, of the Manatee Association, from Mark, vii: 37: "He hath done all things well."

After refreshments, the Association was called to order by the Moderator, Elder S. Walden, and after singing and prayer, letters from the churches were handed in and read.

Petitionary letters were called for, when letters from the following named churches were presented by their delegates, and after the letters were read, the churches were received as members of this body, and the hand of fellowship was given to their delegates by the Moderator, to-wit: Pine Grove church, in Polk county, and Pleasant Hill and Emeus churches in Hernando county.

The Association then proceeded to the election of Moderator and Clerk, which resulted in the re-election of Elder S. Walden, Moderator, and the re-election of Elder J. M. Hayman, Clerk.

The congregations were large, numbering between eight and nine hundred persons, and good behavior was maintained, during the preaching hours especially, and many persons requested prayers for themselves, and seemed to be very much wrought upon.

SECOND ,DAY.

Monday, 9 o'clock A.M.

The Association met pursuant to adjournment, and after singing, prayer was made by Elder J. J. Robertson, after which the roll was called and absentees marked.

Correspondents were called for, when Elders J. W. Hen-

ry, W. F. Norris, J. J. Robertson and A. Wilson, and brethren T. L. Thigpen and Jona Yates, all of the Manatee Association, presented themselves as corresponding messengers and were received as such, and the hand of fellowship was given them by the Moderator.

We advise that all light literature, such as novels, romances, plays, etc., be banished from the houses of the brethren of the Association as pernicious to the morals and spiri'ual welfare of themselves and their children.

Resolved, That we advise Antioch church to set herself in order by disciplining her disorderly members at once.

On motion for a committee to meet with and advise Antioch church, the Moderator appointed the following named brethren as such committee, to-wit: E. G. Wilder, R. M. Wilson, W. M. Groves, J. R. McDonald and J. M. Hayman.

On motion, ordered that the minutes of the Ministers' Convention be published with the minutes of this Association.

On motion, the Moderator returned the thanks of this Association to the church at Turkey Creek and citizens of the community for their kindness to us during this meeting.

The minutes were then read and approved.

THE SOUTH FLORIDA MISSIONARY BAPTIST MINISTERS' CONVENTION.

HILLSBORO COUNTY, FLA., August 29, 1879.

The ministers of various quarters met pursuant to adjournment at the Thonolassassa church.

Elder Alderman Wilson preached the introductory from Exodus,

The former Moderator called the meeting to order.

Enrolled the following ministers' names: Silvester Walden, T. H. Jaudon, J. M. Hayman, J. R. Tatum, L. J. Simmons, R. N. Pylant, J. E. Harralson, from the South Florida Association; Alderman Wilson and J. J. Robinson, from the Manatee Association; R. T. Caddin, from the Midway Association; and B. L. Ray, from Double Branch Church, Hernando county, Fla.

Organized by electing brother S. Walden, President; and brother
J. R. Tatum, Secretary.

Resolved, That this meeting rescind the acts of the former meeting.

The Chair then appointed brothers R. N. Pylant, L. J. Simmons and J. M. Hayman as a committee to arrange business for this meeting.

Invited visiting brethren to seats with us. A great many deacons and laymen accepted.

The chair appointed W. M. Groves, Joseph Casey, and W. Knight to arrange for preaching for this meeting.

Adjourned to meet at 9 o'clock A.M., Saturday. Prayer by brother

Friday evening candlelight preaching by brothers J. J. Robinson

and R. T. Caddin, from 2 Cor., v:20.

SECOND DAY.

SATURDAY, 9 o'clock A.M.

Convention met pursuant to adjournment. Called the roll. The committee appointed to arrange business, presented seven queries, which were received and the committee discharged.

A resolution to take them up in regular order was passed.

1. Question—Is baptism a church or Christian ordinance?

Answer-It is a Christian ordinance.

2. Question-Should our ministers forbear to preach doctrinal sermons when circumstances require it?

Answer-No.

3. Question-Should our churches practice feet-washing?

Answer-No.

A resolution was then passed to suspend the regular order of business and take up the 6th question.

6. Question-Do the Scriptures authorize us to believe in final apostasy ?

Answer-No.

The following three questions were deferred for want of time:

1. Can any number of members be legal without the sanction of the church in official capacity?

2. Should our churches extend the right hand of fellowship to per-

sons received for baptism?

3. Are we authorized by the Scriptures to have more than one order of ministers?

Brother D. Spencer reached the point of meeting Saturday ternoon, and was received from Putnam county, Fla., as a missionary, and preached to a very large and attentive congregation on the following Sabbath, at 10 o'clock A.M., from Matt., xii 31., followed by brother A. Wilson. We believe much good was done.

Evening service by brother J. M. Hayman, from Rev, iii:20, followed by brother Pylant.

The meeting then adjourned to meet on the last fifth Sabbath preceding the last of October at D. 1880, place of meeting to be fixed by

ceding the 1st of October, A.D., 1880, place of meeting to be fixed by the Association. Prayer by brother Simmons.
