

MINUTES.

Antioch Baptist Church,

Suwannee County, Fla., October 18, 1900.

The Suwannee Baptist Association met this day in its twenty-ninth session at the above named church at 10 a.m. It was called to order by the former Moderator, Brother W. S. Hodge.

The Association adjourned until 9 a. m. tomorrow.

At 7 p. m. Rev. A. J. Reamy preached an interesting missionary sermon to an attentive audience from Jonah 3:2.

SECOND DAY-MORNING SESSION.

The Association met pursuant to adjournment at 9 a.m. and was called to order by the Moderator. Song, "Stand Up for Jesus." Moderator read the thirteenth chapter of Corinthians. Prayer by Rev. A. Bond.

The following report was read by the chairman of the Committee on Ministerial Education

Report on Ministerial Education.

We are profoundly impressed with the intellectual deficiency that exists among the clergy of our denomination, in the requisite qualifications of efficiency the emergency demands. The question looms up before us. How shall we stand before our enemies without educated leaders?" How shall we instruct others unless we are first instructed ourselves? The errors so extensively circulated are so readily accepted by men of genius and learning that it requires men who are skilled in the law to counteract their efforts and expose the false and pernicious doctrines they are so industriously teaching among the people. They are building up schools and colleges for the purpose of educating the youth of our country and thereby propagate their false and pernicious doctrines. Shall we sit supinely by under these circumstances; until they have fastened their superstitious errors upon our descendants? or shall we exercise the moral courage necessary to secure the triumph of the church over her enemies?

We are profoundly impressed with the belief that our churches lay hands very often too suddenly upon men for the full work of the ministry without giving due consideration to their qualification for the work of the Gospel ministry.

Report on B. Y. P. U. Work.

To the Brethren of the Suwannee Baptist Association—We your Committee on Baptist Young People's Union Work, be gleave to report as follows: The Baptist Young People's Union of America was organized ten years ago under the leadership of such grand and good men as Doctors Chivers, Chapman, Henson, Mabie and others of our Baptist brethren in all parts of our great country. The Union is designed to train our Baptist young people in heart and mind for church work, such as studying the Scriptures, doing missionary work, and to take an active part in the devotional meetings by leading in prayer, reading, talking and conducting the services.

There are now more than a million Baptist young people in the Unions of the United States and Canada, doing such work, and this is evidence that the object of the organization was founded upon wisdom and the divine sanction of our Heavenly Master.

So far as we know, there is but one Union in our Association. Therefore we earnestly urge upon the pastors and brethren of our Association that they organize B. Y. P. U.'s in their respective churches immediately, and under the guidance of the Holy Spirit educate and train the Baptist young people of our country in the Scriptures and thus fit them for intelligent and active church work.

Woman's Work.

Dear Brethren: We rejoice that we have consecrated women who are willing to leave home, and all that is dear to a woman's heart, and go out in the name of the Lord as cross-bearers to nations who know not the way of salvation. We rejoice that women, in their natural sphere of sympathy and love, are everywhere being organized into missionary societies and consecrating part of their means on the altar of love, in order that they, too, may be cross-bearers. But how long—oh, how long will the mass, by far the large majority of our women, be willing to simply sing about the cross, decorate it with beautiful flowers, or paint it handsomely on canvas to hang on the walls, and not do one thing to tell its meaning to the poor, degraded woman who has never heard its story?"

In our women's missionary societies we have our heart-toheart talks as we study the mission work, and pray for our missionaries, that we cannot have anywhere else.

Country churches have their disadvantages, but when we know of country churches having successful meetings, year after year, we are convinced that all churches can have them.

When once our sisters are willing to give an hour of their time a month, and are willing to plan for the five cents, or a dime, for dues, as we should be, then we can have a society in every church.

While we are here at Antioch, how our minds go back to Antioch of old, the first church that sent out missionaries. In that early church there were some faithful women that took part in the work. The responsibilities are much greater on the women of the present opportunities than they were then.

Dear sisters, the women are doing a great work. Let us be faithful in doing our part.

Dr. Willingham says, "To ask the women for a certain amount is to put it down cash."

Whatever we do for the cause of Christ, we are the ones to receive the greatest blessing.

Last year's report of the State is the following: Women's societies, for foreign missions, \$304.95; for home missions, \$732.98; for state missions, \$324.01. Total, \$1361.94. Children's Bands, for foreign missions, \$17.93; for home missions, \$15.06; for state missions, \$25.02. Total, \$58.01. Grand total, \$1419.95.

The following report was read by Bro G. H. Dorman, from the Committee on

Temperance.

We, your Committee on Temperance, beg leave to make the following as our report

First, we believe that intoxicating liquor is one of the greatest evils of the land. We gather from practical lessons the following, even from the pen of Ingersoll, the "great light of infidelity" and opposer of Christianity. He says intemperance cuts down youth in its vigor, mannood in its strength and age in its veakness. It breaks the father's heart, becaves the doting mother, blights parental hope, and brings down mourning age to the grave. It produces weakness, not strength; sickness, not health; death, not life. It makes wives widows, children orphans, fathers fiends and all of them paupers and beggars. It covers the land with idleness, misery and crime. It fills jails, supplies almshouses and demands asylums. It fosters quarrels and cherishes riots. It crowds penitentiaries and furnishes victims to the scaffold.

Oh! if Christians, those who are born of God, would do as they are commanded to do. "Touch not, taste not, handle not the unclean thing," what an influence it would have upon those under the fostering care of a religious faith. The great burden of taxation to run the courts of our country would be lightened and the money thus expended could be used to send the Gospel of a bleeding Savior to dying people in foreign lands. Our sons and daughters, in place of bringing gray hars down in sorrow to the grave, would be shining lights and better prepared to enter into that rest that remains for the people of God.

Brethren, those who profess to be lovers of the Lord, there is very little good accomplished to meet once a year and write up reports, pay a clerk ten dollars, a printer twenty dollars and get our work in minute form, carry them home and lay them away merely as reference for the next Association.

For Heaven's sake, let us pray the Lord to help us get aroused from our lethargy and put our words into action and put down the mighty demon. Respectfully submitted.

Report on Missions.

The church of Christ is a missionary organization. Christ, its head, was a missionary. He was "sent of the Father." Christ's apostles were all missionaries, sent forth by their Master. Every true minister of the Gospel is a missionary. There can be no exceptions. "As my Father hath sent me, even so send I you," said Christ. As Christ was a missionary, so also are those who go forth at His command missionaries. The true minister of Christ who leaves home and native land to teach the Gospel to the benighted heathen, is a missionary. None the less is the pastor who remains at none a missionary, and, moreover, Christ's language quoted above constitutes every true Christian a missionary. His very discipleship depends on his possessing the spirit of Christ, which is a missionary spirit. To claim to be a Christian, and not be a missionary, is a contradiction. The church is composed of elements: its Head, its ministers and its individual members possess the missionary spirit. The churches of Christ are therefore missionary organizations. They were organized for missionary purposes. Christ laid upon them the duty to disciple all nations. The special business of the churches is to make known the Gospel "to every creature." The one great enterprise which should command all our resources is the evangelization of the nations. Without the missionary spirit and missionary labor, a church is nothing, as utterly worthless as the salt that has lost its savor, or the light that has been put under a bed. Whatever be the attainments in other respects, if a church fails in her missionary character, she fails virtually and utterly. CONSTITUTION.

Section 1. This Association shall be known as the Suwannee Baptist Association.

- Sec. 2. This Association shall be composed of messengers elected by the several churches connected with the Association, each church being entitled to two messengers, and one additional messenger for every twenty-five members, or fractional part thereof, over fifty, and such members shall be received by the Association.
- Sec. 3. This Association shall, at their annual meeting, elect from their members, by ballot, a Moderator, Clerk and Treasurer, who shall serve for one year.
- Sec. 4. The object of this Association shall be: First, to promote unity and brotherly love among the churches. Second, to promote Gospel discipline. Third, to encourage the universal spread of the Gospel and practical religion throughout our bounds and elsewhere.
- Sec. 4. A Missionary Committee shall be appointed by the Moderator at each annual meeting of the body, subject to the approval of the Association, whose duty it shall be to diligently inquire into the destitution within our bounds, make contracts with ministers of this Association, or other associations in correspondence with this, for ministerial labors to supply these destitutions, and report the result of their labors for the approval of the Association.
- Sec. 6. This Association shall invite correspondents and visiting brethren to seats when in session, who shall be entitled to the privilege of aiding the Association with their counsels; and this Association may also withdraw from any church that may be in disorder, when the same cannot be restored.
- Sec. 7. The annual meeting of this Association shall begin on Thursday before the third Sunday in October, and by appointment there shall be an Introductory Sermon preached the first day, and on the Sabbath a collection taken up for missionary purposes
- Sec. 8. This Association shall not lord it over God's heritage nor infringe upon any of the internal rights of the churches, but shall only act as an advisory body.
- Sec. 9. This Constitution may be amended only by a twothirds vote of the messengers present, provided the amendment be reduced to writing.

ARTICLES OF FAITH.

- We believe in one only true and living God, the Father.
 Son and Holy Ghost, and that these three are one.
- We believe that the Old and New Testament Scriptures are Word of God, and the only rules of faith and practice.
- We believe in election, according to the foreknowledge of God, through sanctification of the spirit and belief of the truth.
- 4. We believe that the grace of God that bringeth salvation hath appeared unto all men, and that nothing prevents the salvation of the vilest sinner on earth but his own voluntary rejection of that grace.
- 5. We believe in the total depravity of the human heart, and that the natural state of man is such that he cannot prepare himself for divine favor without the assisting grace of God, enabling him to act according to the good pleasure of His divine will.
- We believe in justification by faith, which gives peace with God, through our Lord Jesus Christ.
- We believe that the Gospel of Christ is a means of divine appointment, to bring sinners to repentance and faith in Jesus Christ, and therefore should be preached to all.
- 8. We believe that all those who are regenerated by the Spirit of God are made heirs of God and joint heirs with our Lord and Savior Jesus Christ, and that they are kept by the power of God through faith unto eternal salvation, and that not one of them will be lost.
- 9. We believe that baptism is the immersion of the whole body in water; that the only proper subjects are described in the preceding article, and the only proper administrators are those who have been regularly ordained by a church of Christ by the imposition of hands of a presbytery.
- 10. We believe that the Lord's Supper was instituted by our Lord Jesus Christ, to be commemorated by His followers, and that none but baptized believers have a spiritual right to partake thereof.
- 11. We believe that the washing of feet, according to the example recorded in the thirteenth chapter of John's Gospel, is a duty enjoined by the Lord Jesus Christ upon His followers, and should be observed immediately after the Lord's Supper, but in no case shall this acticle be so construed as to make it a test of fellowship.
- 12. We believe in a general resurrection of the righteous and the wicked, and that the wicked shall go away into everlasting punishment, and the righteous into life eternal.
- We believe that infants and idiots are saved through the merits of our Lord Jesus Christ.

STATISTICAL TABLE

RULES OF DECORUM.

- Article 1. At the first meeting of each annual session of the Association, the Moderator of the previous session shall call the messengers to order, and, after singing and prayer, he shall declare the Association ready for business; the first item being the election of a Moderator and Clerk, after messengers have enrolled their names. In case of absence of the Moderator, the messengers present shall elect a Moderator pro tem., who shall proceed as aforesaid.
- Art. 2. Each meeting of the Association shall be opened and closed with singing and prayer
- Art. 3. The Moderator shall preserve order and decide all questions in debate, subject to an appeal to the body, and when speaking on any subject, shall call some member to the chair, and in case of a tie may give the casting vote.
- Art. 4. All committees shall be appointed by the Moderator subject to a vote of the body.
- Art. 5. The Clerk shall keep a careful record of the proceedings of each meeting and in the absence of the Moderator, shall call the Association to order and preside until a Moderator pro tem. is elected.
- Art. 6. No business shall be transacted without a quorum, who shall consist of a majority of the registered members.
- Art. 7. All members wishing to speak shall arise and respectfully address the Moderator, confining themselves strictly to the subjest, and no unkind allusions shall be made while speaking.
- Art. 8. No motion shall be debated until seconded, nor voted upon until stated by the Moderator or read by the Clerk.
- Art. 9. When a question is under debate, no motion shall be received, except to adjourn, lay on the table, to amend, indefinitely postpone, refer to a committee, or otherwise, call for the previous question.
- Art. 10. Any member voting in the majority may move a reconsideration at any time during the session.
- Art. 11. The rules of decorum may be amended at any an nual session of the Association by a majority vote of the members present.
