CONSTITUTION

1. This Body shall be known as the Alachua Baptist Association of Florida.

2. It shall be composed of messengers from Southern Baptist Churches of the same faith and gospel order, voluntarily banded together for missionary, educational and benevolent service.

3. The officers of this Association shall be Moderator, Vice-Moderator, Clerk, and Treasurer. The Moderator and Vice-Moderator shall be nominated from the floor and elected by ballot, and by a majority vote, on the first day of the Annual Meeting; but the Association may, by a unanimous vote, instruct the Clerk to cast the ballot of the body as a whole. Officers elected shall assume office at the close of the Annual Session which elects them. No person elected Moderator shall hold office for a longer period than two consecutive years, not counting an unexpired term. The Association in annual session, shall elect or approve all departmental heads for the ensuing year.

4. Each Church shall be entitled to two messengers, and shall be entitled to one additional messenger to every twenty-five additional members over the first fifty, provided no church may have more than ten messengers. These duly elected messengers who are present shall constitute the Association in annual session.

5. The Executive Committee of this Association shall be composed of the following: the Moderator, Vice-Moderator, Clerk, Treasurer, Superintendent of the Associational Sunday School, Director of the Associational Training Union, President of the Associational Woman's Missionary Union, President of the Associational Brotherhood, Director of the Associational Music Department, the President of the Youth Organization, together with all pastors who hold membership within the Association and one other member from each cooperating Church.

6. This Association shall meet annually at such time and place as may be agreed upon by the Body. When necessary, the time and/or place of any meeting may be set or changed by the Executive Committee.

7. The Association shall recognize the independence of Churches and shall not in any wise seek to exercise jurisdiction over them, yet shall have power to drop from its connection any Church found to be unorthodox in faith or practice.

8. Churches may be admitted into this Body by petitionary letter provided they shall have been found orthodox and of a cooperative spirit. Each Church, before being admitted, must make application through the Moderator or the Executive Committee at least three months before the annual or semi-annual Associational meeting, provided however, that the Association may waive the three months period by three-fourths vote of the members present. The Church making petition shall set forth in writing their doctrinal belief and willingness to conform to the rules and regulations by which the Association is governed. Upon reception, the Moderator shall, for the Association extend to the messengers the hand of fellowship.

9. Any Church shall be at liberty to discontinue its connection with the Association if desired, by giving proper notice of such intention. If any Church fails to be represented in annual meetings for three years in succession, it may be dropped from active membership.

10. The Association in annual or semi-annual session, may alter or amend this constitution by a three-fourth vote of members present and voting.

BY-LAWS

1. All sessions of this Body shall be opened and closed reverently in duly approved form,

2. The Moderator shall preside over the deliberations of this Association, keep order, present for discussion and vote all motions properly ordered, and perform all other duties usually appertaining to this office. He shall not vote except in the case of a tie. The Vice-Moderator shall preside in the absence of the Moderator or when asked by the Moderator to preside.

3. Robert's Rules of Order shall be recognized as authority in all matters of parliamentary procedure.

4. It shall be the duty of the Clerk of the Association to keep a fair and correct record of the proceedings, prepare the manuscript for the press, have

minutes printed, and distribute them to the churches as early as possible after the annual meetings and shall keep a complete file of minutes for use of the Association.

5. The Treasurer, who also may be Clerk, shall keep an accurate record of all moneys received and disbursed, shall pay out money only upon instruction from the Body and shall make an itemized report of all receipts and disbursements to the Association in annual session. If requested, the Treasurer shall make a monthly statement to the Executive Committee.

6. The Executive Committee, which is the Association ad interim, shall have general supervision of all work initiated and fostered by the Association. It shall meet monthly to plan for the promotion of all phases of the work, the time and place of meeting to be set by the Executive Committee. It shall use its best efforts to stimulate the spirituality and activities of the Churches and shall report its work to the Association in annual session.

7. The Vice-Moderator shall be program Chairman for all Annual Sessions of the Association. Upon a vacancy occurring in the office of Moderator, the Vice-Moderator shall assume all duties of the Moderator. The Executive Committee shall then select another person to be the Vice-Moderator. It shall also select persons for any other vacancies that may arise.

8. The Clerk, Treasurer, Visual-Aids Librarian, Music Director, Historian, Chairman of Evangelism, the Missions Committee and the Trustees of the Assembly Grounds will be nominated by a committee appointed by the Moderator.

9. These By-Laws may be altered or amended by a two-thirds vote of the Body in annual session.

All of us say we need revival, new vitality and something that will get us out of our present predicament. God supplies this need by Conversion. The Old Testament is the story of God's attempts to get man to turn from self to Him. So is the New Testament a story of God's great provision of Salvation so that man can turn from sin to God.

- I. WHY BE CONVERTED?
 - a. Jesus said it was necessary. John 3:3-10.
 - b. To be what God wants him to be, A NEW Creature.

BAPTIST HOSPITALS

BY BERT DAVIDSON AND C. E. COLB

We believe there is a difference in hospitals, and the great number of patients who come to places where the Lord Jesus Christ is honored recognize true and permanent values. Our two Southern Baptist hospitals, and all others carrying the Baptist name, maintain a spiritual program on an equality with physical procedures. Pastors and Chaplains are authorized and welcome, not just tolerated. Nurses on duty are cooperative when a Pastor wishes to visit a patient. In a hospital room it is the expected thing to do when the scripture is read or quoted and when prayer is spoken. Responses of a spiritual nature are frequently made in all sincerity by the patient. Pastors of all denominations are at greater liberty when ministering in Baptist hospitals than in certain others. There is a difference in hospitals.

Thousands of Sunday School Board tracts, copies of Home Life and other of our publications are being distributed to all patients without fear of objection by administrators or antagonists of our Christian faith. Many of these printings are being taken home by patient or family. In some of our hospitals literature of other denominations is not permitted on public display, the emphasis being strictly Baptist. Thanks be to God for establishing many hospital outlets for Christ's testimony. There is a difference in hospitals.

SOUTH FLORIDA BAPTIST HOSPITAL

We provided 25,934 days of patient care, performed 1,346 surgical operations and we had 896 newborns.

The hospital had a total income of \$1,127,651.00. Of this amount we had net donations of \$37,119.00. We provided free care in an amount of \$66,180.00. This amount for free care represents an increase of \$21,600.00 over the previous year. We had capital expense of \$33,813.00.

Often many people question the need of a donation to a voluntary hospital which is not tax supported. We wish to cite our experience on a patient day basis.

The financial figures immediately above are not figured in patient day cost. Subtract gross patient profit from the other patient day expense and we arrive at a deficit of \$1.69 per patient day. In as much as the average length of stay was 5 days; the deficit amounts to \$8.45 for each patient admitted to the hospital.

Functional Changes

- 1. We have closed in what were screen porches and added a few beds.
- 2. Provided television for patients.
- 3. Air conditioning system increased in patient room areas.
- 4. Salary standards increased.

5. Hospital surveyed and accreditation renewed for three years.

We are now in the infancy of Medicare and we anticipate a minimum wage law to become effective February 1, 1967. Presently we do not know just how much these things will affect our hospital.

Since the financial structure of our hospital has not been critical in recent years our contributions have fallen off. Remembering the free work and capital gains mentioned previously, as compared to the net amount received from contributions it is very obvious we continue to need financial support.

The Great Physician has been merciful to our hospital. Many people continue to pray for our ministry of healing. For all of this we are thankful.

TRAINING UNION

We had 5 associational meetings during the year with "M" Night being our largest meeting. We set a goal of 400 and there were 332 present, with 18 Pastors and 14 Directors. UNITED CHRISTIAN ACTION

Materially, Florida is growing; Spiritually, a sin-sickness of epidemic proportions destroys more victims every day. While our churches grow, we are failing to be the power for Christ_that we should.

1. Over 100,000,000 gallons of beer, wine and wiskey will be consumed this year. Cost: \$550,000,000. Results: 275,000 alcoholics, plus 500,000 "problem drinkers" plus 900,000 social drinkers," crime, suicide, illegitimacy, divorce, are at an all time high.

2. Danger ahead. The 1965 and 1966 State Legislature passed more progambling measures than at any other period of time in the state's history. These were approved by Governor Burns. More than 350 additional days were granted dog, horse, and Jai-Alai gambling tracks, with one new Jai-Alai Fronton being approved this year.

3. Obscenity and pornographic depravity continues to spread pollution and misery.

Some encouraging signs: Spiritual resources unlimited. Our churches are a slumbering giant with tremendous power capable of turning the tide for good. "Wherefore he saith, awake thou that sleepest, and arise from the dead, and Christ shall give thee light. See then that ye walk circumspectly, not as fools, but as wise, redceming the time, because the days are evil." Ephesians 5:14-16.

A righteous indignation will lead to an explosion of holy wrath. We can do the following NOW:

1. Tell those that are in authority you want action now to:

a. Remove all beer, wine and wiskey licenses from all grocery stores drug stores, filling stations, and retail shopping outlets.

b. Eliminate all advertising of all alcoholic, gambling, and obscenity products.

c. Éliminate gambling.

d. Eliminate the spreading of pornographic literature.

2. Let people know where you and your church stand on moral issues.

3. Use voting power, purchasing power and example to stamp out evil.

FIELD SECRETARY FOR DISTRICT SEVEN

BY CLYDE HARLESS

District No. Seven of the Florida Baptist Convention is made up of all the Southern Baptist Churches in Lake County, Marion and Alachua Associations. While working with these Churches this past year I traveled 33,227 miles, delivered 203 Sermons and Addresses and made 21 Mission visit and 336 Church visits. I have conducted 29 prayer meetings, assisted in 6 Ordaination services, preached in 2 Revival meetings and assisted in one School of Missions. During the past year I made 84 Soul winning visits resulting in 28 professions of Faith, 29 additions to the Churches where I have preached (by Baptism) and 24 transferred their Church membership, making a total of 52 additions. I have Baptized 3 this year into a Church that was without a Pastor. I distributed 3,100 tracts, 430 Bibles and portions of Bibles this past year. I have held 135 conferences with groups or Committees and 1,254 with Individuals making a total of 1,387 conferences. I have made 16 surveys, We now have 5 Churches in District 7 sponsoring missions.

Track Racks and Home Life Magazines have been placed in The Munroe Memorial Hospital in Ocala at the Invitation of the Administrator, Mr. Wilson. I plan to place other racks in Hospitals in District seven this year.

Several boxes of Clothing, Health Kits and New Testaments have been distributed to the Migrant workers in Lake County. I plan to increase the work among the Migrants this year. I have mailed out around 5,000 Newsletters and pieces of literature this past year.

Please feel free to call on me when I am needed.

STETSON UNIVERSITY

The total operating budget of Stetson University this year is estimated at \$3,750,000. This represents an increase of \$156,000 over last year's operating expenses. The Florida Baptist Convention was again the major contributor to our operating budget with gifts designated for this use totaling \$298,327.05. In addition, gifts totaling \$70,079.79 were received from Florida Baptist churches as a part of the Christian Education Campaign. Total contributions from 112 Baptist churches in the state during the three-year Christian Education Campaign drive was \$163,848.74. The contributions of these churches toward the advancement of Christian Education is greatly appreciated by Stetson University and the Baptist Bible Institute, who shared in the proceeds from the campaign.

The enrollment on Stetson's DeLand campus this fall is 1,764. With the exception of the post-war years of 1947-48, this is the largest enrollment in the history of the University. The enrollment in Stetson's College of Law in St. Petersburg is 304 for the fall semester. This, too, is a new high. The total enrollment in Stetson's four schools (Liberal Arts, Business Administration, Law and Music) is 2,068.

Baptist students comprise one-third of the Stetson enrollment, and these Baptist students receive one-half of the total financial aid available to students at the University. The increased enrollment at Stetson University is being matched by improved and enlarged plant facilities. Construction has been completed on the new School of Business Administration building, and work is nearing completion on the first wing of a new Science building and residence hall for men. Planning is well under way for the construction of a new School of Music building and a new gymnasium. Construction is already under way in St. Petersburg on new administration and classroom buildings at the Coilege of Law.

ANNUITY BOARD Of the Southern Baptist Convention By Glynn Hickerson

The Southern Baptist Protection Plan

For the first time in two years, all ministers who are not enrolled in the Southern Baptist Protection Plan are being informed about its benefits. A direct mail campaign has been conducted to give ample information to prospective ministers in each state convertion.

The Southern Baptist Protection Plan provides benefits for age, disability and widow. Cost for the protection is based on the minister's salary, and is 10 per cent of any amount up to \$4,000 a year. The minister's church is encouraged to pay the total cost. In some cases the minister and church share the cost. The maximum amount a church can pay in the basic plan is \$400 a year if its minister is under 60 years of age.

The Health Benefit Plan

Enrollment has reached 10,054 in the Health Benefit Plan. During the past year, promotional emphasis has been placed on this plan.

The Health Plan is an all-inclusive program of hospital, surgical and major medical benefits. Enrollment is open on a semi-annual basis. The next enrollment will be open early in the fall with the deadline on November 30, 1966.

Benefits Paid

In 1965, almost \$4 million was paid in age retirement, disability or widow benefits to annuitants through the Annuity Board's protection program. The annuitants' checks vary in amounts, depending on the length of time each was a member and the amount of dues he paid.

Since the beginning of the Annuity Board in 1918, almost \$51 million has been paid out in benefits which annuitants have termed "manna from heaven."

Members In Annuity Board Plans

Today more than 16,660 churches are providing protection through the Protection Program for their ministers. Approximately 10,764 of these churches are paying the 10 per cent dues.

There are 135 of the 176 educational institutions, hospitals, children's homes, homes for the aged and other Convention agencies who have protection programs with the Annuity Board. There are more than 28,000 members in the retirement plans of the Annuity Board.

There are seven states with 70 percent or more of the churches in the Program. At the present time Florida has 65 percent of the churches in the Protection Program for ministers.

Rev. Phil Maxwell promotes the Protection Program in Florida. He is jointly employed by the Annuity Board and Florida Baptist Convention. Christian Literature and The Florida Baptist Witness

By J. E. McGraw

Long recognized for excellence in both the content and appearance of their literature, Southern Baptists have during the past year continued to improve and extend its production and circulation. The publications provide assistance in Bible study, guidance in daily Christian living, and helps for organizing and developing stronger churches.

During the last convention year the Sunday School Board of the Southern Baptist Convention prepared, published and distributed a tremendous total of 106,860,315 copies of more than 100 different periodicals to users in 50 states and numbers of foreign countries. In addition to this literature, there were published 3,128,774 special and supplementary study items, 635,648 copies of 57 new books and 474,732 reprints of 122 old books, 1,297,937 copies of 32 new study books and 2,859,399 reprints of 105 old ones, plus 72,146,308 church bulletins and inserts.

All of the other boards, agencies and auxiliaries of the Southern Baptist Convention also produce and distribute their own specialized publications, such as the Foreign Mission Board's COMMISSION magazine, the Home Mission Board's HOME MISSIONS, the Radio and Television Commission's THE BEAM, Woman's Missionary Union's ROYAL SERVICE, Brotherhood Commission's BROTHERHOOD JOURNAL, etc.

The Baptist state papers, now numbering 28, reported to the Convention in Detroit a total combined circulation of 1,540,260, a 19,801 increase over 1965.

The FLORIDA BAPTIST WITNESS, our own state paper, has experienced a small but steady increase to reach a circulation of 67,662 as of August 1, 1966, up 2,289 over a year ago. Nine hundred twenty-seven churches are now using one or the other of the group subscription plans (764 with budget lists and 163 with clubs) to provide the BAPTIST WITNESS to at least a part of their members. An increasing number of churches send the paper to every resident family.

In order to meet the latest postal requirements for mailing the paper in Zip code sequence, the WITNESS last year had to go to a new type of addressing service. The difficulties attending such a change have been trying at times, and we want to express our appreciation to the churches for their patience and understanding during these long months of adjustment.

The FLORIDA BAPTIST WITNESS is still the best bargain we know costing the churches which take advantage of the budget plan only \$1.25 per year per subscription — 50 issues of a 16-page news magazine at only $2\frac{1}{2}$ cents a copy. And this cost may be billed to the church for convenient monthly payment.

In cases where for some reason it cannot meet the minimum requirement for the budget rate (a number of subscribers equal to at least 10% of its reported membership) a church may order 10 or more papers at the club rate of \$1.50 per year each.

The WITNESS earnestly solicits the full cooperation of the churches in meeting the necessary minimum requirements in ordering subscriptions at either the budget or the club rate, and also including the Zip code with each mailing address.

We would urge every church which now sends the BAPTIST WITNESS into only part of its homes to promptly and prayerfully consider *completing* its subscription list by including *every resident family* on its order, and every church which does not now have the WITNESS in its budget to consider including it in the new budget.

REPORT ON CHRISTIAN EDUCATION

Southern Baptist involvement in Christian education grows each year. In spite of growing difficulties in the areas of finance and faculty recruitment, our ministry in this area still expands. Southern Baptists now operate 39 senior colleges, 15 junior colleges, 7 academies, 5 Bible schools, 6 seminaries, and the American Baptist Theological Seminary, supported jointly with the National Baptist Convention, U. S. A., Inc.

Enrollment in Baptist schools reached an all-time high for 1965-66 of 96,670 compared to 90,510 in 1964-65. These 73 schools graduated 12,205 last year. Total convention gifts (state and SBC) to these schools amounted to \$17,-812,129, an increase of \$922,880 over the previous year. Of this amount, \$5,460,864 went for capital needs and the remainder for operations. In addition, the schools received \$18,362,645 in other gifts, grants, and donations. Total assets are \$501,648,878, of which \$129,570,363 is for endowment.

Especially gratifying is the report that this past year saw an increase of 232 ministerial students in senior and junior colleges. The following represent the total students in training for church-related vocations in all Southern Baptist schools;

The Education Commission of the Southern Baptist Convention and its executive secretary-treasurer, Rabun L. Brantley, continue to offer leadership in the following areas:

- (1) A program of Christian education leadership and coordination
- (2) A program of school and college studies and surveys
- (3) A program of teacher recruitment and placement
- (4) A program of assistance in college recruitment

The Commission publishes "The Southern Baptist Educator" and "College and Career," a paper for young people, to be used in youth conferences, summer assemblies, etc.

The most extensive effort yet made by the Commission is its two-year study, BEST (Baptist Education Study Task). It began in the summer of 1965 and will continue into the summer of 1967. Twenty-four seminars of 20 persons each are meeting three times in 1966 and three times in 1967. Two national conferences are being held. The first was in Nashville, June 13-16, 1966. The second will be June 12-15, 1967. Background papers in seven basic areas have been prepared for the seminars and conferences. Several thousand people will express their views in these areas. The committee will seek to make helpful suggestions for the future of Baptist schools.

Florida Baptists are involved in Christian education through Baptist Bible Institute, Stetson University, and the proposed junior college at West Palm Beach.

Baptist Bible Institute, led by President James E. Southerland, renders a significant service training preachers who are called to the ministry later in life or who for some reason have not been able to secure a college education. Enrollment increased this past year to 268, an increase of 30 over the previous years and the highest ever. A highly trained and dedicated faculty serves at the Graceville insti-

tution, and the influence of the school is felt not only in Florida but in Alabama, Georgia, and other states where our students and graduates serve churches.

Stetson University and President J. Ollie Edmunds continue to seek to serve the denomination and to seek Baptist students. Enrollment during the past year on the DeLand campus was 1,753 and 280 on the College of Law campus in St. Petersburg.

On page 94 of the 1965 Florida Baptist Annual under the heading, "Increased Grants-in-Aid to Baptist Students," will be found the following:

"Baptist students at Stetson have been assured of over \$130,000 in financial assistance from the University during the current year. In addition to these grants, our Baptist students will also receive \$75,000 in long-term repayment loans, making a total of \$205,000 in assistance. Every Baptist applicant requesting financial aid has received it according to his need, and 85 per cent of all Baptist applicants for enrollment were admitted. Over 60 per cent of these new Baptist students are receiving some sort of direct financial assistance. Parents of some of our Baptist students were unable to help their children even with books and personal expense money. These students were given summer employment on our campus, so that they could earn enough money to meet these expenses."

Florida Baptists must make a careful appraisal of their intentions regarding Christian education in the future. It is imperative that our youth be given the best opportunities that we can provide for their education. At the November meeting of the Convention in Pensacola there will no doubt be much discussion concerning the two institutions we now support and the proposed new junior college. Let us pray that God will give us insight and courage to meet the challenge of our day.

BAPTIST BIBLE INSTITUTE BY RICHARD WOMACK

A typical Baptist Bible Institute student would be about 32, married, with three children. Many have been deacons, and more than half now are high school graduates. They usually leave established businesses and trades when they enter the ministry and enroll with us.

For such mature students we have a highly trained, experienced faculty (for the first time in years we have faced the fall semester with all faculty positions filled). The classes parallel those in our SBC seminaries which lead to degree work, except we do not offer Hebrew and Greek. Chapel services and Field Guidance classes, usually led by visiting state and SBC leaders, combine with classroom atmosphere to produce informed and loyal leaders.

To graduate, a student must pass 98 semester hours of work, usually taking him three years. Choices include special emphasis in pastoral training, religious education, or sacred music. Quite a few graduates look around for further studycertain Baptist Colleges allow two years credit for Institute work.

BUDGET: Our 1966 budget was for \$277,354.00, with \$160,181.19 provided through the Florida Baptist Convention Cooperative Program. Churches and individuals gave \$33,429.41 which was \$3,631.97 more than they did the previous year. Other income was from rentals, tuition fees, book sales, et cetera. These figures deal only with budget operation-do not confuse them with the Christian Education Campaign report, which follows.

Christian Education Campaign

Baptist Bible Institute received 25% of all undesignated gifts to the Christian Education Campaign, which officially closed June 1, 1966. This is apart from Cooperative Program funds, representing new money from churches and individuals. Stetson received 75%, and 25% went to Baptist Bible Institute. Through July 31, 1966, we have received \$29,984.13 from this campaign. Our share of expenses was \$1,349.89, leaving us a net gain of \$26,598.24. This is new money and does not include Cooperative Program money for budget needs.

Current Needs

We still need a library building, a cafetorium, and student housing (both dormitory and apartments). An older school would have had these, but we are still growing. Realizing this urgent need, our Trustees are asking that a sufficient and specific amount be placed in the 1966-67 Cooperative Program budget to build a library and cafetorium.

Student Loan Fund

There are several student loan funds available to students who show need.

Conclusion

Those of us who work for you at Baptist Bible Institute, specializing in a field of Christian education which other Baptist schools barely touch, constantly work to maintain the highest standards. Visitors have noted that we are beginning to achieve the dreams of our founders. Because of our excellent faculty, and the depth of our curriculum, more and more students come to us from many states.

Nearly every graduate finds a place of service to his satisfaction, often before graduation.

WE THANK YOU, from the bottom of our hearts, for your continued love and support. As far as we are able, we promise to merit your continuing cooperation. We are working with you as fellow-laborers for the King.

Southern - Louisville, Kentucky

Enrollment at Southern Seminary increased for the fourth consecutive year, contrary to the nation-wide trend. Whereas, with some exceptions, enrollment of ministerial students in Baptist colleges continues to decline, there is some evidence that the supply of ministerial students at the seminary level is stabilizing. One effect of the increasing number of ministerial volunteers in non-Baptist colleges is the change in curriculum and relationship to the main stream of academic life brought about within the seminary. Dramatic changes in theology curriculum have been adopted, providing for greater specialization, newest teaching methods, and interdepartmental courses, which will help meet the challenge of increasing demands being made upon the Baptist minister today. The housing situation is improving, with three sections of the single student dormitory renovated and in use and the

section for single women students to open for the fall term. This renovation has depleted the capital needs budget through 1968, and without increased funds from the Cooperative Program, there will be deficit spending for an indefinite time. At present, the Cooperative Program does not pay for all the academic expenses incurred in training leadership for the churches.

Southwestern — Fort Worth, Texas

Students at Southwestern Seminary came from campuses representing 40 states and 14 foreign countries, with 576 students who enrolled for the first time. New courses added to the curriculum during the year included Ugaritic, new courses in understanding and working with the "exceptional child," studies in programmed instruction, and curriculum writing. Barnard Hall, a residence hall for women, was completely remodeled, renovated, refurnished, and air-conditioned. Carroll Park Apartments, with 184 apartment units, were purchased during the year. Projected for the immediate future are the remodeling of Fort Worth Hall and the ground floor of the Memorial Building and the construction of a Children's Building and a Health Center and Clinic. Special activities for the year included the annual Church Music Workshop that enrolled 400 musicians, the annual college student missions conference which registered over 1,600, a church architecture conference, a church drama clinic, a chaplains' conference, and other special programs.

New Orleans — New Orleans, Louisiana

New Orleans Seminary will begin its 50th year with the 1966-67 session. A second year of major campus renovations is now being planned from a threeyear \$1,600,000 Cooperative Program allocation. Major campus drainage systems, repairs to buildings, replaced plumbing, and waterproofing were parts of the first-year repairs. Building deteriorations will be a major renovation expenditure during 1967. The Schools of Theology, Religious Education, and Church Music were accredited by the Southern Association of Colleges and Schools during the past year, which is in addition to long-time accreditation by the American Association of Theological Schools. A New Orleans Baptist Seminary Foundation was chartered and approved by the SBC executive committee during the past year, the first goal being to secure \$1 million for a permanent fund to provide student church work and missions scholarships, faculty salary increases, and to finance theological research. Repairs are still being made almost a year after Hurricane Betsy caused major damage to the seminary campus.

Golden Gate — Mill Valley, California

Golden Gate Seminary completed its 18th commencement exercises this year. The library improvement program continues to be a central task. The Cooperative Program has provided the seminary with a campus development worth over \$10 million. Twenty-four new apartments have been added during the past 18 months, bringing the total to 110. Secular work remains plentiful and mission opportunities overwhelming. A new emphasis on the urban task should make all who work and study in this area more effective in their Christian witness. The faculty has completed an intensive and revealing study of the factors confronting Christianity in the population shift to urban centers. Six teams have worked for two years to determine the most effective way to present Christ to a lost and needy world. The seminary is centered in the largest mission field in North America; more than twothirds of the population claim no god nor any church relationship. There were six students from Florida this year.

Southeastern — Wake Forest, North Carolina

The primary purpose of Southeastern Seminary is to guide the intellectual and spiritual growth of qualified students for Christian service in pastoral educational, and missionary ministries. It provides opportunities for study, worship, and work in a community of faith and of learning. The dormitory for girls, recently completed and occupied, was dedicated at the annual meeting of the Board of Trustees. The natural beauty of the campus has been enhanced by the planting of boxwoods, roses, and azaleas. The extensive planting of shrubbery was made possible by a generous gift designated for this purpose. The recent location of large industrial plants in the vicinity of Wake Forest has increased remunerative jobs for wives of students under favorable conditions. The faculty, staff, and students are committed to the Christian faith, appreciate the resources of the library, participate in scholarly work, and are vitally related to the churches.

Midwestern — Kansas City, Missouri

The relationship of Midwestern Seminary with the church and denominational leadership of the midwest area leaves little to be desired. The faculty and students are being widely used in every way. The 48 married student apartments have been completed and are beautiful, functional, and up-to-date. Many more could readily be used, if resources were available for building them. A considerable number of graduates are continuing to respond to the call of mission service at home and abroad. Scores are founding and serving new churches in pioneer areas of our land. The faculty continues to volunteer its services in one or two-day Continuing Theological Education Seminars in various population centers of the midwestern area. These are increasingly popular with pastors near and far, as is the night school certificate work for lay leaders in the churches, student wives, and others. Additional aid and loan funds, wisely managed, are needed to do the greatest good for the greatest number. The fourfold emphasis at the seminary continues to be devout scholarship, worldwide missions, warmhearted evangelism, and a keen social consciousness.

MUSIC

The year 1967 is the year that we are going to promote PROCLAIMING YOUR CHURCH'S WITNESS THROUGH EDUCATION. The Associational Music Ministry is the key to the promotion of this program. We hope that our association will work to promote the training of people in the churches to read, sing, play and teach music for the glory of God. To this end many things are planned in which each church may participate such as Music festivals, hypin sings, schools of training, music workshops, and general promotion of better music.

This past year our Associational Festival was held at First Baptist Church, Inverness on January 28, 1966. One church from our Association participated in the state festival at North Park Baptist Church, Orlando, on February 25, 1966. The date for our Associational Music Festival for 1967 is January 20, 1967 at First Baptist Church, Wildwood. This year the State Festivals have been entirely revamped. There will be 5 Junior festivals, 3 Intermediate - Young People festivals and 2 Adult festivals. The festivals nearest to us are: Junior Festival, North Central, Gainesville; Intermediate Festival, Northwood, West Palm Beach; Adult Festival. First Baptist, Ocala.

We plan to encourage our churches to participate in the festivals. In order to participate in the State Festival it will be necessary for every church to participate first in the Associational Festival.

Every church is urged to realize that if it has adults and children, which uses music in its worship services and in the organizations, and which elects a music

director and has regular rehearsals, it has a Music Ministry.

RADIO-TELEVISION COMMISSION By Carter McGinnis

If the Apostle Paul were alive today, he would not use the donkey of Spain, nor the oxcart of India, nor the camel of Egypt, nor, for that matter, the MODEL T FORD as a means of transportation. He would use the fastest type of jet travel to go about the earth proclaiming the Good News of Salvation. And the Apostle Paul would use the most up to date communications media to promulgate the Gospel of JESUS CHRIST, radio and television, even as the Radio and Television Commission of the Southern Baptist Convention is doing today. Southern Baptist programs were broadcast on an all-time high number of radio and television stations throughout the world in 1965. The 21 programs produced and distributed each week by the Radio and Television Commission showed a net gain of 453 stations during the year, not including the Armed Forces Radio-TV Network of 238 stations which now carry a selection of programs.

Programs produced for the denomination by the Radio-TV Commission were being used weekly on 2,389 outlets at the end of the year. A breakdown of these is as follows: Television, 100; AM Radio, 1,310; FM Radio, 159; Armed Forces radio, 193; Armed Forces TV, 45; programs in other languages, 415; English programs on forcign stations, 83; Military, institutional, chaplain's broadcasts, 65; weekly grand total, 2,389.

FOREIGN, HOME, AND STATE MISSIONS

At the close of 1965, the Southern Baptist Foreign Mission Board had a missionary staff of 2,070. This included 51 missionary associates, 6 special project nurses, and 46 missionary journeymen. Appointments during the year totaled 220. Southern Baptist missionaries were under appointment to 61 countries or political entities at the close of 1965.

The leading of people to new life in Jesus Christ is the ultimate purpose underlying all our missionary endeavors. Years of foreign mission labor have taught us that the cultivation of New Testament churches is the wisest investment of missionary resources. At the year's end there were 4,410 churches, 7,131 mission points, and 3,816 national pastors related to our Southern Baptist work.

HOME MISSIONS

The Southern Baptist Home Mission Board employs a missionary force of over 2,000, mostly under cooperative agreements with state Baptist conventions. There are twelve programs of the Home Mission Board including Evangelism Development, Church Loans, Pionier Missions, Metropolitan Missions, and Language Missions.

In addition there are over 760 Southern Baptist Chaplains on active duty with the military forces and connected with the Board through the Chaplain Ministries Program.

STATE MISSIONS

Florida Baptists will give \$3,300,000.00 in this church year through the Cooperative Program. Almost \$1,850,000.00 of this will remain in the state for mission work.

The Lake Yale assembly has been in full operation this year with the RA and GA camps. The West Florida Assembly Grounds have been upgraded. Contracts will soon be let for the nursing care facilities at the Retirement Center. A chair of Bible has been added to the B.S.U. work at the University of South Florida.

The Field Mission program and institutional missions have served Florida Baptists well this year and will influence future years of Christian witnessing.

A REPORT TO THE ASSN. OF OPPORTUNITIES AND STEWARDSHIP OF SOUTHERN BAPTIST HOSPITALS

AN AGENCY OF THE SOUTHERN BAPTIST CONVENTION FISCAL REPORT FOR YEAR ENDING SEPTEMBER 30, 1965

BY HARDY M. HARRELL, Acting Executive Secretary-Treasurer "Management gives order to men's ideas, and direction to their aspirations."

We express appropriate appreciation, in proportion due, to all those in places of management including board members.

Facilities of the hospitals at both New Orleans and Jacksonville were filled almost to capacity during the year. Both hospitals have accepted the challenge of the present day political and cultural changes as opportunities to demonstrate applied Christianity in the ministry of healing. A total of 37,460 patients were admitted to the two hospitals, and 269,682 patient days of service were rendered them. The New Orleans hospital is well under way in the last phase of the current expansion construction program. *Expansion and development plans for the Jacksonville hospital are well advanced*. Christian people, and Baptists in particular, have reason to rejoice in the health care services rendered by the church related, and Christian dedicated, hospital.

The teaching and training opportunities for interns and residents in pastoral care, in medicine and related fields, in hospital administration, schools of nursing, technological schools, and other health care programs, are outstanding. The facilities and medical instructors are highly commended. We appreciate them.

Services rendered by these two hospitals to those unable to pay, continue in large amounts. It is not anticipated that Medicare will reduce this amount. Much charity service is to patients under age 65, and, at present, the most favorable reports indicate that not more than 93% of cost of services rendered to Medicare patients *may* be paid to the hospital by government and *patient*. Where does the balance come from? You and I must tighten our belts and increase our contributions.

Do we Baptists make "much ado about nothing" when we contend for the Belief in separation of church and state? Do we so classify Jesus when He said "render unto Caesar the things that are Caesar's and unto God the things that are God's?" Is there a difference? Wherein rests this Belief? Man was created

in the image of God. He is a Spirit, a personality, with an intellect. This Spirit-Man is invisible. He lives in a visible body. He reveals himself in conversation and deeds.

Out of the heart of man, not the visible pump circulating visible life blood, but the Spirit that shall never die, comes the issues of life itself, in which thoughts are conceived, from which ideas are born, and plans are formed. These plans erupt into a life of evil, or they develop and bloom into a beautiful life of righteousness.

Civil Government can only govern Visible-Man with his conversation and deeds. State is symbolic of Civil Government. Only Spiritual Government can reach Spirit-Man. Church is symbolic of Spiritual Government. Spirit-Man must live with, but be separate from, Visible-Man, or he will be separated from God. This is his choice. While they live together, Visible-Man must obey Civil Government. The church is made of Spirit-Men and must live with, but be separate from, the State, or, she will be separated from God. Divine Law has ordained it. Contributions, grants, and/or support by taxes is symbolic of state. The church and the state are as separate by Nature as Spirit-Man and Visible-Man. Spirit-Man and Visible-Man need the touch of wholeness that comes only through the ministry of the Spirit. Medical healing is all important to Visible-Man. But there is great need for the Spiritual care that heals the total man. Jesus prayed that His Church not be taken out of the world (State) but that it shall be kept from the evil.

BAPTIST CHILDREN'S HOME

The home offers three areas of child care: Group Care in the Children's Home, Mother's Aid Program, and Foster Care.

The home received 259 applications during the fiscal year 1965-66. Fiftynine children were admitted and 101 rejected for various reasons, including a lack of ability to profit from institutional care.

Eighty applications were withdrawn and 19 were pending on June 30, 1966. Seventy-five children were discharged during the year including 59 who were discharged to Lakeland and the South Florida Branch.

There were 1,496 interviews with children and 751 with parents. The families in Mother's Aid are visited as often as the administration and Care Dept. think necessary.

Interviews are necessary in helping children settle in and resolve specific problems.

Follow up visits are made to children who have been discharged to parents or relatives, these visits help parents and children to use what has been learned.

There was a noticeable drop in applications received by the Home during the year 1965-66, due to the Federal Government prohibiting a Dept. of Public Welfare from making application for a dependent child to institutions that were not integrated. However, the order did not effect the enrollment of the children's home.

The home is pleased to report that of 259 referrals it received during the year, 132 were made by pastors. The administration appreciates the cooperation of the pastors in referring needy families to the home.

SUNDAY SCHOOL REPORT

At the beginning of the year Bro. Lockler was Superintendent of the Association, however, he resigned as pastor of the Bushnell church and the associational work in March of this year and I assumed the job as Superintendent in April. We have had our regular meetings for the year and have plans for an interesting year if we can keep getting the support of the various churches. We want to take this means of thanking all who have helped to keep the Associational work moving forward.

Study Course awards through Aug. 31, 1966 were as follows: Total awards (all categories) 797 with 19 churches participating. A total of 89 awards in category 17 with 9 churches being represented in this study. We had 3 Standard Schools in the Association so far as I know; we have only 12 VBS for the year.

We have set some goals for next year which will require our whole hearted support if we are to reach them. We have set a goal of 8 Standard Schools for next year, Training in every church in the Association, at least 20 churches taking part in January Bible Study, a minimum of 20 VBS. We would like to have all officers in the Associational work elected and working by the close of the annual meeting at the latest. We would like to see every church in the Association engaged in the CHURCH GROWTH PLAN. We must reach more People for Bible Study if we are to carry on the work in an acceptable manner.

Be it resolved that we express our appreciation to Rev. J. H. Davis for his inspiring devotional messages with which he warmed our hearts. Therefore be it resolved that we give him a standing vote of thanks.

That we lay aside any remnants of pessimism and go forth from these sessions attempting great things for God and expecting great things from God.

BE IT RESOLVED, that we, the Alachua Baptist Association, oppose any form of legislation legalizing a state lottery for any purpose; because we believe this is in direct opposition to the moral law of God.

BE IT RESOLVED, we are opposed to the sale of "near beer" to anyone under twenty-one years of age.

Capital Punishment

WHEREAS there has arisen a tide of popular opinion in America against capital punishment to the extent that only one criminal has been executed this year in all our 50 states,

WHEREAS or Governor Burns has not permitted an execution since he took office,

WHEREAS we believe that the moral law of God in the Old Testament and New Testament is the same and both covenents demand capital punishment, Exodus 21 and Romans 13,

WHEREAS the effort to abolish capital punishment is in itself an effort of our present society to run from the judgment of God upon their own sins . . . trying to show mercy as a "god" but violating the demands of justice.

WHEREAS there has been greater difficulty of law enforcement today (a protection guaranteed in the Bible) and the abolishment of the death sentence leads to anarchy,

WE, the Alachua Baptist Association, re-affirm our belief in capital punishment.


